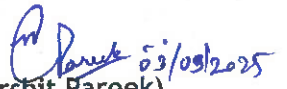

Annex-A

Reasons for Technical Non-Responsiveness of the bidders:

1. M/s Shree Guru Infracon (P) Ltd.

- A. The Bidder has been considered non-responsive pursuant to Clause 2.20.2 of the RFP, on account of non-submission of the required Bid Security under Clause 2.20.1.
- B. The Bidder has been considered non-responsive for not meeting the minimum Threshold Technical Capacity, as stipulated under Clause 2.2.2.2 (i) of the RFP.

2. M/s Tags Projects (P) Ltd. - M/s Riddhi Infrastructure (JV).

- A. The bidder has been considered non-responsive for not meeting the minimum Threshold Technical Capacity of Rs. 20.08 crore by the Other Member, in accordance with Clause 2.2.2.2 (i) read with Clause 2.2.2.4 (i) of the RFP.
- B. The Lead Member does not meet the minimum required Bid Capacity of Rs. 60.25 Crores, in accordance with Clause 2.2.2.1 read with Clause 2.2.2.4 (i) of the RFP, thereby rendering the bid non-responsive.
- C. The Other Member does not meet the minimum required Net Worth, of Rs. 2.01 Crores, in accordance with Clause 2.2.2.3 (i) read with Clause 2.2.2.4 (i) of the RFP, thereby rendering the bid non-responsive.
- D. Due to non-submission of the revised documents, required as per the clarification sought, the bid submitted by the Bidder has been considered non-responsive.
