However, in the instant case, the bidder has submitted the invoice dated 30.05.2016 which confirms the age of equipment more than 5 years as on bid submission date. Further, the bidder has claimed project wherein bidder was appointed as Sub contractor for the limited scope of work and there is no mention of work incident management. As per clause 4.4. B (b)(ii) Appendix to Bid, the bidder is required to submit the Date of Birth certificate. However, the same has not been found in the submission made by the bidder. Hence, as per Clause 4.4. B (b)(i) & (ii) Appendix to Bid and clause 4.4 (b) of the RFP Document the bidder may be treated as non-responsive.
