32. The supply of vehicles is initially for duration of two years only from the date of issue of Letter of Acceptance Vehicles may be continued beyond two year period on the above conditions if required by NHAI for further period as decided by NHAI.
33. The successful bidder shall submit all the required documents of vehicle, driver, insurance, GST etc. execute the agreement within a week of issue of 'Letter of Acceptance' on Five Hundred Rupee bond paper, failing which 2nd lowest bidder will be given offer in the Lowest rates quoted in the bidding.
34. Amendments, corrigendum, if any, would be hosted on NHAI website only.
35. NHAI reserves all rights to curtail, modify, halt/cancel, reject any or all offer/s, at any stage without assigning any reasons and no claims of whatsoever nature will be entertained on this account.
36. NHAI will not have obligation :-
- No liability whatsoever for payment of wages/salaries other benefits and allowances to his personnel that might become applicable under any Act or Order of the Govt. in this regard and the Service Provider shall indemnify NHAI against any/all claims which may arise under the provisions of various Acts, Government Orders etc. and any breach of such laws or regulations shall be deemed to be breach of this contract.
 - No direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to NHAI have to be suitably compensated by Service Provider.
 - Not be responsible for theft, burglary, fire or any mischievous deeds by his staff.
 - Service Provider shall be the employer for his workers and NHAI will not be held responsible fully or partially for any dispute that may arise between the service provider and his workers.
 - In no circumstances the staff of service provider shall claim his right for employment in NHAI for any post.
 - No direct or indirect liability on account of any accident to the vehicle or by the vehicle.

B. Earnest Money Deposits (EMD)/Bid security:-

The Bidders shall furnish, Earnest Money/Bid Security as part of tender as specified in the document. The Earnest Money shall be in the form of Demand Draft/Online Transfer in favour of National Highways Authority of India, payable at Kolhapur. Any tender not accompanied by an acceptable Earnest Money shall be rejected by the NHAI as non-responsive. The Earnest Money of unsuccessful bidders will be returned within 3 months.

C. The Bid Security / Earnest Money will be forfeited

- If the Bidder withdraws the Bid after its submission;
- If the Bidders does not accept the correction of the bid price; or
- In the case of a successful Bidder, if the Bidder fails to produce requisite document, sign the Agreement and supply the vehicles within a week of issue of 'Letter of Acceptance'.
