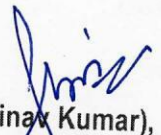

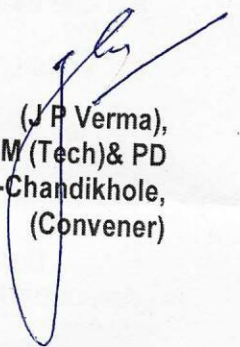
3. It is observed that the Financial Bids submitted by *M/s Leaptree Engineers Pvt. Ltd.* at quoted amount of Rs. 45,34,347.52/- (Rupees Forty Five Lakhs Thirty Four Thousand Three Hundred Forty Seven Fifty two Paise only) is -25.30% below the estimated cost of Rs. 60.70 Lakhs (Excluding GST & Labour Cess) as a bidders.
