**\* Reasons for Non-Responsiveness of M/s. Siddharth Construction**

The Bidder M/s Siddharth Construction has been declared Non-Responsive as the said Bidders fails to meet the following minimum eligibility criteria specified in the RFP and therefore, declared ineligible for next stage of Bidding Process:

**Note:** The Bidder has not submitted the response to clarifications sought, therefore, the bid of the said Bidder has been evaluated on the basis of available documents, based on which the Bidder fails to meet the minimum eligibility criteria requirement specified in the RFP and therefore, declared ineligible for next stage of Bidding Process:

On the basis of available documents, the Bidder fails to meet the Particular Construction Experience specified in Clause 1.3.1 (b) of RFP. Bidder has claimed various projects for Construction Experience and in support of the same, the Bidder has submitted Client Certificates, however, due to various infirmities the Bidder fails to meet the Particular Construction Experience specified in Clause 1.3.1 (b) of RFP:

**1. Project: NH-29E Jungle Kaudia to Mohaddipur:** The value of work executed as restricted to the Bidder's JV share (30% as per Joint Bidding Agreement submitted in the Technical Bid), falls below the threshold of Rs. 122.88 Crore as stipulated in the RFP and reiterated in the table above. Accordingly, the said project may not be considered as eligible for the purpose of qualification/ evaluation.

**2. Project: Dehlpur-Raniganj-Patti-Kohdaour under Central Road Fund:** The date of actual completion of the Project is mentioned as 30.06.2019 in the Client's Certificate dated 22.11.2023, submitted by the Bidder, which falls outside the permissible time limit ending on 01.04.2020 (i.e. FY 2020-21) as specified in the RFP. Hence, the said project may not be considered as eligible for the purpose of qualification/ evaluation.

**3. Project: “Babhnan to Gaur Tinich under RIDF-24:** The certified value of work executed by the Bidder is Rs. 45.77 Crore, which is below the minimum requirement of similar completed works considering Estimated Cost specified in the RFP and reiterated in the table above, i.e. it is less than Rs. 122.88 Crore. Therefore, the said project may not be considered as eligible for the purpose of qualification/ evaluation.

**4. Project: “Four-laning of GT Road Prayagraj-Varanasi (SH-106) from Ch. 219.500 to 242.600:** As per Client’s Certificate dated 19.02.2025, the certified value of DBM/BC and PQC/DLC works are Rs. 63.42 Crore and Rs. 6.89 Crore respectively, by virtue of which, the said project may be considered under point no.: (iii) of the table under Clause 1.3.1 (b) of RFP.

**5. Project: SH-113 Naraine Kalanjher:** The Client’s Certificate provides details of executed quantities for DBM/BC, however, the corresponding monetary values for DBM/BC or PQC/DLC have not been mentioned/ certified, which is required as per RFP.

Further, the value of the said Project, as restricted to the Bidder’s JV share (70% as per Joint Bidding Agreement submitted in the Technical Bid) comes out to be Rs. 97.31 Crore, which falls below the threshold of Rs. 122.88 Crore as stipulated in the RFP and reiterated in the table above. Accordingly, the said project may not be considered as eligible for the purpose of qualification/ evaluation.

By virtue of the facts mentioned above, the Bidder should have at least 03 (three) projects having Estimated Cost of Rs. 122.88 Crore and the Value of DBM/BC or PQC/DLC in the said projects must be Rs. 61.44 Crore or above. However, from the above-mentioned facts, it is evident that four out of the five projects submitted by the Bidder do not meet the eligibility criteria and may not be considered as eligible for the purpose of qualification/ evaluation.

**Hence, on the basis of available documents submitted in the Technical Bid. The Bidder fails to meet the minimum eligibility criteria of Particular Construction Experience specified in Clause 1.3.1 (b) of RFP.**

Financial Capabilities as required under Clause 1.6 of RFP claimed by the Bidder in Form 7A i.e. Source of Funding after deducting Financial Commitment for ongoing Civil work is coming out to be negative.

**Therefore, the Bidder fails to meet minimum eligibility criteria as per Clause 1.6 of Section-IX of RFP.**

In addition to above, following infirmities/ discrepancies were observed, however the Bidder did not submit any response, which were specifically asked for. The same are again reiterated below:
