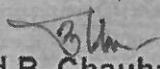

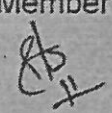
It is found that the only one bidder 'M/s. Riddhi Siddhi Associate' has participated in the Bidding process.

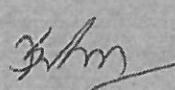

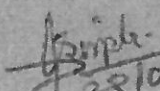
The Power of Attorney, Cost of Bid Document, and EMD / Bid Security (Annex-II) have been verified and found in order.
