To promote and incorporate the Concessionaire as a limited liability company under the Companies Act 2013 and as the entity which shall undertake and perform the obligations and exercise the rights of the selected Bidder under the LOA, including the obligation to enter into the Concession Agreement pursuant to the LOA for executing the Project pursuant to Recital (E) of draft Concession Agreement.
- iv. The Concessionaire shall, for the performance of its obligations hereunder, provide to the Authority no later than 30(thirty) days from the date of the Agreement, an Insurance Surety Bond (issued by Insurance Company authorized by Insurance Regulatory and Development Authority of India in the form set forth in Annexure II of Schedule-F), Account Payee Demand

Draft, Fixed Deposit Receipt, Banker's Cheque or irrevocable and unconditional Guarantee(including e - Bank Guarantee) from a Bank (including e- Bank Guarantee) for a sum equivalent to 5% (five per cent) of the Bid Project Cost in the form set forth in Schedule-F.
