- ii. M/s. SAMY TRAVELS (Bid ID: 884164).

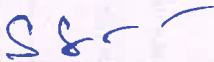

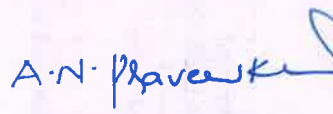
