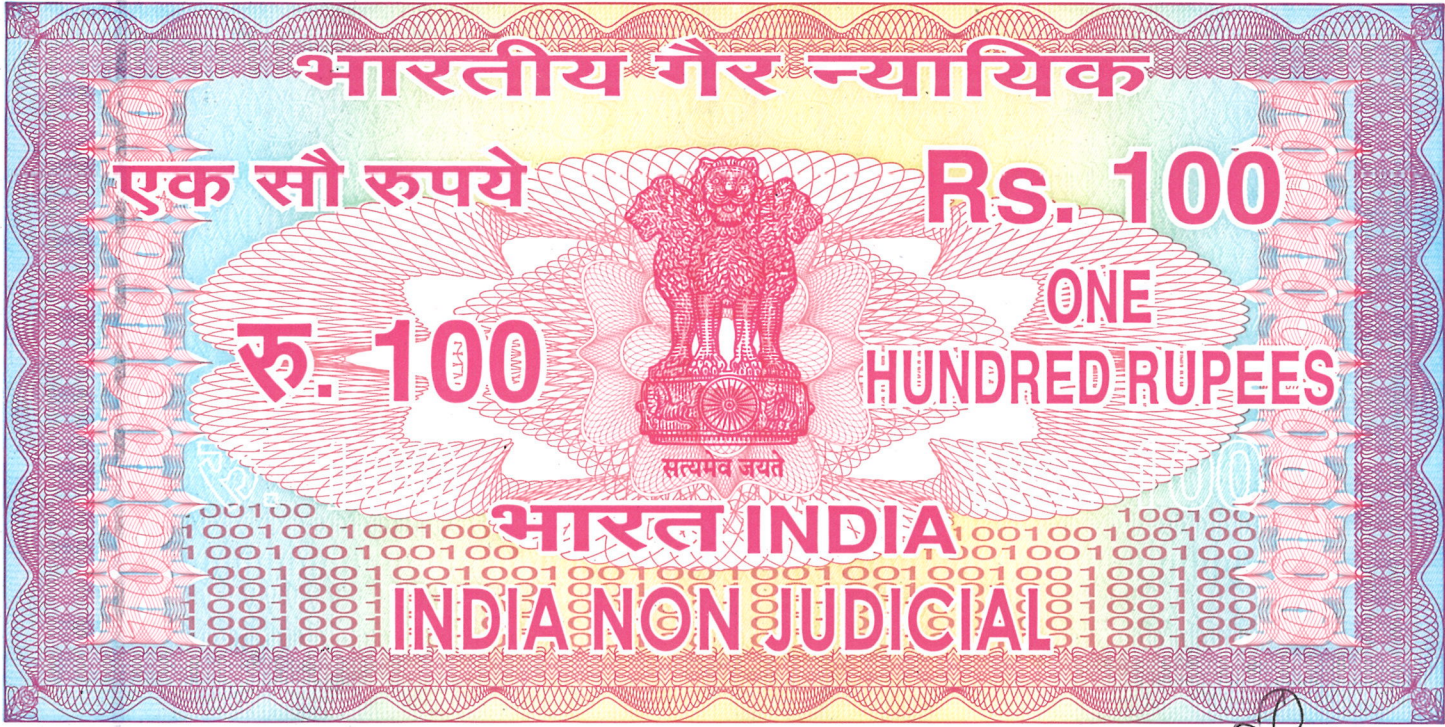

AGREEMENT

This agreement is made in Thanjavur on 11.09.2025 between S.Mahendran Proprietor of M/S R.S.Mani Travels having office No.40, 10th Street, Anna Nagar, Villar Road, Thanjavur-613 006 hereinafter referred to as "the party of the **FIRST PART**" and the General Manager (Tech) Cum Project Director, Project Implementation Unit - Thanjavur, **National Highways Authority of India**, No. 54, Natarajapauram North Colony, Medical College Road, Thanjavur- 613004, hereinafter referred to as "the party of the **SECOND PART**".

WHEREAS the party of the First part agreed to provide 1 No. of Bolero/Scorpio or Equivalent Vehicle not older than 3 years of purchase to the office of the party of the second part and the first part agreed to provide the services agreed upon as per terms and conditions set forth herein in this agreement.

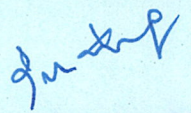

NOW THIS AGREEMENT WITNESSETH AS UNDER:

1. That the party of the first part shall provide 1 No. of good quality Bolero/Scorpio or Equivalent Vehicle and the model shall be new or not older than 03 Years. Initially for a period of 12 months on monthly hired basis to the party of the second part.
2. That the monthly rental of Rs.79,000/- (Excluding GST) will be paid for the use of the Vehicle with a monthly ceiling of 3,500 km (42,000 Km for One Year) by the party of second part to first party.
3. The party of first part shall also provide the driver having a valid driving license. The valid registration, insurance and fitness certificate of the supplied vehicle to be ensured by the party of first part. All necessary taxes for operating the vehicle shall be fully paid by the agency as per prevailing Motor Vehicles Act with comprehensive insurance cover. The first party has to provide well behaved/uniformed driver with mobile phone.
4. The vehicle shall be a dedicated one for exclusive use of NHAI Officials, as required, for all days in a month. NHAI will not be responsible for parking / accommodation / facility of meals for the driver and the first party should make the above arrangements on their own.
5. The vehicle shall be normally 12 hrs per day but this office reserves its right to use the vehicle round the clock without paying anything extra. Vehicle shall primarily run in the jurisdiction of the respective PIU.
6. All cases related to accident/damaged/compensation shall be the responsibility of the first part. The first part shall provide a substitute vehicle immediately.
7. The first part shall bear all expenses required for keeping the vehicles in smooth running condition such as fuel, lubrication oil, & other consumables, Necessary service, Maintenance, Repairs & Replacement etc. The first part should ensure that sufficient fuel is always available for travel.
8. The first party shall be responsible for all the acts and deeds of the driver of the vehicle. The Authority will in no way be responsible for violation of traffic rules and / or other losses either by driver of the vehicle or by the Agency.
9. The first party shall ensure proper cleanliness and hygiene condition in the vehicle and upholstery / interior of the vehicle shall be maintained in excellent condition.
10. The first party shall provide experienced and well - behaved Driver having valid driving license. The driver should be in sound mental and physical condition and perform the duty sincerely and diligently. He should not take alcohol or any other intoxicants or smoke while on duty hours. The first party shall replace the driver within 24 hours in case of any misconduct noticed by NHAI.

11. The vehicle provided should have permit to travel in the entire State of Tamil Nadu
12. The quoted rates will be exclusive of GST but inclusive of Driver's Salary & other benefits, cost of all lubricants; full routine maintenance and toll tax if any including cost of spares etc & any other incidentals as may be required.
13. In case of vehicle failure, the agency shall arrange for an alternative vehicle immediately or shall bear the actual expenses incurred by the officer for hiring a taxi. If the substitute vehicle is not provided a penalty of Rs.2,500/- per day shall be affected from the bills of agency.
14. The mileage will be calculated from the place designed for reporting every day.
15. That the required documents relating to payment of road tax, insurance, registration, etc. should always be available in the Vehicle.
16. That the proper Log book, as per standard format should be maintained and got signed by the officer who is traveling in the Vehicle on daily basis.
17. The Agency should submit their bill in duplicate along with logbook with in 1st week of succeeding month for payment.
18. That the engagement will be for a period **12 months**, with effect from **01.09.2025 to 31.08.2026**. Vehicle may be continued beyond 12 months' period on the above conditions if required by NHAI for further period as decided by NHAI on mutual consent basis.
19. NHAI will have the right to terminate the Contract by giving 1-month advance notice.
20. The first party shall abide by the terms and conditions which forms a party of this agreement.
