In case there is still a tie, the firm with the highest experience (i.e. earlier date of establishment) shall be awarded. The decision of the Company's Management shall be final and binding in this regard." Accordingly, since M/s Milind Nyati & Co. was established in 1987 as against M/s Mahesh C. Solanki & Co. established in 1989, M/s Milind Nyati & Co. shall be awarded the assignment.
