This has reference to RFP submitted for the subject project. The result of Technical Evaluation of the bids received along with reasons for their non-responsiveness are tabulated below :

1/15	M/s Ganesh Ram Dokania	Non-Responsive <i>Bidder has submitted the required document, i.e., Appendix-II: Bank Guarantee for Bid Security bearing BG No. 0618425IFG000365 dated 24.10.2025, issued by Indian Bank, Gopalganj-II Branch. Upon confirmation of the Bank Guarantee by the Authority vide letter bearing No. NHAI/HQ/UP(E)/Varanasi Bypass/NH-56/E-Tender dated 08.12.2025, it has been observed that the name and details of the applicant mentioned in the Bank Guarantee pertain to 'Kumar Manash Constructions Pvt. Ltd., Sareya, Ward No. 5, Near Kali Mandir, Gopalganj' instead of 'M/s Ganesh Ram Dokania'. Accordingly, the bid is liable to be declared as Non-Responsive in accordance with Clause 2.20.2 of the RFP, mentioned below:</i> <i>"Any BID not accompanied by the BID Security shall be summarily rejected by the Authority as non-responsive. For the avoidance of doubt, bid accompanied by a Bid Security sourced through a third party shall likewise be summarily rejected as non-responsive."</i>
