As per the approval issued vide Note dated **12.08.2025** by the Regional Officer, Nagpur, bids for the subject work have been invited on **13.08.2025** [from 11:00 A.M.] with bid due date as **12.09.2025** up to 11:00 A.M.

- 1) As per the tender schedule, the "Technical Bids" have been opened on **15.09.2025** and the Committee considered all the Bids for further evaluation. No representative of any bidder chose to attend the opening of Technical e-bids. The attendance sheet is placed below at **Annexure-I**.
- 2) The bid evaluation Committee completed the "detailed technical evaluation" of the received bids as per **Clause 26 of Section-II: ITB of RFP** which is placed below at **Annexure-III**, which is summarised as follows:

- 3) The Committee has declared the following 1 bidder as "non-responsive" due to the following reasons:

3/3 - M/s. Mynedi Hemanth Kalyan:

A. Sr. No. 1 of the detailed "Technical Evaluation" sheet:

As per Clause 4.1 (a) Page 6 of the RFP the Bidder is required to provide average annual turnover for the last 3 years.

However, the bidder has not provided the details of the average annual turnover for the last 3 years.

- B. The bidder has not submitted the required documents as per Clause-4.1(a), 4(b), 5.1 (iii), 5.1 (iv) & 5.1 (vi) of the RFP document.**

Hence, the Committee has declared the bid / bidder as "Non-Responsive".

- 4) At Clause - 4.1 (b) of Section I 'Instructions to Bidders (ITB)' of the RFP Document (F/C), minimum experience of one year in relevant field, i.e. Hotel / Restaurants including operation & maintenance of toilets has been sought.

At Sr. No. 2 of the detailed "Technical Evaluation Report" placed below at Annexure-I, it is noted that bidders have produced a separate proof of having experience in "maintenance of toilets". However, it is noted that they are running Hotel / restaurant and the same must have got toilet for customers in their establishment. Hence, this Committee considered them to have requisite experience in "maintenance of toilets" and recommended their bids as "Technically responsive".

- 5) The Committee hereby recommends to declare:

- a) The bid / bidder No. 3/3 as **"Technically Non-Responsive"** &
b) The balance 2 bidders at Sr. No. 1/3 and 2/3 of table under Para 4 above as "Technically responsive".

In view of the above, this Committee herewith recommends uploading of the above result of "Technical evaluation" of received e-bids on the e-tendering portal of NHAI as per Clause 23.5 of the RFP document, with a request to the bidders for raising their objections / clarifications, if any, up to 12:00 noon on 03.10.2025.

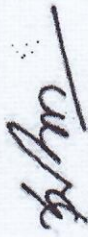
