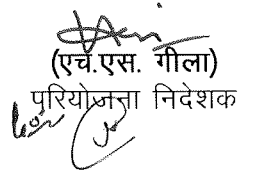

This is in reference to this office letter dated 29.03.2022(Annex-1) vide which letter of commencement for services of running & maintenance of commercial vehicles on monthly hire basis has been issued to M/s. Radhika Travels Ajmer, and subsequently, Agreement was signed between National Highways Authority of India through Project Director, PIU-Ajmer and M/s.Radhika Travels (Proprietor Sh. Manjeet Singh S/o Sh. Amrit Singh) on 01.04.2022 (Annex-2). Further, Competent Authority vide Note No. 2 of e-office file no. 280823 has approved extension of services of M/s.Radhika Travels upto 31.07.2025 or mobilization of new agency, whichever is earlier.

Further, the Proposal for inviting fresh bids was forwarded to RO-Jaipur vide E-office file no 280823. whereupon, the Competent Authority at Note No# 06 dt. 19.05.2025, has accorded approval for inviting fresh e-bids. Accordingly, PIU-Ajmer previously invites E-tender for hiring of commercial vehicles on monthly basis that was available on the e-tender website w.e.f 20.05.2025 from 17:00 Hrs and the last date of Bid Submission was 19.05.2025 upto 11:00 hrs. (Date has been extended on 02.07.2025 up to 11:00 hrs.) After the closing date of the Tender, due to administrative / technical reasons, the committee annulled / cancelled the tender process on 08.07.2025.

Further, PIU-Ajmer again invites E-tender for hiring of commercial vehicles on monthly basis that was available on the e-tender website w.e.f 11.07.2025 from 11:00 Hrs and the last date of Bid Submission was 11.08.2025 upto 11:00 hrs. Opened Bid on 12.08.2025 on 11:30 hrs. 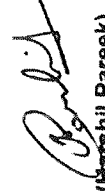

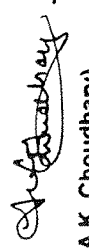

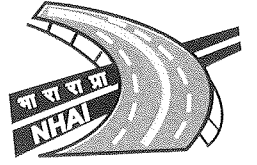
