

Minutes of Meeting Dated 19.09.2025

Sub.: Providing, Running and Maintenance of 2 Nos. of Vehicles (One Innova and One Bolero) at National Highways Authority of India, Project Implementation Unit (PIU), Bongaigaon, Assam – Opening of Financial Bid.

With reference to the above-cited Notice Inviting Tender (NIT), the tender for the subject work was invited through online mode with the last date and time for submission as 08.09.2025 up to 12:00 hrs, and the scheduled date and time for opening of the technical bid as 09.09.2025 at 12:00 hrs.

3. On opening the technical bids on the scheduled date, it is hereby informed that four (04) responsive bidders have submitted bids for providing vehicles (one Innova and one Bolero) at the Project Implementation Unit, Bongaigaon. Details are as under:

4. The evaluation of the technical bids was carried out on 16.09.2025. It has been observed that all four (04) participating bidders have complied with the requirements stipulated in the Notice Inviting Tender (NIT) including the deposition of the cost of bid document amounting to Rs. 5,000/- into the NHAI CBS Bank Account No. 3184201000047. Further, committee recommended to open financial bid on 19.09.2025 at 18:00 hrs.

5. Based on the bid evaluation (Technical and Financial), it is evident that M/s Risha Infrastructure has submitted the lowest financial bid L-1 for both vehicles (Innova and Bolero) and accordingly, the committee has determined that M/s Risha Infrastructure is the most suitable vendor for the execution of the contract. The committee, therefore, recommends that Letter of Acceptance (LoA) be issued to M/s Risha Infrastructure for the subject work.

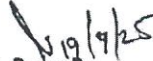
