The bids for the subject work were invited vide NIT No. NHAI/PIU/Ahilyanagar/Admn./Vehicle/2025-26/01 dated 21.08.2025. The bids have been received on 04.09.2025 (online) and the same were opened on 08.09.2025 in PIU-Ahilyanagar. The attendance sheet of Evaluation committee and bidder's representatives is placed at Annexure-I.

2. Subsequent to opening of Technical bids, it has been seen that 02 Nos. of bids for the subject work was received on e-tender portal as detailed below:

3. Accordingly, Committee has verified all the documents (Copy attached as Annexure-II) as submitted by above two bidders and it is observed that;

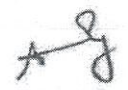
3.1 M/s. Guru Mauli Tours and Travels has not deposited Additional Performance Guarantee of Rs.25,000/- for Innova and Rs.25,000/- for Scorpio Vehicle. Further, clause no.8 of Bid Documents mentioned that, "In case the bidder who wants to purchase brand new vehicle/s for this work, he shall give an undertaking in the form given in Annexure-IV of Section IV (Technical Bid). In that case he will have to submit Additional Performance Guarantee of Rs.25,000/- per vehicle through NEFT to NHAI bank account. The offer will be considered non responsive if such additional performance guarantee is no submitted with the Bid". Hence, M/s Guru Mauli Tours and Travels is considered as Non responsive.

3.2 M/s Shri Swami Samarth Travels has submitted various work order copies in technical bids, however, experience certificate of that organization at least 2 years as per Terms & Condition of clause no.2 of Bid documents is not submitted in technical bids. Hence, M/s Shri Swami Samarth Travels is considered as Non responsive.

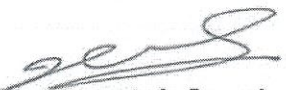
4. In view of the above, Evaluation Committee recommends for re-inviting bids.
