**Minutes of Tender committee Meeting for financial evaluation of the tender for work of "Road Safety Works & Maintenance of NH 744 (Old No. 208) From.Km.81/600 to Km.98/568 & 99/798 to Km.153/0 in the state of Tamilnadu" (Tender Ref. no. NHAI/PIU/NGL/NH-744/2025/06)**

1. The bids received from the bidders have been evaluated and as per the evaluation, the bidder, i.e. M/s. PPK Construction, Madurai is not qualified, since the bidder has not furnished similar work experience and integrity pact. The other two bidders, i.e., 1) M/s. SS AND CO, Devakottai and 2) M/s. MS Constructions, Surandai, have qualified in the technical evaluation since these two (2) bidders have furnished all the mandatory technical documents as contemplated in the RFP.

2. Since the Two (2) bidders have qualified in the technical bid evaluation, the committee unanimously decided to open and evaluation of financial bid of the two (2) bidders 1) M/s. SS AND CO, Devakottai and 2) M/s. MS Constructions, Surandai in accordance with of clause 30 of ITB of RFP.

3. Accordingly, financial bids of the technically qualified Two (2) bidder has been opened on 29.09.2025 @ 6.30 PM. The amount quoted by the bidders are as under:
