In response to the E-Tender Call Notice, a total of four (04) bids were received from various agencies. The technical bids were opened on 26.09.2025 at 14:30 hrs.

It was observed that some of the information provided by the bidders did not fully adhere to the clauses of the RFP. Therefore, clarifications were sought from two bidders, namely Gopi Tour and Travels and Lucky Infra Project, in accordance with the RFP guidelines, to facilitate the evaluation process.

Both bidders submitted their clarifications on 06.10.2025, which were examined by the Committee. Subsequently, a comparative statement was prepared. Out of the total four bids received:

- Three (03) bids were found responsive and considered for financial bid opening.
- One (01) bid was found non-responsive.

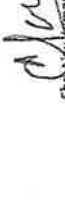

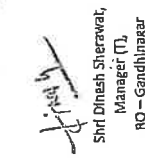

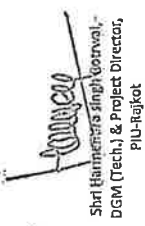
