Minutes of Meeting of Tender Evaluation Committee (Financial Evaluation) dated 15.11.2025 for "Facility Services in NHAI, Regional Office, Madurai and its Project Implementation Units (Providing Manpower viz. Site Engineers, Media Assistant, Legal Assistant, IT Support Assistant, Stenographers, Accountants, Computer Operators, Office Assistants, Peon, Chowkidar/ Security Guards/Watchman, Safaiwala/Sweeper, etc.) for two years" (Tender Ref. No. NHAI/17011/03/17/2025/RO Madurai).

1. Consequent upon the approval of Regional Officer, Madurai the detailed technical evaluation with the final technical scores were uploaded in E-tender Portal on 12.11.2025, and the same is tabulated as under;

2. Further, opening of Financial Bids was scheduled at 11.00 Hrs IST on 15.11.2025. Accordingly, the committee opened the financial bids of all qualified bidders of the Technical Evaluation.

3. No representative of any bidder has attended the Financial Bid Opening.

4. As per Para 4.2.1 & 4.2.2 of Section-II ITB of RFP, the weightage of Technical and Financial Score shall be 70% & 30% respectively. Para 4.2.3, Financial Proposal evaluation of Section-2 ITB, describes the procedure to be adopted for arriving the Final Score (Technical Score + Financial Score). Based on the above criteria, the combined score obtained by the bidders is calculated and enclosed as Annexure-A. Summary of the same is tabulated as under;
