**Sub:- Minutes of meeting for opening and evaluation of Financial bid for finalization of Hiring of Vehicles (Innova or equivalent, Scorpio or equivalent and Swift Dzire or equivalent) on monthly rental basis for PIU-Ambala (2<sup>nd</sup> Call) – reg.**

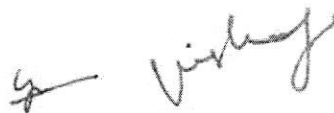
This is in reference to Minutes of meeting at reference (ii) and this office order at reference (ii), vide which this office has intimated to all 06 (Six) nos. of bidder regarding discussion taken by the tender evaluation committee during evaluation of technical bid for finalization of Hiring of Vehicles (Innova or equivalent, Scorpio or equivalent and Swift Dzire or equivalent) on monthly rental basis for PIU-Ambala (2<sup>nd</sup> Call). The following point intimated to all 06 (Six) nos. of bidder: -

- A. On scrutinizing the technical bids by the constituted committee, the following bidders are declared qualified/disqualified for financial bid.
  - a. **Bidders declared qualified in technical bid:-**
    - (i) M/s Bestway Cabs services Pvt. Ltd., Chandigarh.
    - (ii) M/s PM Associates, Jind.
    - (iii) M/s Lucky Infra Project, Jaipur.
  - b. **Bidders declared Disqualified in Technical bid:-**
    - (i) M/s Salasar Ji Enterprises, Ambala Cantt- Bid not updated online.
    - (ii) M/s Dolphin Tours & Travels, Mohali- No Experience Certificate enclosed and neither EMD/Tender fees has been paid.
    - (iii) M/s Balaji Enterprises, Charkhi Dadri- No Experience certificate from Competent Authority of any PSU/ Central Govt. / State Govt./ Government undertaking in accordance with clause no. 1 of Section-2 of RFP.
- B. The reasons for technical non-responsiveness of the bidders is enclosed herewith. Representations, if any, on the technical evaluation shall be submitted latest by 21.11.2025 through mail amb@nhai.org or piuambala@gmail.com. This is for information of all concerned.
- C. The opening of Financial Bids of the Technically Responsive bidders will be intimated later on 22.11.2025.

2. On 21.11.2025 one representation has been received from M/s. Salasar Ji Enterprises, Ambala Cantt which has been replied by this office letter no. 11001/NHAI/AMB/3092 dated 21.11.2025 and as this office order dated 20.11.2025 and Minutes of Meeting dated 19.11.2025, the Tender Evaluation Committee assembled on 22.11.2025 and the financial bid were opened online of following 03 (Three) technically qualified bidders:-

- (i) M/s Bestway Cabs services Pvt. Ltd., Chandigarh.
- (ii) M/s PM Associates, Jind.
- (iii) M/s Lucky Infra Project, Jaipur.

3. The various provisions in the bid document with regard to Financial open of the bid is as under:-



(a) **Clause -8.2 of section-II of Bid Document:** The committee shall open the financial bids of responsive bidder on the bid due date in the presence of responsive bidder or their authorized representative who wish to remain present at the time of opening of financial bid. The financial bids shall be corrected for discrepancies by the committee. If, there is discrepancy between words and figures, the amount of words shall prevail. The arithmetic calculations for multiplication and summation shall be checked by the committee and suitably corrected. Such corrected offer shall be considered as the offer of the bidder.

(b) **Clause -9 of section-II of Bid Document:** NHAI shall issue Letter of Acceptance to the lowest bidder, whose Technical & Financial bid have been found acceptable. The successful bidder shall then submit performance security within 7 days and execute the Agreement with NHAI on non-judicial stamp paper, cost of which shall be borne by him.

(c) **Clause -11 of section-II of Bid Document:** NHAI reserves right to reject any or all the bids without assigning any reason and no claim of whatsoever nature will be entertained for such act.

(d) **Clause -11 of section-III of Bid Document:** The lowest quoted rates shall be judged for vehicle for evaluation of the bid.

(e) **Clause -12 of section-III of Bid Document:** The bidder must quote the rates both in words and figures for all category of vehicle. In case there is a difference between the quoted rate in words and figures, rate quoted in words shall prevail. If no rate is quoted for a particular type of vehicle, then the bidder shall be considered as non-responsive.

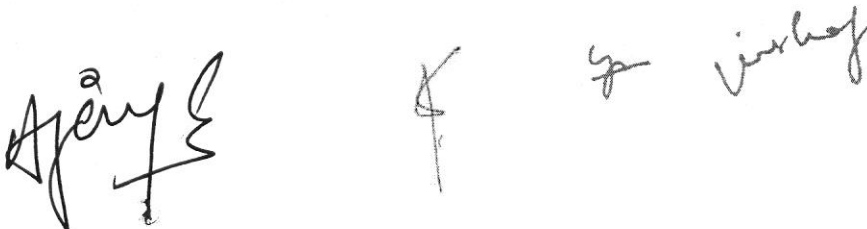
4. Accordingly, the tender evaluation committee has evaluated the financial bid submitted by all 03 (Three) technically qualified bidders in accordance with above acted provision of Bid Document and found that M/s. Bestway Cabs Services Pvt. Ltd. has quoted lowest rate for overall for 24 (Twenty-Four) months. The following has been observed in the financial evaluation sheet of the eligible bidders whose technical bid has been opened.

(a) The total amount in word matches with the total amount in figure for 02 (two) bidders but in the financial sheet of the bidder M/s. Lucky Infra Project, Jaipur, the bidder had quoted the rate per month which was requested in Serial No.-2 in the word column at Serial No.- 5 but has not given financial total figure amount in word as given by other two bidders.

(b) Further in the financial sheet of bidder uploaded online M/s. Lucky Infra Project, Jaipur no name of the bidder has been included in respective case in which it was requested.

But after Serial No. (a) and (b) there is no changes in financial ranking in accordance with regard to final amount quoted by the all the bidder. The online financial bid of all 03 (Three) bidders are enclosed as **Annexure-A, B & C.**

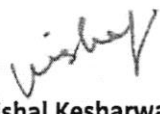

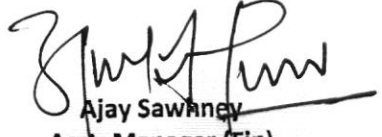
