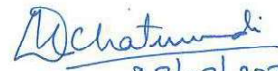

2. As per clause 2.2.2 (BB), all the above Responsive bidders are requested to submit their updated Assessed Available Net Worth latest by 24.03.2026 (1700 Hrs) covering all PPP works for which the bidder has emerged as the winner of the bids but LOA has not been issued as on the day before opening the financial bids and on-going works to be completed during the period of completion of the subject project along with the

certifications from their Statutory Auditor. Also, the bidder shall ensure that any change in the receipt of payment for the projects considered in the calculation of Value of B is duly supported by issued certificate/documentary proof. Such issued proof/certificate shall be countersigned by the Client or Concessionaire/Authorized Signatory of SPV. If the required documentary evidence is not submitted, the Assessed Available Net Worth shall remain unchanged as on the bid due date for that project.

3. The financial bids of the Responsive bidders shall be opened on **25.03.2026 at 1100 Hrs** at Training Room, Ground Floor, NHAI HQ subject to submission of updated Assessed Available Net Worth, failing which appropriate action may be taken as per RFP.
