Minutes of Tender committee Meeting for financial evaluation of the tender for work of "Eliminating Hotspots / Accident spot locations in Nagercoil-Kavalkinaru section from km 0/0 to km 16/276 of NH-944(Old NH-47B) by providing Solar Street lights. (Tender Ref. no. NHAI/PIU/NH-944/Tender/2025/008)".

1. In the technical evaluation, four (4) bids were received through the e-procurement portal. The receipt of Tender Fee and Bid Security submitted by the bidders were examined. It was observed that M/s. Sudeep Engineers, Aurangabad did not furnish Tender Fee & Bid Security as contemplated in the RFP. Hence the same is rejected as Non-responsive as per clause 16.2 & 16.3 of ITB.

2. Further the bids received from the other three (3) bidders have been evaluated and as per the evaluation, the three bidders, i.e., 1) M/s. S Kannan, Contractor, Dindigul, 2) M/s. RCS, Trichy and 3) M/s. V Best Engineers, Trichy, have qualified in the technical evaluation since the bidders have furnished all the mandatory technical documents as contemplated in the RFP.

3. Since the Three (3) bidders have qualified in the technical bid evaluation, the committee unanimously decided to open and evaluation of financial bid of the both the bidders in accordance with of clause 30 of ITB of RFP.

4. Accordingly, financial bids of the technically qualified Three (3) bidders have been opened on 06.11.2025 @ 11.00 AM. The amount quoted by the bidders are as under:

4. In view of the above, the committee unanimously decided to accept the bid quoted by the L1 bidder M/s. S Kannan, Contractor, Dindigul, for Rs. 18,27,480/- which is 3.0% less than estimated cost along with 10% Performance Security in accordance with of clause 33 of ITB of RFP.
