Minutes of Tender committee Meeting for technical evaluation of the tender for work of "Eliminating Hotspots / Accident spot locations in Nagercoil-Kavalkinaru section from km 0/0 to km 16/276 of NH-944(Old NH-47B) by providing Solar Street lights. (Tender Ref. no. NHAI/PIU/NH-944/Tender/2025/008)".

1. NHAI, PIU-Nagercoil invited bids vide Tender ID: 2025_NHAI_252960_1 for the works of *"Eliminating Hotspots / Accident spot locations in Nagercoil-Kavalkinaru section from km 0/0 to km 16/276 of NH-944(Old NH-47B) by providing Solar Street lights"* with an estimated cost of Rs.9.42 Lakh (excluding GST).

2. A committee has been constituted vide NHAI/PIU/NGL/NH-944/Hotspot/2025/2493dt. 24.10.2025 with the following members to carry out tender evaluation;

1. Shri. T. Velraj, Project Director, PIU-Nagercoil
2. Shri. R. Murugaprakash, DGM(T), RO Madurai
3. Shri. Rajeev Kumar Shukla, Accountant, PIU-Nagercoil

3. The last date for submission of bids and opening of technical bids was scheduled on 27.10.2025 and 28.10.2025 respectively. The Committee opened and decrypted the e-bids submitted online on 28.10.2025. A total of four (4) bids were received through the portal, namely:

- i. M/s. S Kannan, Contractor, Dindigul (Bid ID: 919847)
- ii. M/s. Sudeep Engineers, Aurangabad (Bid ID: 919906)
- iii. M/s. RCS, Trichy (Bid ID: 919929)
- iv. M/s. V Best Engineers, Trichy (Bid ID: 919935)

4. In accordance with MoRTH Circular No. RW/NH-37010/4/2010-EAP (Printing) Vol. IV dated 30.04.2020, the evaluation of bids was carried out based on the documents uploaded in the portal as per the RFP requirements. The receipt of Tender Fee and Bid Security submitted by the bidders were examined. It was observed that M/s. Sudeep Engineers, Aurangabad did not furnish Tender Fee & Bid Security as contemplated in the RFP. Hence the same is rejected as Non-responsive as per clause 16.2 & 16.3 of ITB.

5. Further the bids received from the other three (3) bidders have been evaluated and the detailed evaluation has been attached in Annexure. As per the evaluation, the bidders, i.e., 1) M/s. S Kannan, Contractor, Dindigul, 2) M/s. RCS, Trichy and 3) M/s. V Best Engineers, Trichy, have qualified in the technical evaluation since these three (3) bidders have furnished all the mandatory technical documents as contemplated in the RFP.



6. In view of the above, since the Three (3) bidders have qualified in the technical bid evaluation, the committee unanimously decided to open and evaluation of financial bid of the both the bidders in accordance with of clause 30 of ITB of RFP.
