

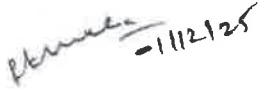

Minutes of Tender committee Meeting for financial evaluation of the tender for work of "Road Safety Works in the existing NH-744 (Old NH-208) from.Km.157/0 to Km.187/0 in the state of Tamilnadu" (Second call), Tender Ref. No. NHAI/PIU/NGL/NH-744/2025/09 (Tender ID: 2025_NHAI_253438_2)

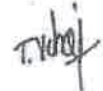
1. In the technical evaluation, Four (4) bids were received through the e-procurement portal. As per the evaluation, the bidder, i.e. Ms. VBest Engineers, Trichy, has furnished shorter bid validity (i.e. 120 days) against the requirement of 165 days as per RFP. Accordingly, the bid submitted by the bidder Ms. VBest Engineers, Trichy has been rejected as Non-Responsive as per clause 15.1 of ITB of RFP.
2. The other three (3) bidders, i.e., 1) M/s. MS Construction, Surandai, 2) M/s.Venkatakrishna Reddy, Nellore and M/s. S. Kannan, Dindigul, have qualified in the technical evaluation since these bidders have furnished all the mandatory technical documents as contemplated in the RFP.
3. Since the Three (3) bidders have qualified in the technical bid evaluation, the committee unanimously decided to open and evaluation of financial bid of the both the bidders in accordance with of clause 30 of ITB of RFP.
4. Accordingly, financial bids of the technically qualified Three (3) bidders have been opened on 25.11.2025 @ 11.00 AM. The amount quoted by the bidders are as under:

5. In view of the above, the committee unanimously decided to accept the bid quoted by the L1 bidder M/s. Venkatakrishna Reddy, Nellore, for Rs. 24,42,317/- which is 25.0% less than estimated cost along with 10% Performance Security (₹2,44,232/-) and 1.33% Additional Performance Security (₹32,564/-) in accordance with of clause 33 of ITB of RFP.
