Minutes of Tender committee Meeting for technical evaluation of the tender for work of "Road Safety Works in the existing NH-744 (Old NH-208) from.Km.157/0 to Km.187/0 in the state of Tamilnadu" (Second call), Tender Ref. No. NHAI/PIU/NGL/NH-744/2025/09 (Tender ID: 2025_NHAI_253438_2).

1. NHAI, PIU-Nagercoil invited bids vide Tender ID: 2025_NHAI_253438_1 for the works of "Road Safety Works in the existing NH-744 (Old NH-208) from.Km.157/0 to Km.187/0 in the state of Tamilnadu" with an estimated cost of Rs.32.56 Lakh (excluding GST).
2. A committee has been constituted vide PIU-Nagercoil letter no. NHAI/PIU/NGL/NH-744/Hotspot/2025/2566 dt. 06.11.2025 with the following members to carry out tender evaluation;
 1. Shri. T. Velraj, Project Director, PIU-Nagercoil
 2. Shri. R. Murugaprakash, DGM(T), RO Madurai
 3. Shri. Rajeev Kumar Shukla, Accountant, PIU-Nagercoil
3. Since, only single bid has been received, the Tender Evaluation Committee unanimously decided to annul the bidding process and call fresh tender as per clause 23 of ITB (Section II) of RFP.
4. Accordingly, the second call for the bids have been invited on 11.11.2025. The last date for submission of bids and opening of technical bids was scheduled on 17.11.2025 and 18.11.2025 respectively. The Committee opened and decrypted the e-bids submitted online on 18.11.2025. It is observed that four (4) bids were received through the portal, namely:
 - i. M/s. MS CONSTRUCTION, Surandai (Bid ID: 927678)
 - ii. M/s. Venkatakrishna Reddy, Nellore (A.P) (Bid ID: 927799)
 - iii. Ms. VBest Engineers, Trichy (Bid ID: 927967)
 - iv. M/s. S. Kannan, Dindigul (Bid ID: 928008)
5. In accordance with MoRTH Circular No. RW/NH-37010/4/2010-EAP (Printing) Vol. IV dated 30.04.2020, the evaluation of bids was carried out based on the documents uploaded in the portal as per the RFP requirements. Receipt of Tender Fee and bid security submitted by the bidders have been confirmed by the Accounts Division of PIU Nagercoil.
6. The bids received from the above bidders have been evaluated and the detailed evaluation has been attached in Annexure. As per the evaluation, the bidder, i.e. Ms. VBest Engineers, Trichy, has furnished shorter bid validity (i.e. 120 days) against the requirement of 165 days as per RFP. Accordingly, the bid submitted

by the bidder Ms. VBest Engineers, Trichy has been rejected as Non-Responsive as per clause 15.1 of ITB of RFP.

7. The other there (3) bidders, i.e., 1)M/s. MS CONSTRUCTION, Surandai, 2) M/s. Venkatakrisna Reddy, Nellore and M/s. S. Kannan, Dindigul, have qualified in the technical evaluation since these bidders have furnished all the mandatory technical documents as contemplated in the RFP.

8. In view of the above, since three (3) bidders have qualified in the technical bid evaluation, the committee unanimously decided to open and evaluation of financial bid of the above three (3) bidders in accordance with of clause 30 of ITB of RFP.
