Your Annual quoted remittance of **Rs. 77,31,95,342/- (Rupees Seventy-Seven Crore Thirty-One Lakh Ninety-Five Thousand Three Hundred and Fourty-Two Only)** for engaging you as the contractor for collection of user fee at above mentioned fee plaza, has been accepted by the competent authority of the Paradip Port Road Company Limited on the terms and conditions of Contract forming part of the Bidding Documents.

2. As per Clause 2.9.1 of RFP, within 7 (Seven) days from the date of issue of this LOA, you are required to submit a Performance Security consisting of followings:

- a) RTGS transfer of amount into Paradip Port Road Company Limited Account [Canara Bank Current A/c. No. 8598201006151; IFSC Code: CNRB0008598], amounting to **Rs. 3,17,75,151/- (Rupees Three Crore Seventeen Lakh Seventy-Five Thousand One Hundred and Fifty-One Only)** by a Scheduled Bank in India; and
- b) a Bank Guarantee as per the format prescribed by the Authority from any Nationalized Indian Bank/State Bank of India or its subsidiaries/IDBI/ ICICI/Export Import Bank/Foreign Bank with counter guarantee from any Nationalized Indian Bank or State Bank of India or its subsidiaries/any RBI approved Scheduled Commercial Bank having net worth of more than Rs. 500 Crore (Rupees Five Hundred Crores) from its Indian Operations for **Rs. 3,17,75,151/- (Rupees Three Crore Seventeen Lakh Seventy-Five Thousand One Hundred and Fifty-One Only)** (an amount equal to 15 day's agreed remittance), valid for a period of 14 (Fourteen) months from the Date of LOA

3. After submission of the Performance Security, the successful bidder shall be required to sign the contract in the form of contract prescribed in Appendix-2 within 3 (Three) days from the date of submission of the Performance Security and after signing the contract, the successful bidder shall be required to take over the fee plaza including adjacent Toilet blocks and start the user fee collection and upkeep/maintenance of adjacent Toilet blocks including recouping the consumable items within 2 (Two) days of date of signing the Contract or within the date as may be prescribed by the Authority in LOA.

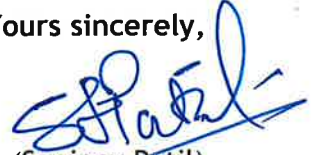
