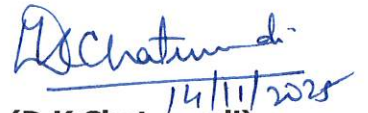
4. The RFP document contains detailed information about qualification/ requirements & evaluation/ selection process for appointment of Independent Engineer.
