ii) M/s Saptagon Asia Private Limited IN Association with Civil Mantra ConsAi Limited vide email dated 12.05.2026 has submitted their representation vide letter no. 1600 dated 12.05.2026 wherein consultant had submitted their brief regarding non-responsiveness in technical evaluation and has self-claimed their marks as 96.00.

iii) M/s Pioneer Infra Consultants Pvt. Ltd. in JV with Artefact Projects Ltd. in association with Neoteric Consultant LLP vide email dated 11.05.2026 has submitted their representation vide letter no. 588 dated 11.05.2026 wherein consultant had submitted their brief regarding non-responsiveness in technical evaluation and has self-claimed their marks as 96.22.

iv) M/s MSPARK Futuristics & Associates In Jv With M/s Armenge Engineering Pvt Ltd vide email dated 13.05.2026 has submitted its representation vide letter no. 1988 dated 12.05.2026 wherein consultant had submitted their brief regarding non-responsiveness in technical evaluation and has self-claimed their marks as 96.26.

v) M/s Sterling Indo Tech Consultants Pvt. Ltd. (SITC), Joint Venture with M/s. Yongma Engineering Co. Ltd. in association with M/s Designilla Private Limited. vide email dated 13.05.2026 has submitted their representation vide letter no. 545 dated 13.05.2026 wherein consultant had submitted their brief regarding non-responsiveness in technical evaluation and has self-claimed their marks as 97.18.

4. The representations were finally examined on the basis of the documents submitted at the time of original technical bid submission, along with valid representations based on technical bid submitted only. Additional documents submitted by bidder in their representations which were not part of original bid submission has not been considered. However, latest Court orders and NHA orders/circulars were taken into account during the final evaluation. Accordingly, the Final Summary/Result of Technical Evaluation is as under:

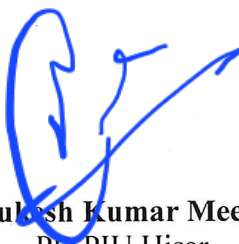
