This Bank Guarantee shall be as per relevant format given in the RFP. The BG shall be valid for a period of 38 months i.e. up to 2 months beyond the expiry of the Contract of 36 months.
6. It is requested to ensure the availability of all key personnel for interview in compliance with policy circular no. 10.1.30 dated 15.11.2021 & 10.1.36 dated 26.09.2023.
