07 (seven) nos. bidders participated who submitted their bids in response to the NIT No. 02/2025 dated 16.12.2025 for the above stated tender work and 03 (three) nos of bidders were qualified in Technical evaluation. The Evaluation Committee vide its meeting dated 21st January 2026 had unanimously recommended to open the Financial e-bids of all the Technically Responsive bidders. Accordingly, the financial e-bids of all the technically qualified bidders have been opened on 29 January 2025 at 11.00 Hrs. The names of the technically qualified bidders are as below:-

Opening of Financial e-Bid:

For opening and evaluation of Technical and Financial e-Bids, a committee was approved by Chief General Manager (Tech) / RO-Kolkata vide RO-Kolkata letter no. NHAI/RO-KOL/001/2025/10/26/1414 dated 29.12.2025 consisting of the following members.

On 29.12.2025 at 11.00 AM, the e-financial bids were opened. No bidder or their authorised representatives were present during the opening of Financial e-Bid. The details of Financial Bids were downloaded and attached herewith. The bidder wise Financial bids are tabulated as under: -

Observation:

The e-Financial Bids of all the above mentioned technically qualified bidders were opened by the committee. From the Price Bid which was downloaded, it has been seen that M/s **Lords Mark Industries Private Limited** has quoted the bid price of **Rs. 6,371,200.00/- (Rupees Sixty-Three lakhs Seventy-One Thousand and Two hundred only)** against the estimated cost of Rs 7,240,000.00/- which is 12% less than that of the estimated cost put to tender and found L1.

As per Clause 12.2 & 20.1 of ITB of RFP, following documents in physical form are to be submitted by the bidders within bid due date: -

- (a) Earnest Money/ Bid Security
- (b) Bid Documents Fees
- (c) Proof of submission of Tender Processing fees

- (g) Integrity Pact

- (d) Notarised copy of original Power of Attorney of Mr. Sachidanand H. Upadhyay.
- (e) Duly Notarised Affidavit along with Undertakings.

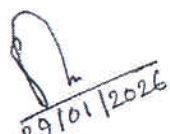
The above-mentioned physical documents have also been verified from the documents uploaded by the firm and found to be in order.

Recommendation: -

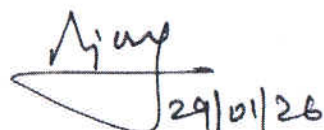
