Reasons for Technical Non-Responsiveness of the bidders:

1. M/s Grnaco Industries and Constructions Ltd

Bidder has not submitted any response to the clarification sought. Accordingly, in view of non-submission of replies, the Bid submitted by the Bidder may be declared as non-responsive in accordance with Clause 3.1.5 of RFP, the relevant extract of which are furnished below-

"If a Bidder does not provide clarifications sought under Clause 3.1.4 above within the prescribed time, its Bid may be liable to be rejected. In case the Bid is not rejected, the Authority may proceed to evaluate the Bid by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of the Authority."

In the absence of available documents, the Bidder fails to meet the minimum eligibility criteria specified in Clause 2.2.2.1, 2.11.1 and 2.20.1 of RFP.

2. M/s RSGV Infra Private Limited

Bidder has not submitted any response to the clarification sought. Accordingly, in view of non-submission of replies, the Bid submitted by the Bidder may be declared as non-responsive in accordance with Clause 3.1.5 of RFP, the relevant extract of which are furnished below-

"If a Bidder does not provide clarifications sought under Clause 3.1.4 above within the prescribed time, its Bid may be liable to be rejected. In case the Bid is not rejected, the Authority may proceed to evaluate the Bid by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of the Authority."

In the absence of available documents, the Bidder fails to meet the minimum eligibility criteria specified in Clause 2.2.2.1, 2.2.2.2(iii), 2.11.1 and 2.20.1 of RFP.

Therefore, in view of the above, the Bidder fails to meet the minimum eligibility criteria as specified in Clause 3.1.6.1, 2.2.2.1, 2.2.2.2(iii), 2.11.1 and 2.20.1 of RFP and further, as per Clause 3.1.5 of RFP, the said Bidder is declared as ineligible for next stage of Bidding.

3. M/s N H Constructions Pvt Ltd

Bidder has claimed a project "Rehabilitation and up-gradation to 2 lane with paved shoulder from existing chainage km 64.535 to km 85.385 (design chainage km 55.800 to km 74.350) under 13 TF on Akhnoor-Poonch road (NH-144A) under Project Sampark (Package-III) in UT of J&K." and submitted certificate issued by the Authority Engineer, that may not be considered as the certificate is not issued by concern client.

Furthermore, cost of the Similar structure is less than required cost mentioned in clause 2.2.2.2(iii) of RFP. Hence, the same may not be considered.
