Centralized Tendering Cell (CTC) of Kakrapar Gujarat Site has invited public tender for above mentioned work by e-tendering process through CPP portal. Technical bid was opened on 03/02/2025 and 05 (Five) bidders have participated in the process.

Based on the scrutiny of the documents submitted by the bidders, the following observations are recorded against the bidders:

- (1) (1/5) M/s C.M.Gaikwad:
Qualified under 1.1(b), 2.1, 2.3, 3, 4 & 9.

- (2) (2/5) M/S B Raviraj Infra Construction (BRIC):

In the submitted Work-1, as per completion certificate the work done value is 98,03,797/- . and this is Work done for Private body. But as per submitted TDS certificate the work done value is Rs. 42,37,288/- which is not meeting the PQ criteria clause 1.1 . Hence not considered.

In the submitted Work-2 , work is not matching with similar work definition mentioned in PQ Criteria Clause 1 sub clause 1.2. Hence, not considered.

In view of above this bidder is DISQUALIFIED under work experience in PQ criteria clause 1.1.

- (3) (3/5) M/s MHK Buildcon LLP

The bidder became MHK Buildcon LLP on 03/08/2023 as per the details submitted by them in the tender.

In the submitted work 1 with Tender no. NWR/ S&C/ RGS/ Civil-102990301, the work was awarded to M/S MHK-AT PLT(JV) and the work was completed on 30/06/2019.

In the submitted work 2 with Agreement no. C & S /1175, the work was awarded to M/s. M H Khanusiya and the work was completed on 15/05/2023.

In both cases , the work was completed before the formation of MHK Buildcon LLP. Thus, as per clause 1.0 Work experience, under 1.3.4 both the works cannot be considered as bidder is claiming experience of previous firm having different name / or style than the LLP firm which is participating in the bid.

In view of above this bidder is DISQUALIFIED under work experience in PQ criteria clause 1.1.

(4) (4/5) M/S Sharma Construction
Qualified under 1.1(C), 2.1, 2.3, 3, 4 & 9.

(5) (5/5) M/S Sai Chaitrali Construction & Servicecs
Qualified under 1.1(C), 2.1, 2.3, 3, 4 & 9.
