Clause 1.1 Work experience

The bidder shall have the experience of similar works satisfying the following eligibility criteria during last 07 (seven) years ending last day of month, previous to the commencement date of sale of tender:

- a) 03 (Three) similar works completed each costing not less than 40% of Estimated cost i.e. Rs. 35.85 Lakhs
OR
b) 02 (Two) similar works completed each costing not less than 50% of Estimated cost i.e. Rs. 44.81 Lakhs
OR
c) 01 (One) similar work completed costing not less than 80% of Estimated cost i.e. Rs. 71.70 Lakhs

Clause 2.0 Financial criteria**Clause 2.1 Average annual financial turnover**

The average annual financial turnover during the last three years ending 31st March of the previous financial years should be at least 30% of estimated cost i.e. Rs. 26.88 Lakhs

Clause 2.3 Solvency Certificate or Net worth Certificate**Clause 2.3.1 Solvency Certificate**

Solvency certificate issued by a Nationalized or any Scheduled bank in favour of the bidder should be for a value not less than at least 40% of the estimated cost put to tender i.e. Rs. 35.85 Lakhs

OR

Clause 2.3.1 Net worth Certificate

Net Worth of the Bidder as per the latest audited financial year previous to the one in which tender sale has been commenced as published on e-tendering portal shall be at least 10% of estimated cost put to tender i.e. Rs. 8.96 Lakhs.

Also, Net Worth of the company has not been eroded by more than 30% in the last 03(three) audited financial years previous to the last day of month previous to the commencement date of sale of tender.

❖ **Bidder at Sl. No. 1/3, M/s NAMBAHADUR**

Evaluated as per clause 1.1 Work experience

Bidder has submitted work for "Civil Maintenance and Auxiliary works at Out Side Operating Island area and Maintenance of Water Supply and Sanitary systems in KAPS 1&2 Plant Site (2021-23)." for Kakrapar Gujarat Site (NPCIL) vide WO No. KAPS/CTC/1-2/SMU/REV/2021/WO/72160 Dated : 28/04/2021. The executed value of work is 3,09,34,275/- which is more than 80% of Estimated cost i.e. Rs. 71.70 Lakhs. Also the work falls in line with similar definition of work.

Evaluated as per Clause 2.0 Financial criteria

As per Clause 2.1 Average annual financial turnover

The annual average turnover of last three years based on submitted documents of bidder is Rs. 271.48 Lakhs which is more than required value of Rs. 26.88 lakhs. Hence, Bidder is Qualified under PQ clause No. 2.1

As per Clause 2.3 Solvency Certificate or Net worth Certificate

Net worth certificate submitted by bidder for FY 2023-24 (As per Bidder Audit for FY 2024-25 is under progress) has a value of Rs. 57.42 lakhs which is greater than the required value of Rs. 8.96 lakhs. Hence, Bidder is Qualified under PQ clause No. 2.3.

The executed value of work is 3,81,99,290/- which is more than 80% of Estimated cost i.e. Rs. 71.70 Lakhs. Also the work falls in line with similar definition of work.

Evaluated as per Clause 2.0 Financial criteria

As per Clause 2.1 Average annual financial turnover

The annual average turnover of last three years based on submitted documents of bidder is Rs. 315.06 Lakhs which is more than required value of Rs. 26.88 lakhs. Hence, Bidder is Qualified under PQ clause No. 2.1

As per Clause 2.3 Solvency Certificate or Net worth Certificate

In response to Query asked on CPP portal, Net worth certificate submitted by bidder for FY 2023-24 (As per Bidder, Audit for FY 2024-25 is under progress) has a value of Rs. 65.74 lakhs which is greater than the required value of Rs. 8.96 lakhs. Hence, Bidder is Qualified under PQ clause No. 2.3.

Evaluated as per Clause 3.0 Registration with EPF

Bidder has submitted two work for "Miscellaneous Civil Maintenance works in New Colony Residential Buildings at Kakrapar Gujarat Site Township." for Kakrapar Gujarat Site (NPCIL) vide WO No. KAPS/CTC/Common/EMG/REV/2020/WO/72118 Dated 29/09/2020 & "Construction of assembly hall for Veljar Primary School under CSR of Kakrapar Gujarat Site" for Kakrapar Gujarat Site (NPCIL) vide WO No. KAPS/CTC/Common/EMG/REV/2020/WO/72111 Dated 28/08/2020. The executed value of works is 47,09,939/- and 51,18,187/- respectively which is more than 50% of Estimated cost i.e. Rs. 44.81 Lakhs. Also the work falls in line with similar definition of work.

Evaluated as per Clause 2.0 Financial criteria

As per Clause 2.1 Average annual financial turnover

The annual average turnover of last three years based on submitted documents of bidder is Rs. 237.71 Lakhs which is more than required value of Rs. 26.88 lakhs. Hence, Bidder is Qualified under PQ clause No. 2.1

As per Clause 2.3 Solvency Certificate or Net worth Certificate

In response to Query asked on CPP portal, Net worth certificate submitted by bidder for FY 2023-24 (As per Bidder, Audit for FY 2024-25 is under progress) has a value of Rs. 96.11 lakhs which is greater than the required value of Rs. 8.96 lakhs. Hence, Bidder is Qualified under PQ clause No. 2.3.

Evaluated as per Clause 3.0 Registration with EPF

Bidder has submitted copy of EPF registration bearing EPF No. **GJ/SRT/31689-D**. Hence, Bidder is qualified under PQ clause No.3.0

Evaluated as per Clause 4.0 Registration with PAN
