If B-1 is not found to be technically & commercially qualified and B-2 is technically and commercially qualified, B-2 will be awarded the contract, and so on In the DoL 7 (seven) numbers of bidders will be selected first, in the order of B-1 (Bidder-1), B-2, B-3, B-4, B-5, B-6 and B-7. The technical and commercial scrutiny will be carried out for these seven bidders only.
