

A. PEC Recommendations:

In view of above deliberations, PEC recommends:

A.1 To award the work to **M/s LALITYA BARUAH, V.C.- 908734 (B-1 bidder)** for “Construction of Boundary wall, guard gumti, Security morcha and canteen, Chemical store, Toilet, dwarf wall with fencing and RCC post, Gate, drain, partition wall, false conductor grouting, HDPE lining, mud protection wall, drains, deep tube well etc. including miscellaneous works during and after drilling operations for drill site RSFM, RSFL & RSAO in cluster with well no-R# 37, R#148 & R#150 in RDS area in RDS area” for an amount of Rs.1,32,79,306.00/- (inclusive of 12% GST), which is at PAR with estimated cost put to tender.
