

Subject: Financial Ranking for Award of Tender against Tender No T16AC25001 for Hiring of 40 MT Cranes

Tender No. T16AC25001 was invited through GePNIC vide Tender ID 2025_ONGC_223977_1 on 15.01.2025 with Starting Date 16.01.2025 for Hiring of 05 Nos. of 40 MT cranes for a period of 03 years at Tripura Asset.

Technical Bid Closing / Opening was originally scheduled on as 06.02.2025 / 07.02.2025 (i.e. 21 days from date of invitation of bid). The TBO date was extended for 01 week on request from prospective bidders. Thus, Bid Submission was closed on 13.02.2025 and Techno-Commercial Bid was opened on the revised date, i.e. 14.02.2025 with 15 Participating Bidders.

After one Round of Clarifications / Confirmations / Deficient Documents, 10 bidders were shortlisted and the offers of 05 bidders were rejected.

Price bids of the 10 bidders were opened on 15.04.2025 where M/s NE OILFIELD SERVICES PRIVATE LIMITED emerged as the L-1 Bidder. The Prices and Ranking of all shortlisted bidders after considering Purchase Preference Policies (PP-MSE and PPP-MII) are as under:
