

A. PEC Recommendations:

In view of above deliberations, PEC recommends:

A.1 To award the work to **M/s RAJIB LOHIA, VC: 933913 (B-1 bidder)** for “Construction of the compound wall at CISF Camp (150 m Brick work and 371 m chain link fencing), Joysagar in RDS area.” for an amount of Rs.1,57,82,537.69/- (inclusive of 18% GST), which is at PAR with estimated cost put to tender.

A.2 To obtain performance security @10% of awarded value i.e. **Rs. 15,78,260.00/-** from **M/s RAJIB LOHIA, VC: 933913**.
