1. Scope of work:

Scope of work & Special Conditions of Contract will be as per **Annexure -III** of tender documents.

2. Price Schedule:

The Contract price for "Comprehensive repair of different types of Packages Airconditioning (AC) units installed at various locations in ONGC Hazira Plant" shall be ₹. 9,18,630/- (Rupees Nine lakh Eighteen Thousand Six Hundred Thirty) inclusive of P&F, To & Fro Transportation, Insurance and all taxes & duties charges.

- Total price at 'Sl. No. 3' shall remain firm for the entire period of the contract except revision permissible under 'Change in Law' provision of tender.
- GST as per prevailing tariff @18% has been considered for the complete scope of work as per tender document. In case of change in tariff during execution of job, same shall be dealt as per Change in law provisions of contract.
- Contractor shall provide all the necessary compliances / Invoice / documents for enabling ONGC to avail Input tax credit benefits, in respect of the payments of GST which are payable against the contract. (GST registration number of ONGC, Hazira Plant Surat is 24AAACO1598A4ZQ; PAN No: AAACO1598AGST)

3. Completion period of Contract: The completion period shall be as per clause 3.0 of SCC Annexure III, i.e. **90 days from the date of NOA or as mentioned in the contract.**

4. Warranty:

Warranty conditions shall be as clause 5.0 of SCC Annexure-III of the tender documents.

5. Liquidated Damages (LD):

Liquidated Damages (LD) shall be as per clause 4.0 of SCC Annexure-III of the tender documents.

6. Performance Security /Security Deposit -

- The contractor shall submit the Security deposit/Performance Bank Guarantee (PBG) of Rs. 91,860.00 (Rupees Ninety-One Thousand Eight Hundred Sixty only (@10% of Contract Price) within 15 days of the date of NOA i.e. on or before 19.07.2025 as per clause 10 of General condition of contract (Annexure -II). The performance bank guarantee shall be drawn in favour of ONGC as per Appendix -I of

- Annexure -II and shall remain valid up to 30.12.2026 (completion period (90 days) + warranty period (12 months) + claim period 90 days).
- b. The Contractor shall be required to submit the proof of successful payment of Security Deposit amount to the designated account of ONGC, and details of payment.
 - c. In case the contractor fails to submit the security deposit / performance Bank Guarantee within stipulated date, ONGC may take action as per conditions specified in the tender.
 - d. Non-submission of PBG within stipulated period may lead to annulment of the contract and action against contractors as per tender/NOA conditions.
 - e. The contractor must confirm within 03 days of issue of this NOA that PBG shall be submitted within 15 days from the date of NOA.
- 7. Terms of Payment:**
Payment will be made as per clause 6 of Annexure -III (SCC) and clause 7.0 of Annexure II of tender documents.
- 8. Contract Signing:**
The detailed contract will be signed by both parties within 30 days of placement of this Notification of Award (NOA).
- 9. Other Terms and Conditions:**
All other terms and conditions of the contract shall be as per subject tender to be read with clarifications/amendments/corrigendum issued (if any) along with written correspondence(s).
- 10.** For the purpose of commencement of activities under the contract, this NOA will constitute a binding between ONGC and the Contractor.
