- 1.0 Oil And Natural Gas Corporation Limited (ONGC) is pleased to place this Notification Of Award (NOA) on **M/s Tulsidas Ramjibhai & Sons** for the work of “**Repair & Renovation works for Gaveshana building, WON Basin, ONGC, Baroda**” against with the Scope of Work and the terms and conditions as detailed in ONGC’s Tender/Bidding documents and subsequent letters / notifications / e-mails / faxes issued by ONGC as in reference above and offer and letters of M/s Tulsidas Ramjibhai & Sons referred as above, at your quoted percentage rate, i.e., 22.23% below the Estimated Cost put to Tender, amounting to **Rs. 2,24,44,075.69 (Rupees Two Crores Twenty Four Lakhs Forty Four Thousand Seventy Five and Paise Sixty Nine only)** which is inclusive of GST at the rate of 18% above basic cost.
- 2.0 The duration of the Contract is **8 (eight) months**, to be reckoned from 7<sup>th</sup> day of the date of issue of NOA or from date of handing over of the site, whichever is later.
- 3.0 Kindly furnish Performance Security for a sum of **Rs. 22,44,408/- (Rupees Twenty Two Lakhs Forty Four Thousand Four Hundred Eight Only)** equivalent to 10% (ten percent) of the contract value **within 30 days** from the date of this Notification Of Award (NOA), i.e., **by 20.02.2026** in line with para 10.0 of GCC for due performance of the Contract. The provisions of clause 36 of the Instructions to Bidder shall be applicable for submission of Performance Security. This Performance Security shall be valid initially for a period to cover the Scheduled Completion period for the works plus defect liability period of 1 year, plus 1 month claim period, as per NIT.
- 4.0 Failure in submission of Performance Security shall constitute sufficient grounds for annulment of award and forfeiture of Bid Security as per Clause 17.7(c) of ITB.
- 5.0 The Contractor shall be required to sign a formal detailed Contract with ONGC for which you are requested to attend this office in person on any working day along with Non-judicial Stamp Paper of Rs. 300/- for executing the Agreement within **30 (thirty) days** from the date of this Notification Of Award (NOA).
