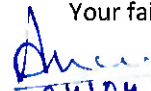

You are requested to comply with the provision of Contract labour (Regulation and Abolition) Act 1970 and Contract labour (Regulation and Abolition) Central rules 1971, Child Labour (prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and condition of Service) Act 1996, Building and other Construction Workers Welfare cess Act 1996 and Minimum Wages Act rules thereof central and state Governments.
5. You are also directed to contact Coordination In-charge (C-I-C), Thiruvananthapuram Airport immediately, who will be the nodal officers for this work. The Airport Support Unit (ASU) at the Airport is functioning under C-I-C, Thiruvananthapuram.

6. Please note that the time allowed for carrying out the work shall be 90 days and same shall be reckoned from the 10th day after issue of this letter.
