5. The licensee shall employ only Indian nationals and get their antecedents and loyalty verified before employing them on the job. The licensee shall ensure that no person of doubtful antecedent and nationality is in anyway associated with the job.

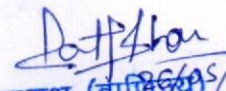
6. In case of Civil/Electrical works, NOC has to be obtained from AAI beforehand.
