B. Qualifying requirements of contractors/ Tenderers containing the following: -

- i) Should have successfully completed or substantially completed three works, each of ₹40.00 Lakh [without GST] or two works each of ₹50.00 Lakh [without GST] or one work of ₹80.00 Lakh [without GST] in single contract of similar nature of Works (Civil Works) during last 07 (seven) years ending last day of month previous to the one in which tenders are invited.

Note: -

1. *The experience certificates of works completed pre GST era, Completion amount will be divided by 1.12 (to exclude pre GST taxes) to make it at par with experience certificates of post GST era but excluding GST.*
2. *The tenders invited for Annual Rate Contracts for O&M/ AMC/ CMC works, agency having experience of completed AMC contract of more than one year shall be counted for the value of work for a completed one year on pro-rata basis. However, the agency who has completed one year of work in running AMC contract of more than one year, may be counted for the value of work for a completed one year on pro-rata basis.*
3. *Experience gained by executing work on back – to – back contract/ Sub- Contract basis is acceptable in the following conditions.*
 - (a) *Work Should be actually executed by the second agency (Sub – Contractor) with due concurrence of the owner as tripartite agreement/ written approval. It should be backed by valid agreement and experience certificate.*
 - (b) *Payments received by second agency should be reflected in TDS certificates.*
4. *Experience gained in composite works for the specialized nature of works (List of Specialized Items/ Jobs/ Works are mentioned at Para 35.3 of AAI Works Manual) were executed by main contractor either by in – house expertise & experience or by engaging the specialized agencies with the approval of main client as per contract conditions. In such cases, main contractor as well as specialized agency both get the experience certificate for the same work from their respective client(s) i.e. main contractor for composite work along with specialized works from owner and specialized agency for specialized work(s) from the main contractor.*

In this situation, the experience certificate of either specialized agency or main agency having in – house expertise & experience, who has actually executed the specialized work(s) shall be considered for Technical/ Pre-qualifying criteria in similar specialized nature of work(s).
5. *Substantial completion shall be based on 80 (eighty) percent (value wise) or more works completed under the contract. Substantial completion should not be defined in terms of percentage completion, rather it should be based on functional consideration. Certificate for 'substantial completion of project/work/asset should contain two parts. Part – I shall contain 'financial value of work done' and Part – II shall contain 'certificate of functional completion of project/ work/ asset'.*

“The value of executed works shall be brought to current costing level by enhancing the actual value of works at simple rate of 7% per annum, calculated from the date of completion to date of bid opening (Cover – I/ Technical bid).

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Tenderers showing work experience certificate from non – government/ non – PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.

- ii) Should have Average Annual Financial Turnover of ₹35.40 Lakh on construction works during last three years ending 31st March of the previous financial year. The Financial Information shall be submitted in the given format Form – B (Proforma – IV, page no. A – 5). Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- iii) The tenderers should have a minimum net worth of ₹15.00 Lakh, issued by certified Chartered Accountants. The Certificate should be submitted in the given format Form – C (Proforma – V, page no. A – 6).

** For Start – ups bidders and Sub-contractors, for repair works estimated cost of upto Rs. 30 lakhs, the requirements regarding General Construction Experience, Particular construction Experience and Available Bid Capacity may not be insisted upon provided the bidders fulfil other criteria regarding Financial/ Personnel/ Equipment capabilities. However, to avoid overstretching of their resources, no such contractors may be allowed to hold more than 2 (Two) contracts under relaxed credentials, at any given time.*

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. No other cells should be changed. Once the details have been completed, the tenderers should save it and submit it online, without changing the filename. 3. Refund of EMD

EMD deposited by all the bidders except the confirmed lowest bidder shall be returned within one week from the date of opening of the financial bid. EMD of the successful bidder shall be returned on receipt of Security Deposit equivalent to EMD amount/ performance bank guarantee.

4. Bid Submission: -

5. Not more than one tender shall be submitted by one tenderer of tenderers having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/ director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tender of both parties liable to rejection.
6. The tenderers shall upload the requisite clarification/ documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <http://etenders.gov.in/eprocure/app>) by clicking on the link “**Online bidder Enrollment**” on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify/ nCode/ eMudhra etc.), with their profile.

e-Tendering brings in economy, efficiency and transparency in the procurement of goods, works and services. CVC are inclined to force implementation of e-Tendering in all Govt. departments & PSUs. Online payment gateway for payment, refund and settlement of EMD and Tender Fee is part of the implementation of e-Tendering system i.e. CPPP <https://etenders.gov.in> .

Stakeholders:

1. **Tender Floating Department:** Airports Authority of India (AAI)
2. **The Technical Service Providers (TSP)** - NIC to facilitate CPP Portal with entire back end process and providing technical support to the Government Dept.
3. **Bank** - AAI has authorized State Bank of India as nodal bank provides payment gateway services and receives Tender fees and Earnest Money Deposits (EMDs) from various bidders participating in e- Tendering/ e-procurement process, holds the amount in Current/Savings Bank account till the time of finalization of tendering process. - b. **Collection of EMD through Bank Guarantee(BG):** During the tender creation TIA will allow the option of “**EMD through BG or EMD Exemption**” so that bidders will be able to upload the copy of BG or Exemption certificate as per tender terms and condition.

***Note:** Keeping in the view of running tender status, the portal currently has both online and offline payment options for next few days, after which the offline mode will be disabled.*

2. During the collection process the amount will be debited from the bidder account and credited to the collection pooling account of the AAI.
3. Till the tender opening all the collected amount will be residing in the collection pooling account of AAI.
4. **Refund and Settlement process:**
 - a. **Step-I:** After opening the tender, bid submitted successfully along with the online payment, the tender fee settled to 'Tender Fee Settlement Account' and EMD amount will remain in 'Pooling Account'.
 - b. **Step-II: On Technical Evaluation:** After submission of technical evaluation report on the CPP portal, the 'EMD of Technically Qualified bidders will remain in the pooling account' and EMD amount of rejected bidders will be refunded to their source account.
 - c. **Step-III: On Financial Evaluation:** After submission of financial evaluation report on the CPP portal, the 'EMD of L1 bidder will remain in the pooling account' and EMD amount of rejected bidders will be refunded to their source account.
 - d. **Step-IV: EMD Refund of L1:** After AOC completion on the portal, the L1 bidders EMD amount will be refunded to their source account and for this Bid managers are advised to complete the AOC process:
 - Only after receiving the PBG and its confirmation from the bank.
 - or**
 - Adjustment of Security Deposit (SD) as per NIT Condition.
5. **In the case of "Cancellation of tender" before opening and "Re-Tender":**
 - All the submitted amount will be refunded to the bidders.
6. **In the case of "Cancellation of tender" after opening and "Re-Tender":**
 - The tender fee has already settled to the AAI's tender fee settlement account at the EoD of tender opening.
 - Now only EMD residing in the collection pooling account, the EMD will be refunded to the bidders.
7. **In case of 'Withdraw of bid' by the vendor:**
 - Procurement system allows the bidder to withdraw till the bid submission closing date, assume that the bidder has paid the amount and withdrawn the bid, eProcurement system will initiate the refund of EMD on the day of tender opening.

8. **In case of Revocation Corrigendum:**

- If TIA publishes revocation corrigendum to accept the rejected bidder than TIA must ask EMD again via offline mode before publishing the revocation corrigendum because EMD amount has already been refunded or refund initiated to the rejected bidders A/c.

9. **Procedure for Forfeiture of EMD through CPP Portal:**

Forfeiture activity can be performed at the time of rejection of the bidder.

Step I: Rejected the bidder during the Technical or Financial Evaluation process.

Step II: On the same day, use the menu “Forfeiture Menu” to Forfeit the EMD.

Step III: Select the tender and then the bidder to forfeit the EMD

Step IV: At the end of the day System will settle the Forfeited EMD to “Forfeited EMD Settlement A/c”

Note: *Forfeiture of EMD will have to be claimed on same day of rejection otherwise it will not be available in the system because at the end of the day CPPP will initiate refund to the rejected bidders.*

General Rules & Rules	All work proposed for execution by contract are notified in a form of invitation to tender pasted in public places /NIC CPP Portal and signed by the officer inviting tender or by publication in Newspapers and posted on AAI web-site and NIC CPP Portal http://etenders.gov.in and www.aai.aero (for reference only). This form will state the work to be carried out, as well as the date for submitting and opening tenders and the time allowed for carrying out the work, also the amount of earnest money to be deposited with the tender, and the amount of the security deposit and Performance guarantee to be deposited by the successful tenderer and the percentage, if any, to be deducted from bills. Copies of the specifications, designs and drawings and any other documents required in connection with the work signed for the purpose of identification by the officer inviting tender shall also be open for inspection by the contractor at the office of officer inviting tender during office hours.
2.		In the event of the e-tender being submitted by a firm, it must be digitally signed. Such tender will be treated as signed tender. For physical tender it must be signed separately by each partner thereof or in the event of the absence of any partner, it must be signed on his behalf by a person holding a power-of-attorney authorizing him to do so, such power of attorney to be produced with the tender, and it must disclose that the firm is duly registered under the Indian Partnership Act, 1952.

17.		The contractor/ bidder shall give a list of AAI employees related to him.
18.		The tender for the work shall not be witnessed by a contractor or contractors/ bidders who himself / themselves has / have tendered or who may and has / have tendered for the same work. Failure to observe this condition would render, tenders of the contractors tendering, as well as witnessing the tender, liable to summary rejection.
19.		The tender for composite work includes, in addition to building work, all other works such as sanitary and water supply installations drainage installation, electrical work, horticulture work, roads and paths etc. The tenderer apart from being a registered contractor (B&R) of appropriate class, must associate himself with agencies of appropriate class which are eligible to tender for sanitary and water supply, drainage, electrical and horticulture works in the composite tender.
20.		The contractor/ bidder shall submit list of works completed in last 5 years* as well as which are in hand (in progress) in the following format for assessing bidding capacity of the bidders:-

21.		The contractor/bidder shall comply with the provisions of the Apprentices Act 1961, and the rules and orders issued there under from time to time. If he fails to do so, his failure will be a breach of the contract and the Executive Director (Engg.) may in his discretion, without prejudice to any other right or remedy available in law, cancel the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation by him of the provisions of the said Act.
22.		If complete site is available for work, the work shall be completed in the manner specified here in special condition of contract and NIT specifications. Note: In such case para 23 below may be deleted by NIT approving authority.
23.		If complete site is not available for taking up the work, the same shall be made available in phases. The scope of work covered in each phase, time for completion of work in each phase and methodology of taking over completed work in phased manner has been specified under special condition of contract. The completion time for each phase shall be applicable as indicated in tender documents. The work shall also be taken over by Engineer-in-Charge in phases. The warranty for the works executed in each phase shall be applied independently w.e.f. date of completion /taking over of individual phase. Note: In such case para 22 above may be deleted by NIT approving authority



CONDITIONS OF CONTRACT

Definitions :

1.		The contract means the documents forming the tender and acceptance thereof and the formal agreement executed between the competent authority on behalf of the Chairman, Airports Authority of India and the Contractor, together with the documents referred to therein including these conditions, the specifications, designs, drawings and instructions issued from time to time by the Engineer-in-Charge and all these documents taken together, shall be deemed to form one contract and shall be complimentary to one another.
2.		In the contract, the following expressions shall, unless the context otherwise requires, have the meanings, hereby respectively assigned to them :-
		i. The expression works or work shall, unless there be something either in the subject or context repugnant to such construction, be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent, and whether original, altered, substituted or additional. ii. The site shall mean the land / or other places on, into or through which work is to be executed under the contract or any adjacent land, path or street through which work is to be executed under the contract or any adjacent land, path or street which may be allotted or used for the purpose of carrying out the contract. iii. The Contractor/tenderer/bidder shall mean the individual, firm or company whether incorporated or not, Joint Venture / Consortium undertaking the works and shall include the legal personal representative of such individual or the persons constituting such firm or company, or the successors of such firm or company and the permitted assignees of such individual, firm or company. iv. The Chairman means the Chairman Airports Authority of India and his Successors. v. The Engineer-in-Charge means the Engineering Officer who shall supervise and be in-charge of the work and who shall sign the contract on behalf of the Chairman, Airports Authority of India as mentioned in Schedule 'F' hereunder. vi. AAI or Airports Authority of India shall mean the Chairman Airports Authority of India. vii. The terms Member (Planning) means the head of Department of Engineering, Airports Authority of India. viii. Accepting Authority shall mean the authority mentioned in Schedule 'F'. ix. Excepted Risk are risks due to riots (other than those on account of contractor's employees), war (whether declared or not) invasion, act of foreign enemies, hostilities, civil war, rebellion revolution, insurrection, terrorism, military or usurped power, any acts of Airports Authority of India, damages from aircraft, acts of God, such as earthquake, lightening and unprecedented floods, and other causes over which the contractor has no control and accepted as such by the Accepting Authority or causes solely due to use or occupation by Airports Authority of India of the part of the works in respect of which a certificate of completion has been issued or a cause solely due to Airports Authority of India's faulty design of works. x. Market Rate shall be the rate as decided by the Engineer-in-Charge on the basis of the prevailing cost of materials and labour at the site where the work is to be executed plus the percentage mentioned in Schedule 'F' to cover, all overheads and profits. Provided that no extra overheads and profits shall be payable on the parts of works assigned to other agency(s) by the contractor as per terms of contract.



		xi. Schedule(s) referred to in these conditions shall mean the relevant schedule(s) annexed to the tender papers or the standard Schedule of Rates of the government mentioned in Schedule 'F' hereunder, with the amendments thereto issued upto the date of receipt of the tender. xii. Department means Airports Authority of India, which invites tender on behalf of Chairman, Airports Authority of India. xiii. Tendered value means the value of the entire work as stipulated in the letter of award.
3.	Scope and Performance	Where the context so requires, words imparting the singular only also include the plural and vice versa. Any reference to masculine gender shall whenever required include feminine gender and vice versa.
4.		Headings and Marginal notes to these General Conditions of Contract shall not be deemed to form part thereof or be taken into consideration in the interpretation or construction thereof or of the contract.
5.		The contractor shall be furnished, free of cost one certified copy of the contract documents except standard specifications, Schedule of Rates and such other printed and published documents, together with all drawings as may be forming part of the tender papers. None of these documents shall be used for any purpose other than that of this contract.
6.	Works to be carried out	The work to be carried out under the Contract shall, except as otherwise provided in these conditions, include all labour, materials, tools, plants, equipment and transport which may be required in preparation of and for and in the full and entire execution and completion of the works. The descriptions given in the Schedule of Quantities (Schedule – A) shall, unless otherwise stated, be held to include wastage on materials, carriage and cartage, carrying and return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion of the work as aforesaid in accordance with good practice and recognized principles.
7.	Sufficiency of Tender	The Contractor shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender for the works and of the rates and prices quoted in the Schedule of Quantities, which rates and prices shall, except as otherwise provided, cover all his obligations under the Contract and all matters and things necessary for the proper completion and maintenance of the works.
8.	Discrepancies and Adjustment of Errors	The several documents forming the Contract are to be taken as mutually explanatory of one another, detailed drawings being followed in preference to small scale drawing and figured dimensions in preference to scale and special conditions in preference to General Conditions.
8.1		In the case of discrepancy between the Schedule of Quantities, the Specifications and / or the Drawings, the following order of preference shall be observed :-
		i. Description of Schedule of Quantities. ii. Particular/ technical Specification and Special Condition, if any. iii. Drawings. iv. MoRTH Specifications v. C P W D Specifications. vi. Indian Standard Specifications of B I S./ IRC Code of Practice / ASTM standards. vii. Sound Engineering practice as directed by the Engineer-in-charge, whose decision in this regard shall final and binding on the contractor.
8.2		If there are varying or conflicting provisions made in any one document forming part of the contract, the Accepting Authority shall be the deciding authority with regard to the intention of the document and his decision shall be final and binding on the contractor.
8.3		Any error in description, quantity or rate in Schedule of Quantities or any omission therefrom shall not vitiate the Contract or release the Contractor from



		the execution of the whole or any part of the works comprised therein according to drawings and specifications or from any of his obligations under the contract.
8.4	Payment for similar items with different quoted rates in different subheads of the contract agreement	If the contractor has quoted different rates for the same item appearing in two or more subheads, then the lowest of the rates quoted shall only be considered for payments during execution of work. In case of deviation of quantity of such item, payments shall be made at the lowest quoted rate for quantity executed upto the deviation limit specified in the contract. Beyond the deviation limit the rate shall be derived as per relevant contract provision.
9.	Reverse Auction for purchase tenders	AAI may opt for reverse auction in case of purchase tender if value of supplies put to tender is more than Rs. 2Cr. 
10.	Signing of Contract	The successful tenderer / contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of :
i)		i. The notice inviting tender, all the documents including drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto. ii. Standard AAI Form as mentioned in Schedule 'F' consisting of : a. Various standard clauses with corrections upto the date stipulated in Schedule 'F' along with annexures thereto. b. AAI Safety Code. c. Model Rules for the protection of health, sanitary arrangements for workers employed by AAI or its contractors. d. AAI Contractor's Labour Regulations. e. List of Acts and omissions for which fines can be imposed. iii. No payment for the work done will be made unless contract in form of agreement is signed by the contractor.

This guarantee shall be in the form of Insurance Surety Bonds, Account Payee Demand Draft, or Bank Guarantee (including e-Bank Guarantee) from any of the Scheduled Commercial Banks (i.e. Indian or Foreign Banks included in the Second Schedule of Reserve Bank of India Act, 1934 excluding Co-Operative/Regional Rural Banks) in accordance with the form annexed hereto. (Appendix-XI).
		ii. Performance guarantee should be furnished within 30 days of issue of award letter. In case the contractor fails to deposit performance guarantee within the stipulated period, no payment will be released to the contractor for the work done in respect of T st running account bill. Moreover, interest @10% per annum on performance guarantee amount would be levied (non-refundable) for delayed period of submission.
		iii. The Performance Guarantee shall be initially valid upto the stipulated date of completion plus 100 days beyond that. In case the time for completion of work gets enlarged the contractor shall get the validity of Performance Guarantee extended to cover such enlarged time for completion of work. After recording of the completion certificate for the work by the competent authority, the performance guarantee shall be returned to the contractor, without any interest. However, in case of contracts involving maintenance of buildings and services / any other work thereafter, 50% of Performance Guarantee shall be retained as Security Deposit as per contract conditions. The same shall be returned on successful completion of commitment year wise proportionately.
		iv. The Engineer-in-Charge shall not make a claim under the performance guarantee except for amounts to which the AAI is entitled under the contract (not withstanding and/or without prejudice to any other provisions in the contract agreement) in the event of: - Failure by the contractor to extend the validity of the Performance Guarantee as described herein above, in which event the Engineer-in-Charge may claim the full amount of the Performance Guarantee. - Failure by the contractor to pay the Chairman, AAI any amount due, either as agreed by the contractor or determined under any of the Clauses/Conditions of the agreement, within 30 days of the service of notice to this effect by Engineer-in-Charge.
		v. In the event of the contract being determined or rescinded under provision of any of the Clause/Condition of the agreement, the performance guarantee shall stand forfeited in full and shall be absolutely at the disposal of the Chairman, AAI.

**CLAUSE 1 A**

	Recovery of Security Deposit	The person/persons whose tender(s) may be accepted (hereinafter called the contractor) shall permit AAI at the time of making any payment to him for work done under the contract to deduct a sum at the rate of 5% of the gross amount of each running and final bill till the sum deducted will amount to security deposit of 5% of the tendered value of the work. Such deductions will be made and held by AAI by way of Security Deposit unless he/they has/have deposited the amount of Security at the rate mentioned above in the form of Bank Guarantee (including e-Bank Guarantee) from any of the Commercial Bank (i.e. Indian or Foreign Banks included in the Second Schedule of Reserve Bank of India Act, 1934 excluding Co-Operative/Regional Rural Banks). In case a Guarantee Bonds of any Bank is furnished by the contractor to the AAI as part of the security deposit and the Bank is unable to make payment against the said Guarantee Bond, the loss caused thereby shall fall on the contractor and the contractor shall forthwith on demand furnish additional security to the AAI to make good the deficit. In works where condition of submission of performance guarantee is not applicable, the security deposit at the rate of 10% (Ten Percent) of gross amount of each running bill shall be deducted instead of 5%, till the sum will amount to security deposit of 10% of the contract value of work. Other conditions shall remain same as stated above. All compensations or the other sums of money payable by the contractor under the terms of this contract may be deducted from, or paid by the sale of a sufficient part of his security deposit or from the interest arising therefrom, or from any sums which may be due to or may become due to the contractor by AAI on any account whatsoever and in the event of his Security Deposit being reduced by reason of any such deductions or sale as aforesaid, the contractor shall within 10 days make good in Fixed Deposit Receipt, Insurance Surety Bonds, Account Payee Demand Draft or Bank Guarantee from any of the Commercial Bank (if deposited for more than 12 months) endorsed in favour of the Airports Authority of India, any sum or sums which may have been deducted from, or raised by sale of his security deposit or any part thereof. The security deposit shall be collected from the running bills and the final bill of the contractor at the rates mentioned above. The security deposit as deducted above can be released against Bank Guarantee issued by any Commercial Bank (i.e. Indian or Foreign Banks included in the Second Schedule of Reserve Bank of India Act, 1934 excluding Co-Operative /Regional Rural Banks), on its accumulations to a minimum of Rs. 5 lakh to the condition amount of such bank guarantee, except last one, shall not be less than Rs. 5 lakh. Note 1: Provided further that the validity of Bank Guarantee shall be in conformity with provisions contained in the clause 17 which shall be extended from time to time depending upon extension of contract under provision of Clause 2 & Clause 5. Note 2: Note 1 above shall be applicable for both clause 1 and 1 A.

	Additional Performance Security	The contractor shall submit an irrevocable additional performance security in the form of an irrevocable Insurance Surety bond, demand draft, bank guarantee issued from Scheduled Commercial Bank (i.e. Indian or Foreign Banks included in the Second Schedule of Reserve Bank of India Act, 1934 excluding Co-Operative / Regional Rural Banks, if the Bid price offered by the selected bidder is lower than 10% of the estimated cost put to tender. (vi) All matters pertaining to validity, extension, claims, forfeiture, and any other conditions in relation to the additional performance security shall be governed by the provisions of Clause 1: Performance Security.

In case the contractor fails to make up for the delay in subsequent milestone(s), amount mentioned against each milestone missed subsequently also shall be withheld. However, no interest, whatsoever, shall be payable on such withheld amount.

If the contractor being a company shall pass a resolution or the court shall make an order that the company shall be wound up or if a receiver or a manager on behalf of a creditor shall be appointed or if circumstances shall arise which entitle the court or the creditor to appoint a receiver or a manager or which entitle the court to make a winding up order. x. If the contractor shall suffer an execution being levied on his goods and allow it to be continued for a period of 21 days.

After giving notice to the contractor to measure up the work of the contractor and to take such whole, or the balance or part thereof, as shall be un-executed out of his hands and to give it to another contractor or any other means to complete the work. The contractor, whose contract is determined as above, shall not be allowed to participate in the tendering process for the balance work. In the event of above courses being adopted by the Engineer-in-Charge, the contractor shall have no claim to compensation for any loss sustained by him by reasons of his having purchased or procured any materials or entered into any engagements or made any advances on account or with a view to the execution of the work or the performance of the contract. And in case action is taken under any of the provision aforesaid, the contractor shall not be entitled to recover or be paid any sum for any work thereof or actually performed under this contract unless and until the Engineer-in-Charge has certified in writing the performance of such work and the value payable in respect thereof and he shall only be entitled to be paid the value so certified.

The contractor shall submit along with every running bill (on account or interim bill) material-wise reconciliation statements supported by complete calculation reconciling material issued, total consumption and certified balance (diagrammatic or item-wise in the case of M & D) and resulting variations and reasons thereof. Engineer-in-charge shall whose decision shall be final and binding on the contractor) be within his rights to follow the procedure of recovery in clause 42 at any stage of the work if reconciliation is not found to be satisfactory. The contractor shall bear the cost of getting the material issued, loading, transporting to site, unloading, storing under cover as required, cutting, assembling and joining the several parts together as necessary. Notwithstanding anything to the contrary contained in any other clause of the contract and all stores / materials so supplied to the contractor or procured with the assistance of the AAI shall remain the absolute property of Authority and the contractor shall be the trustee of the stores/ materials, and the said stores/ materials shall not be removed/ disposed off from the site of the work on any account and shall be at all times open to inspection by the Engineer-in-charge or his authorized agent. Any such stores/ materials remaining unused shall be returned to the Engineer-in-charge in as good a condition in which they were originally supplied at a place directed by him, at a place of issue or any other place specified by him as he shall require, but in case it is decided not to take back the stores/ materials the contractor shall have no claim for compensation on any account of such stores/ materials so supplied to him as aforesaid and not used by him or for any wastage in or damage to in such stores/ materials. On being required to return the stores/ materials, the contractor shall hand over the stores/ materials on being paid or credited such price as the Engineer-in-charge shall determine, having due regard to the condition of the stores/ materials. The price allowed for credit to the contractor, however, shall be at the prevailing market rate not exceeding the amount charged to him, excluding the storage charge, if any. The decision of the Engineer-in-charge shall be final and conclusive. In the event of breach of the aforesaid condition, the contractor shall in addition to

		throwing himself open to account for contravention of the terms of the licenses or permit and/ or for criminal breach of trust, be liable to Authority for all advantages or profits resulting or which in the usual course would have resulted to him by reason of such breach. Provided that the contractor shall in no case be entitled to any compensation or damages on account of any delay in supply or non-supply thereof all or any such materials and stores provided further that the contractor shall be bound to execute the entire work if the materials are supplied by the Authority within the original scheduled time for completion of the work plus 50% thereof or schedule time plus 6 months whichever is more if the time of completion of work exceeds 12 months but if a part of the materials has been supplied within the aforesaid period then the contractor shall be bound to do so much of the work as may be possible with the materials and stores supplied in the aforesaid period. For the completion of the rest of the work, the contractor shall be entitled to such extension of time as may be determined by the Engineer-in-charge whose decision in this regard shall be final and binding on the contractor. DELETED The contractor shall see that only the required quantities of materials are got issued. Any such material remaining unused and in perfectly good/ original condition at the time of completion or determination of the contract shall be returned to the Engineer-in-charge at the stores from which it was issued or at a place directed by him by a notice in writing. The contractor shall not be entitled for loading transporting, unloading and stacking of such unused material except for the extra lead, if any involved, beyond the original place of issue.

	Materials to be provided by the contractor and Mandatory Tests	1. The contractor shall, at his own expense, provide all materials, required for the works other than those which are stipulated to be supplied by the Authority. 2. The contractor shall, at his own expense and without delay supply to the Engineer in-charge samples of materials to be used on the work and shall get these approved in advance. All such materials to be provided by the contractor shall be in conformity with the specifications laid down or referred to in the contract. The contractor shall, if requested by the Engineer-in-charge furnish proof, to the satisfaction of the Engineer-in-charge that the materials so comply. The Engineer-in-charge shall within thirty (30) days of supply of samples or within such further period as he may require intimate to the Contractor in writing whether samples are approved by him or not. If samples are not approved, the Contractor shall forthwith arrange to supply to the Engineer-in-charge for his approval, fresh samples complying with the specifications laid down in the contract. When materials are required to be tested in accordance with specifications, approval of the Engineer-in-charge shall be issued after the test results are received. 3. The contractor shall at his cost submit the samples of materials to be tested or analyzed and shall not make use of or incorporate in the work any materials represented by the samples until the required tests or analysis have been made and materials finally accepted by the Engineer-in-charge. 4. If any additional tests apart from mandatory tests specified in the contract are required to be carried out at the instance of AAI or any other advisory body, to ensure conformity of the item to the contract specifications, the cost of such tests shall be borne by AAI. In case the material/ equipment

		fails in the above tests, the expenditure incurred by AAI on testing of such material or equipment along with incidental charges borne by AAI (if any) shall be recovered from the dues of the contractor and action shall be taken under Clause 16 and other relevant clauses of the contract. 5. The contractor shall not be eligible for any claim or compensation either arising out of any delay in the work or due to any corrective measures required to be taken on account of and as a result of testing of materials. 6. The contractor shall, at his cost, make all arrangements and shall provide all facilities as the Engineer-in-charge may require for collecting and preparing the required number of samples for such tests at such time and to such place or places as may be directed by the Engineer-in-charge and bear all charges including testing charges. The Engineer-in-charge shall have full powers to require the removal from the premises of all materials which in his opinion are not in accordance with the specifications and in case of default, the Engineer-in-charge shall be at liberty to employ at the expense of the contractor, other persons to remove the same without being answerable or accountable for any loss or damage that may happen or arise to such materials. The Engineer-in-charge shall also have full powers to require other proper materials to be substituted thereof and in case of default, the Engineer-in-charge may cause the same to be supplied and all costs which may be attend such removal and substitution shall be borne by the Contractor. 8. The contractor shall at his own expense, provide a material testing lab at the site for conducting routine field tests. The lab shall be equipped at least with the testing equipment as specified in Schedule F. 9. Details in respect of all mandatory tests shall be maintained in the desired format and attached with each Running Account Bill.

CLAUSE 10 B

(I)	Secured Advance on Nonperishable materials	1. The Contractor, on signing an indenture form specified in Appendix-XX, shall be entitled to be paid during the progress of the execution of the work up to 75% of the assessed value of any materials, which are in the opinion of the Engineer-in-charge nonperishable, non-fragile and non-combustible and are in accordance with the contract and which have been brought on the site in connection therewith and are adequately stored and/ or protected against damage by weather or other causes but which have not at time of advance been incorporated in the works. When materials on account of which an advance has been made under this sub-clause are incorporated in the work, the amount of such advance shall be recovered/ deducted from the next payment made under any of the clause or clauses of this contract. Such secured advance shall also be payable on other items of perishable nature, fragile and combustible with the approval of the Engineer-in-charge provided the contractor provides a comprehensive insurance cover for the full cost of such materials. The decision of the Engineer-in-charge shall be final and binding on the contractor in this matter. No secured advance, shall however, be paid on high-risk materials such as ordinary glass, sand, petrol, diesel.

		The secured advance shall also be payable against items brought at site for use in electrical and mechanical systems. Such secured advance shall be paid on submission of Collateral Bank Guarantee submitted by the vendor against the payment in case equipment/system fails to perform on testing and commissioning. Normally secured advance is paid up to 75% of the assessed value of items but in any case it shall not exceed 80% of cost of items indicated for supply of equipment.
(II)	Mobilisation Advance	2. Mobilization advances not exceeding 10% of the tender value may be given, if requested by the contractor in writing within six months of the order to commence the work. Such advance shall be released in two or more installments to be determined by the Engineer-in-Charge at his sole discretion. The first installment of such advance shall be released by the Engineer-in-charge to the contractor on a request made by the contractor to the Engineer-in-Charge in this behalf. (III)	Interest on Mobilization advance	3. The interest, on mobilization, advance shall be calculated from the date of payment to the date of recovery (both days inclusive) on the outstanding amount of advance, simple interest @ prevailing Bank rate + 3%.
(IV)	Recovery of Mobilisation advance	4. Recovery of such sums advanced shall be made by deduction from the contractor's bill commencing after first ten percent of the gross value of the work is executed and paid, on pro-rata percentage basis to the gross value of the work billed beyond 10% in such a way that the entire advance is recovered by the time eighty percent of the gross value of the contract is executed and paid, together with interest due on the entire outstanding amount up to date of recovery of the installment. If the circumstances are considered reasonable by the Engineer-in-charge, the period mentioned for request by the contractor in writing for grant of mobilization advance may be extended at the discretion of the Engineer-in-charge.

The floor may be kutcha but plastered with mud gobri and shall be at least 15 cm (6") above the surrounding ground. The roofs shall be laid with the thatch or any other materials as may be approved by the Engineer-in-Charge and the contractor shall ensure that throughout the period of their occupation, the roofs remain water – tight. - The contractor shall provide each hut with proper ventilation. - All doors, windows and ventilators shall be provided with suitable leaves for security purposes. - There shall be kept an open space of at least 7.2 m (8 yards) between the rows of huts which may be reduced to 6m (20 ft.) according to the availability of site with the approval of the Engineer-in-Charge. The Engineer-in-charge shall record the date and time of receipt of such intimation in the log sheet of the plant or machinery. Based on this if the breakdown before lunch period or major breakdown will be computed considering half a day's breakdown on the day of complaint. If the breakdown occurs in the post lunch period of major breakdown will be computed starting from the next working day. In case of any dispute under this clause, the decision of the Executive Director (Engg) /General Manager (Engg) shall be final and binding on the contractor. v. The hire charges shown above are for each day of 8 hours (inclusive of the one hour lunch break) or part thereof. vi. Hire charges will include service of operating staff as required and also supply of lubricating oil and stores for cleaning purposes. Power fuel of approved type, firewood, kerosene oil etc. for running the plant and machinery and also the full time chowkidar for guarding the plant and machinery against any loss or damage shall be arranged by the contractor who shall be fully responsible for the safeguard and security of plant and machinery. The contractor shall on or before the supply of plant and machinery sign an agreement indemnifying the Department against any loss or damage caused to the plant and machinery either during transit or at site of work. vii. The extension of time for signing of this agreement shall not be generally permitted. The signing time shall only be extended if handing over of site is delayed due to reasons beyond control of the contractor.

SAFETY CODE

1. Suitable Scaffolds should be provided for workmen for all works that cannot safely be done from the ground, or from solid construction except such short period work as can be done safely from ladders. When a ladder is used, an extra mazdoor shall be engaged for holding the ladder and if the ladder is used for carrying materials as well suitable footholds and hand-hold shall be provided on the ladder and the ladder shall be given an inclination not steeper than $\frac{1}{4}$ to 1 ($\frac{1}{4}$ horizontal and 1 vertical).
2. Scaffolding of staging more than 3.6m (12ft.) above the ground or floor, swung or suspended from an overhead support or erected with stationary support shall have a guard rail properly attached or bolted, braced and otherwise secured at least 90 cm. (3ft.) high above the floor or platform of such scaffolding on staging and extending along the entire length of the outside and ends thereof with only such opening as may be necessary for the delivery of materials. Such scaffolding or staging shall be so fastened as to prevent it from swaying from the building or structure.
3. Working platforms, gangways and stairways should be so constructed that they should not sag unduly or unequally, and if the height of the platform or the gangway or the stairway is more than 3.6 m (12ft.) above ground level or floor level, they should be closely boarded, should have adequate width and should be suitably fastened as described in (2) above.
4. Every opening in the floor of a building or in a working platform shall be provided with suitable means to prevent the fall of person or materials by providing suitable fencing or railing whose minimum height shall be 90 cm.(3ft.)
5. Safe means of access shall be provided to all working platforms and other working places. Every ladder shall be securely fixed. No portable single ladder shall be over 9m. (30ft.) in length while the width between side rails in rung ladder shall in no case be less than 29 cm. (11 $\frac{1}{2}$ ") for ladder upto and including 3m. (10ft.) in length. For long ladders, this width should be increased at least $\frac{1}{4}$ " for each additional 30cm. (1 foot) of length. Uniform step spacing of not more than 30cm shall be kept. Adequate precautions shall be taken to prevent danger from electrical equipment. No materials on any of the site or work shall be so stacked or placed as to cause danger or inconvenience to any person or the public. The contractor shall provide all necessary fencing and lights to protect the public from accident and shall be bound to bear the expenses of defence of every suit, action or other proceedings at law that may be brought by any person for injury sustained owing to neglect of the above precautions and to pay any damages and cost which may be awarded in any such suit, action or proceedings to any such person on which may, with the consent of the contractor, be paid to compensate any claim by any such person.
6. a. Excavation and Trenching – All trenches 1.2 m. (4ft.) or more in depth, shall at all times be supplied with at least one ladder for each 30m. (100ft.) in length or fraction thereof, Ladder shall extend from bottom of the Trench to at least 90cm (3fts) above the surface of the ground. The side of the trenches which are 1.5 m. (5 ft.) or more in depth shall be stepped back to give suitable slope or securely held by timber bracing, so as to avoid the danger of sides collapsing. The excavated material shall not be placed within 1.5 m. (5 ft.) of the edges of the trench or half of the depth of the trench whichever is more. Cutting shall be done from top to bottom. Under no circumstances, undermining or undercutting shall be done.



b. Safety Measures for digging bore holes : -

- i. If the bore well is successful, it should be safely capped to avoid caving and collapse of the bore well. The failed and the abandoned ones should be completely refilled to avoid caving and collapse;
 - ii. During drilling, Sign boards should be erected near the site with the address of the drilling contractor and the Engineer-in-charge of the work;
 - iii. Suitable fencing should be erected around the well during the drilling and after the installation of the rig on the point of drilling, flags shall be put 50 Mtr all around the point of drilling to avoid entry of people/animals;
 - iv. After drilling the bore well, a cement platform (0.50 Mtr x 0.50 Mtr x 1.20 Mtr) 0.60 Mtr above ground level and 0.60 Mtr below ground level should be constructed around the well casing;
 - v. After the completion of the borewell, the contractor should cap the borewell properly by welding steel plate, cover the borewell with the drilled wet soil and fix thorny shrubs over the soil. This should be done even while repairing the pump;
 - vi. After the borewell is drilled the entire site should be brought to the ground level;
7. Demolition – Before any demolition work is commenced and also during the progress of the work,
- i) All roads and open areas adjacent to the work site shall either be closed or suitably protected.
 - ii) No electric cable or apparatus which is liable to be a source of danger or a cable or apparatus used by the operator shall remain electrically charged.
 - iii) All practical steps shall be taken to prevent danger to persons employed from risk of fire or explosion or flooding. No floor, roof or other part of the building shall be so overloaded with debris or materials as to render it unsafe.
8. All necessary personal safety equipment as considered adequate by the Engineer-in-Charge should be kept available for the use of the person employed on the site and maintained in a condition suitable for immediate use, and the contractor should take adequate steps to ensure proper use of equipment by those concerned. The following safety equipment shall invariably be provided.
- i) Workers employed on mixing asphaltic materials, cement and lime mortars shall be provided with protective footwear and protective goggles.
 - ii) Those engaged in white washing and mixing or stacking of cement bags or any material which is injurious to the eyes, shall be provided with protective goggles.
 - iii) Those engaged in welding works shall be provided with welder's protective eye-shields.
 - iv) Stone breaker shall be provided with protective goggles and protective clothing and seated at sufficiently safe intervals.
 - v) When workers are employed in sewers and manholes, which are in active use, the contractors shall ensure that the manhole covers are opened and ventilated atleast for an hour before the workers are allowed to get into the manholes, and the manholes so opened shall be cordoned off with suitable railing and provided with warning signals or boards to prevent accident to the public. In addition, the contractor shall ensure that the following safety measures are adhered to:-
- a) Entry for workers into the line shall not be allowed except under supervision of the Sr. Superintendent (Engg.) or any other higher officer.
 - b) At least 5 to 6 manholes upstream and downstream should be kept open for at least 2 to 3 hours before any man is allowed to enter into the manhole for working inside.
 - c) Before entry, presence of toxic gases should be tested by inserting wet lead acetate paper which changes colour in the presence of such gases and gives indication of their presence.



- d) Presence of Oxygen should be verified by lowering a detector lamp into the manhole. In case, no Oxygen is found inside the sewer line, workers should be sent only with oxygen kit.
 - e) Safety belt with rope should be provided to the workers. While working inside the manholes, such rope should be handled by two men standing outside to enable him to be pulled out during emergency.
 - f) The area should be barricaded or condoned off by suitable means to avoid mishaps of any kind. Proper warning signs should be displayed for the safety of the public whenever cleaning works are undertaken during night or day.
 - g) No smoking or open flames shall be allowed near the blocked manhole being cleaned.
 - h) The malba obtained on account of cleaning of blocked manholes and sewer lines should be immediately removed to avoid accidents on account of slippery nature of the malba.
 - i) Workers should not be allowed to work inside the manhole continuously. He should be given rest intermittently. The Engineer-in-Charge may decide the time upto which a worker may be allowed to work continuously inside the manhole.
 - j) Gas masks with Oxygen Cylinder should be kept at site for use in emergency.
 - k) Air-blowers should be used for flow of fresh air through the manholes. Whenever called for, portable air blowers are recommended for ventilating the manholes. The Motors for these shall be vapour proof and of totally enclosed type. Non sparking gas engines also could be used but they should be placed at least 2 metres away from the opening and on the leeward side protected from wind so that they will not be a source of friction on any inflammable gas that might be present.
 - l) The workers engaged for cleaning the manholes / sewers should be properly trained before allowing to work in the manhole.
 - m) The workers shall be provided with Gumboots or non sparking shoes bump helmets and gloves non sparking tools safety lights and gas masks and portable air blowers (when necessary). They must be supplied with barrier cream for anointing the limbs before working inside the sewer lines.
 - n) Workmen descending a manhole shall try each ladder stop or rung carefully before putting his full weight on it to guard against insecure fastening due to corrosion of the rung fixed to manhole well.
 - o) If a man has received a physical injury, he should be brought out of the sewer immediately and adequate medical aid should be provided to him.
 - p) The extent to which these precautions are to be taken depend on individual situation but the decision of the Engineer-in-Charge regarding the steps to be taken in this regard in an individual case will be final.
 - (vi) The Contractor shall not employ men and women below the age of 18 years on the work of painting with products containing lead in any form. Wherever men above the age of 18 are employed on the work of lead painting, the following precaution should be taken:-
 - a) No paint containing lead or lead products shall be used except in the form of paste or ready made paint.
 - b) Suitable face masks should be supplied for use by the workers when paint is applied in the form of spray or a surface having lead paint is dry rubbed and scrapped.
 - c) Overall shall be supplied by the contractors to the workmen and adequate facilities shall be provided to enable the working painters to wash during and on the cessation of work.
9. An additional clause (viii)(i) of AAI Safety Code (iv) the Contractor shall not employ women and men below the age of 18 on the work of painting with product containing lead in any form, wherever men above the age of 18 are employed on the work of lead painting, the following principles must be observed for such use:
- i) White lead, sulphate of lead or product containing these pigment, shall not be used in painting operation except in the form of pastes or paint ready for use.
 - ii) Measures shall be taken, wherever required in order to prevent danger arising from the application of a paint in the form of spray.



- iii) Measures shall be taken, wherever practicable, to prevent danger arising out of from dust caused by dry rubbing down and scraping.
 - iv) Adequate facilities shall be provided to enable working painters to wash during and on cessation of work.
 - v) Overall shall be worn by working painters during the whole of working period.
 - vi) Suitable arrangement shall be made to prevent clothing put off during working hours being spoiled by painting materials.
 - vii) Cases of lead poisoning and suspected lead poisoning shall be notified and shall be subsequently verified by medical man appointed by competent authority of AAI.
 - viii) AAI may require, when necessary medical examination of workers.
 - ix) Instructions with regard to special hygienic precautions to be taken in the painting trade shall be distributed to working painters.
10. When the work is done near any place where there is risk of drowning, all necessary equipments should be provided and kept ready for use and all necessary steps taken for prompt rescue of any person in danger and adequate provision, should be made for prompt first aid treatment of all injuries likely to be obtained during the course of the work.
11. Use of hoisting machines and tackle including their attachments, anchorage and supports shall conform to the following standards or conditions:
- i) (a) These shall be of good mechanical construction, sound materials and adequate strength and free from patent defects and shall be kept repaired and in good working order.
(b) Every rope used in hoisting or lowering materials or as a means of suspension shall be of durable quality and adequate strength, and free from patent defects.
 - ii) Every crane driver or hoisting appliance operator, shall be properly qualified and no person under the age of 21 years should be in charge of any hoisting machine including any scaffolding winch or give signals to operator.
 - iii) In case of every hoisting machine and of every chain ring hook, shackle swivel and pulley block used in hoisting or as means of suspension, the safe working load shall be ascertained by adequate means. Every hoisting machine and all gear referred to above shall be plainly marked with the safe working load. In case of a hoisting machine having a variable safe working load each safe working load and the condition under which it is applicable shall be clearly indicated. No part of any machine or any gear referred to above in this paragraph shall be loaded beyond the safe working load except for the purpose of testing.
 - iv) In case of departmental machines, the safe working load shall be notified by the Electrical Engineer-in-Charge. As regards contractor's machines the contractors shall notify the safe working load of the machine to the Engineer-in-Charge whenever he brings any machinery to site of work and get it verified by the electrical Engineer concerned.
12. Motors, gearing, transmission, electric wiring and other dangerous parts of hoisting appliances should be provided with efficient safeguards. Hoisting appliances should be provided with such means as will reduce to the minimum the risk of accidental descent of the load. Adequate precautions should be taken to reduce to the minimum the risk of any part of a suspended load becoming accidentally displaced. When workers are employed on electrical installations which are already energized, insulating mats, wearing apparel, such as gloves, sleeves and boots as may be necessary should be provided. The worker should not wear any rings, watches and carry keys or other materials which are good conductors of electricity.
13. All scaffolds, ladders and other safety devices mentioned or described herein shall be maintained in safe condition and no scaffold, ladder or equipment shall be altered or removed while it is in use. Adequate washing facilities should be provided at or near places of work.



14. These safety provisions should be brought to the notice of all concerned by display on a notice board at a prominent place at work spot. The person responsible for compliance of the safety code shall be named therein by the contractor.
15. To ensure effective enforcement of the rules and regulations relating to safety precautions the arrangements made by the contractor shall be open to inspection by the Labour Officer or Engineer-in- Charge of the department or their representatives.
16. Notwithstanding the above clauses from (1) to (15), there is nothing in these to exempt the contractor from the operations of any other Act or Rules in force in the Republic of India.



MODEL RULES FOR THE PROTECTION OF HEALTH AND SANITARY ARRANGEMENTS FOR WORKERS EMPLOYED BY AAI OR ITS CONTRACTORS

1. APPLICATION

These rules shall apply to all buildings and construction works in charge of AAI in which twenty or more workers are ordinarily employed or are proposed to be employed in any day during the period during which the contract work is in progress.

2. DEFINITION

Work place means a place where twenty or more workers are ordinarily employed in connection with construction work on any day during the period during which the contract work is in progress.

3. FIRST-AID FACILITIES

- (i) At every work place, there shall be provided and maintained, so as to be easily accessible during working hours, first-aid boxes at the rate of not less than one box for 150 contract labour or part thereof ordinarily employed.
- (ii) The first-aid box shall be distinctly marked with a red cross on white back ground and shall contain the following equipment.
 - (a) For work places in which the number of contract labour employed does not exceed 50 Each first –aid box shall contain the following equipments:
 - 1. 6 small sterilised dressings
 - 2. 3 medium size sterilised dressings
 - 3. 3 large size sterilised dressings
 - 4. 3 large sterilised burn dressings
 - 5. 1 (30 ml) bottle containing a two per cent alcoholic solution of iodine.
 - 6. 1 (30 ml) bottle containing salvolatile having the dose and mode of administration indicated on the label.
 - 7. 1 snakebite lancet.
 - 8. 1 (30 gms) bottle of potassium permanganate crystals.
 - 9. 1 pair scissors.
 - 10. 1 copy of the first-aid leaflet issued by the Director General, Factory Advice Service and Labour Institute, Government of India.
 - 11. 1 bottle containing 100 tablets (each of 5 gms) of aspirin.
 - 12. Ointment for burns.
 - 13. A bottle of suitable surgical antiseptic solution.
 - (b) For work places in which the number of contract labour exceed 50. Each first-aid box shall contain the following equipments.
 - 1. 12 small sterilised dressings.
 - 2. 6 medium size sterilised dressings.
 - 3. 6 large size sterilised dressings
 - 4. 6 large size sterilised burn dressings.
 - 5. 6 (15 gms) packets sterilised cotton wool.
 - 6. 1 (60 ml). Bottle containing two per cent alcoholic solution iodine.
 - 7. 1 (60 ml) bottle containing salvolatile having the dose and mode of administration indicated on the label.
 - 8. 1 roll of adhesive plaster.
 - 9. 1 snake bite lancet.
 - 10. 1 (30 gms) bottle of potassium permanganate crystals.
 - 11. 1 pair scissors.
 - 12. 1 copy of the first-aid leaflet issued by the Director General Factory Advice Service and Labour Institute / Government of India.
 - 13. A bottle containing 100 tablets (each of 5 gms) of aspirin.



14. Ointment for burns.
15. A bottle of suitable surgical antiseptic solution.

- (iii) Adequate arrangements shall be made for immediate recoupment of the equipment when necessary.
- (iv) Nothing except the prescribed contents shall be kept in the First-aid box.
- (v) The first-aid box shall be kept in charge of a responsible person who shall always be readily available during the working hours of the work place.
- (vi) a person in charge of the First-aid box shall be a person trained in First-aid treatment in the work places where the number of contract labour employed is 150 or more.
- (vii) In work places where the number of contract labour employed is 500 or more and hospital facilities are not available within easy distance from the works. First-aid posts shall be established and run by a trained compounder. The compounder shall be on duty and shall be available at all hours when the workers are at work.
- (viii) Where work places are situated in places which are not towns or cities, a suitable motor transport shall be kept readily available to carry injured person or person suddenly taken ill to the nearest hospital.

4. DRINKING WATER

- i) In every work place, there shall be provided and maintained at suitable places, easily accessible to labour, a sufficient supply of cold water fit for drinking.
- ii) Where drinking water is obtained from an intermittent public water supply, each work place shall be provided with storage where such drinking water shall be stored.
- iii) Every water supply or storage shall be at a distance of not less than 50 feet from any latrine drain or other source of pollution. Where water has to be drawn from an existing well which is within such proximity of latrine, drain or any other source of pollution, the well shall be properly chlorinated before water is drawn from it for drinking. All such wells shall be entirely closed in and be provided with a trap door which shall be dust and waterproof.
- iv) A reliable pump shall be fitted to each covered well, the trap door shall be kept locked and opened only for cleaning or inspection which shall be done at least once a month.

5. WASHING FACILITIES

- i) In every work place adequate and suitable facilities for washing shall be provided and maintained for the use of contract labour employed therein.
- ii) Separate and adequate cleaning facilities shall be provided for the use of male and female workers.
- iii) Such facilities shall be conveniently accessible and shall be kept in clean and hygienic condition.

6. LATRINES AND URINALS

- i) Latrines shall be provided in every work place on the following scale namely:
 - a) Where female are employed, there shall be at least one latrine for every 25 females.
 - b) Where males are employed, there shall be at least one latrine for every 25 males.
- ii) Provided that, where the number of males or females exceeds 100, it shall be sufficient if there is one latrine for 25 males or females as the case may be upto the first 100, and one for every 50 thereafter.
- iii) Every latrine shall be under cover and so partitioned off as to secure privacy, and shall have a proper door and fastenings.
- iv) Construction of latrines: The inside walls shall be constructed of masonry or some suitable heat-resisting nonabsorbent materials and shall be cement washed inside and outside at least once a year, Latrines shall not be of a standard lower than borehole system.



- v) (a) Where workers of both sexes are employed, there shall be displayed outside each block of latrine and urinal, a notice in the language understood by the majority of the workers "For Men only" or "For Women Only" as the case may be.
(b) The notice shall also bear the figure of a man or of a woman, as the case may be.
- vi) There shall be at least one urinal for male workers upto 50 and one for female workers upto fifty employed at a time, provided that where the number of male or female workmen, as the case may be exceeds 500, it shall be sufficient if there is one urinal for every 50 males or females upto the first 500 and one for every 100 or part thereafter.
- vii) (a) The latrines and urinals shall be adequately lighted and shall be maintained in a clean and sanitary condition at all times.
(b) Latrines and urinals other than those connected with a flush sewage system shall comply with the requirements of the Public Health Authorities.
- viii) Water shall be provided by means of tap or otherwise so as to be conveniently accessible in or near the latrines and urinals.
- ix) Disposal of excreta: Unless otherwise arranged for by the local sanitary authority, arrangements for proper disposal of excreta by incineration at the work place shall be made by means of a suitable incinerator. Alternately excreta may be disposed of by putting a layer of night soil at the bottom of a pucca tank prepared for the purpose and covering it with a 15 cm. Layer of waste or refuse and then covering it with a layer of earth for a fortnight (when it will turn to manure).
- x) The contractor shall at his own expense, carry out all instructions issued to him by the Engineer in-Charge to effect proper disposal of night soil and other conservancy work in respect of the contractor's workmen or employees on the site. The contractor shall be responsible for payment of any charges which may be levied by Municipal or Cantonment Authority for execution of such on his behalf.

7. PROVISION OF SHELTER DURING REST

At every place there shall be provided, free of cost, four suitable sheds, two for meals and the other two for rest separately for the use of men and women labour. The height of each shelter shall not be less than 3 metres (10 ft) from the floor level to the lowest part of the roof. These shall be kept clean and the space provided shall be on the basis of 0.6 sq.m. (6 sq ft) per head. Provided that the Engineer-in-Charge may permit subject to his satisfaction, a portion of the building under construction or other alternative accommodation to be used for the purpose.

8. CRECHES

- i) At every work place, at which 20 or more women workers are ordinarily employed, there shall be provided two rooms of reasonable dimensions for the use of their children under the age of six years. One room shall be used as a play room for the children and the other as their bedroom. The rooms shall be constructed with specifications as per clause 19 H (ii) a, b & c.
- ii) The rooms shall be provided with suitable and sufficient openings for light and ventilation. There shall be adequate provision of sweepers to keep the places clean.
- iii) The contractor shall supply adequate number of toys and games in the play room and sufficient number of cots and beddings in the bed room.
- iv) The contractor shall provide one ayah to look after the children in the crèche when the number of women workers does not exceed 50 and two when the number of women workers exceed 50.
- v) The use of the rooms earmarked as crèches shall be restricted to children, their attendants and mothers of the children.



9. CANTEENS

- i) In every work place where the work regarding the employment of contractor labour is likely to continue for six months and where in contract labour numbering one hundred or more are ordinarily employed, an adequate canteen shall be provided by the contractor for the use of such contract labour.
- ii) The canteen shall be maintained by the contractor in an efficient manner.
- iii) The canteen shall consist of at least a dining hall, kitchen, storeroom, pantry and washing places separately for workers and utensils.
- iv) The canteen shall be sufficiently lighted at all times when any person has access to it.
- v) The floor shall be made of smooth and impervious materials and inside walls shall be limewashed or colour washed at least once in each year. Provided that the inside walls of the kitchen shall be lime washed every four months.
- vi) The premises of the canteen shall be maintained in a clean and sanitary condition.
- vii) Waste water shall be carried away in suitable covered drains and shall not be allowed to accumulate so as to cause a nuisance.
- viii) Suitable arrangements shall be made for the collection and disposal of garbage.
- ix) The dining hall shall accommodate at a time 30 per cent of the contract labour working at a time.
- x) The floor area of the dining hall, excluding the area occupied by the service counter and any furniture except tables and chairs shall not be less than one square metre (10 sft) per diner to be accommodated as prescribed in Sub-Rule (ix).
- xi) (a) A portion of the dining hall and service counter shall be partitioned off and reserved for women workers in proportion to their number. (b) Washing places for women shall be separate and screened to secure privacy.
- xii) Sufficient tables stools, chairs or benches shall be available for the number of diners to be accommodated as prescribed in Sub-Rule (ix).
- xiii) (a) 1. There shall be provided and maintained sufficient utensils crockery, furniture and any other equipment necessary for the efficient running of the canteen.
2. The furniture utensils and other equipment shall be maintained in a clean and hygienic condition.
(b) 1. Suitable clean clothes for the employees serving in the canteen shall be provided and maintained.
2. A service counter, if provided, shall have top of smooth and impervious material.
3. Suitable facilities including an adequate supply of hot water shall be provided for the cleaning of utensils and equipments.
- xiv) The food stuffs and other items to be served in the canteen shall be in conformity with the normal habits of the contract labour.
- xv) The charges for food stuffs, beverages and any other items served in the canteen shall be based on 'No Profit, No loss' and shall be conspicuously displayed in the canteen.
- xvi) In arriving at the price of foodstuffs, and other article served in the canteen, the following items shall not be taken into consideration as expenditure namely :-
 - a) The rent of land and building.
 - b) The depreciation and maintenance charges for the building and equipments provided for the canteen.
 - c) The cost of purchase, repairs and replacement of equipments including furniture, crockery, cutlery and utensils.
 - d) The water charges and other charges incurred for lighting and ventilation.
 - e) The interest and amounts spent on the provision and maintenance of equipments provided for the canteen.
- xvii) The accounts pertaining to the canteen shall be audited once every 12 months by registered accountants and auditors.



10. ANTI-MALARIAL PRECAUTIONS

The contractor shall at his own expense, conform to all anti-malarial instructions given to him by the Engineer-in-Charge including the filling up of any borrow pits which may have been dug by him.

11. The above rules shall be incorporated in the contracts and in notices inviting tenders and shall form an integral part of the contracts.

12. AMENDMENTS

AAI may, from time to time, add to or amend these rules and issue directions - it may consider necessary for the purpose of removing any difficulty which may arise in the administration thereof.



AIRPORTS AUTHORITY OF INDIA

Contractor's Labour Regulations

1. SHORT TITLE

These regulations may be called the AAI Contractors Labour Regulations.

2. DEFINITIONS

(i) **Workman** means any person employed by AAI or its contractor directly or indirectly through a subcontractor with or without the knowledge of the AAI to do any skilled, semiskilled or unskilled manual, supervisory, technical or clerical work for hire or reward, whether the terms of employment are expressed or implied but does not include any person:-

- a) Who is employed mainly in a managerial or administrative capacity: or
- b) Who, being employed in a supervisory capacity draws wages exceeding five hundred rupees per mensem or exercises either by the nature of the duties attached to the office or by reason of powers vested in him, functions mainly of managerial nature : or
- c) Who is an out worker, that is to say, person to whom any article or materials are given out by or on behalf of the principal employers to be made up cleaned, washed, altered, ornamental finished, repaired adopted or otherwise processed for sale for the purpose of the trade or business of the principal employers and the process is to be carried out either in the home of the out worker or in some other premises, not being premises under the control and management of the principal employer. No person below the age of 14 years shall be employed to act as a workman.

(ii) **Fair Wages** means wages whether for time or piece work fixed and notified under the provisions of the Minimum Wages Act from time to time.

(iii) **Contractors** shall include every person who undertakes to produce a given result other than a mere supply of goods or articles of manufacture through contract labour or who supplies contract labour for any work and includes a subcontractor.

(iv) **Wages** shall have the same meaning as defined in the Payment of Wages Act.

3. i) Normally working hours of an adult employee should not exceed 9 hours a day. The working day shall be so arranged that inclusive of interval for rest, if any, it shall not spread over more than 12 hours on any day.
- ii) When an adult worker is made to work for more than 9 hours on any day or for more than 48 hours in any week, he shall be paid over time for the extra hours put in by him at double the ordinary rate of wages.
- iii) a) Every worker shall be given a weekly holiday normally on a Sunday, in accordance with the provisions of the Minimum Wages (Central) Rules 1960 as amended from time to time irrespective of whether such worker is governed by the Minimum Wages Act or not.
- b) Where the minimum wages prescribed by the Central/State Government under the Minimum Wages Act are not inclusive of the wages for the weekly day of rest, the worker shall be entitled to rest day wages at the rate applicable to the next preceding day, provided he has worked under the same contractor for a continuous period of not less than 6 days.
- c) Where a contractor is permitted by the Engineer-in-Charge to allow a worker to work on a normal weekly holiday, he shall grant a substituted holiday to him for the whole day on one of the five days immediately before or after the normal weekly holiday and pay wages to such worker for the work performed on the normal weekly holiday at overtime rate.

4. DISPLAY OF NOTICE REGARDING WAGES ETC.

The contractor shall before he commences his work on contract, display and correctly maintain and continue to display and correctly maintain in a clear and legible condition in conspicuous places on the work, notices in English and in the local Indian languages spoken by the majority of the workers giving the minimum rates of wages fixed under Minimum Wages Act, the actual wages being paid, the hours of work for which such wage are earned, wages periods, dates of payments of wages and other relevant information as per Appendix 'VIII'.



5. PAYMENT OF WAGES

- (i) The contractor shall fix wage periods in respect of which wages shall be payable.
- (ii) No wage period shall exceed one month.
- (iii) The wages of every person employed as contract labour in an establishment or by a contractor where less than one thousand such persons are employed shall be paid before the expiry of seventh day and in other cases before the expiry of tenth day after the last day of the wage period in respect of which the wages are payable.
- (iv) Where the employment of any worker is terminated by or on behalf of the contractor the wages earned by him shall be paid before the expiry of the second working day from the date on which his employment is terminated.
- (v) All payment of wages shall be made on a working day at the work premises and during the working time and on a date notified in advance and in case the work is completed before the expiry of the wage period, final payment shall be made within 48 hours of the last working day.
- (vi) Wages due to every worker shall be paid to him direct or to other person authorised by him in this behalf.
- (vii) All wages shall be paid in current coin or currency or in both.
- (viii) Wages shall be paid without any deductions of any kind except those specified by the Central Government by general or special order in this behalf or permissible under the Payment of Wages Act 1956.
- (ix) A notice showing the wages period and the place and time of disbursement of wages shall be displayed at the place of work and a copy sent by the contractor to the Engineer-in-Charge under acknowledgement.
- (x) It shall be the duty of the contractor to ensure the disbursement of wages in the presence of the Senior Superintendent Engg or authorised representative of the Engineer-in-Charge who will be required to be present at the place and time of disbursement of wages by the contractor to workmen.
- (xi) The contractor shall obtain from Engineer in charge or the authorised representative of the Engineer-in-Charge a certificate under his signature at the end of the entries in the "Register of Wages" or the "Wage-cum-Muster Roll" as the case may be in the following form:
 "Certified that the amount shown in column No. has been paid to the workman concerned in my presence onat....."

Note: In case of payment of wages paid through bank, the contractor shall submit a copy of bank statement for relevant period duly signed by him.

6. FINES AND DEDUCTIONS WHICH MAY BE MADE FROM WAGES

- (i) The wages of a worker shall be paid to him without any deduction of any kind except the following:
 - a) Fines
 - b) Deductions for absence from duty i.e. from the place or the places where by the terms of his employment he is required to work. The amount of deduction shall be in proportion to the period for which he was absent.
 - c) Deduction for damage to or loss of goods expressly entrusted to the employed person for custody, or for loss of money or any other deduction which he is required to account, where such damage or loss is directly attributable to his neglect or default.
 - d) Deduction for recovery of advances or for adjustment of overpayment of wages, advances granted shall be entered in a register.
 - e) Any other deduction which the Central Government may from time to time allow.
- (ii) No fines should be imposed on any worker save in respect of such acts and omissions on his part as have been approved of by the Chief Labour Commissioner.
Note: An approved list of Acts and Omissions for which fines can be imposed is enclosed at Appendix-XII.



- (iii) No fine shall be imposed on a worker and no deduction for damage or loss shall be made from his wages until the worker has been given an opportunity of showing cause against such fines or deductions.
- (iv) The total amount of fine which may be imposed in any one wage period on a worker shall not exceed an amount equal to three paise in a rupee of the total wages, payable to him in respect of that wage period.
- (v) No fine imposed on any worker shall be recovered from him by installment, or after the expiry of sixty days from the date on which it was imposed.
- (vi) Every fine shall be deemed to have been imposed on the day of the act or omission in respect of which it was imposed.

7. LABOUR RECORDS

- (i) The contractor shall maintain a Register of persons employed on work on contract in Form XIII of the CL(R&A) Central Rules 1971 (Appendix VI)
- (ii) The contractor shall maintain a Muster Roll register in respect of all workmen employed by him on the work under Contract in Form XVI of the CL (R&A) Rules 1971 (Appendix VII).
- (iii) The contractor shall maintain a Wage Register in respect of all workmen employed by him on the work under contract in Form XVII of the CL (R&A) Rules 1971 (Appendix VIII)
- (iv) **Register of accident** - The contractor shall maintain a register of accidents in such form as may be convenient at the work place but the same shall include the following particulars :
 - (a) Full particulars of the labourers who met with accident.
 - (b) Rate of Wages
 - (c) Sex
 - (d) Age
 - (e) Nature of accident and cause of accident
 - (f) Time and date of accident
 - (g) Date and time when admitted in Hospital
 - (h) Date of discharge from the Hospital
 - (i) Period of treatment and result of treatment
 - (j) Percentage of loss of earning capacity and disability as assessed by Medical officer
 - (k) Claim required to be paid under Workmen's Compensation Act.
 - (l) Date of payment of compensation
 - (m) Amount paid with details of the person to whom the same was paid
 - (n) Authority by whom the compensation was assessed.
 - (o) Remarks
- (v) The contractor shall maintain a **Register of Fines** in the Form XII of the CL(R&A) Rules 1971 (Appendix-XIII).
The contractor shall display in a good condition and in a conspicuous place of work the approved list of acts and omissions for which fines can be imposed (Appendix-XII)
- (vi) The contractor shall maintain a **Register of deductions for damage or loss** in Form XX of the CL (R&A) Rules 1971 (Appendix-XIV)
- (vii) The contractor shall maintain a **Register of Advances** in Form XXIII of the CL (R&A) Rules 1971 (Appendix-XV)
- (viii) The contractor shall maintain a **Register of Overtime** in Form XXIII of the CL (R&A) Rules 1971 (Appendix-XVI).

8. ATTENDANCE CARD-CUM-WAGE SLIP

- (i) The contractor shall issue an **Attendance card-cum-wage** slip to each workman employed by him in the specimen form at (Appendix-IX)
- (ii) The card shall be valid for each wage period.
- (iii) The contractor shall mark the attendance of each workman on the card twice each day, once at the commencement of the day and again after the rest interval, before he actually starts work.
- (iv) The card shall remain in possession of the worker during the wage period under reference.



- (v) The contractor shall complete the wage slip portion on the reverse of the card at least a day prior to the disbursement of wages in respect of the wage period under reference.
- (vi) The contractor shall obtain the signature or thumb impression of the worker on the wage slip at the time of disbursement of wages and retain the card with himself.

9. EMPLOYMENT CARD

The contractor shall issue an **Employment Card** in Form XIV of the CL (R&A) Central Rules 1971 to each worker within three days of the employment of the worker (Appendix-X).

10. SERVICE CERTIFICATE

On termination of employment for any reason whatsoever the contractor shall issue to the workman whose services have been terminated, a **Service certificate** in Form XV of the CL(R&A) Central Rules 1971.

11. PRESERVATION OF LABOUR RECORDS

All records required to be maintained under Regulations Nos. 6 & 7 shall be preserved in original for a period of three years from the date of last entries made in them and shall be made available for inspection by the Engineer-in-Charge or Labour Officer or any other officers authorised by the Ministry of Urban Development in this behalf.

12. POWER OF LABOUR OFFICER TO MAKE INVESTIGATIONS OR ENQUIRY

The Labour Officer or any person authorised by Central Government on their behalf shall have power to make enquiries with a view to ascertaining and enforcing due and proper observance of Fair Wage Clauses and the Provisions of these Regulations. He shall investigate into any complaint regarding the default made by the contractor or subcontractor in regard to such provision.

13. REPORT OF LABOUR OFFICER

The Labour Officer or other persons authorised as aforesaid shall submit a report of result of his investigation or enquiry to the Engineer-in-Charge concerned indicating the extent, if any, to which the default has been committed with a note that necessary deductions from the contractor's bill be made and the wages and other dues be paid to the labourers concerned. In case an appeal is made by the contractor under Clause 13 of these regulations, actual payment to labourers will be made by the Engineer-in-Charge after G.M. Engg. has given his decision on such appeal.

(i) Engineer-in-Charge shall arrange payments to the labour concerned within 45 days from the receipt of the report from the Labour Officer or the G.M. Engineer as the case may be.

14. APPEAL AGAINST THE DECISION OF LABOUR OFFICER

Any person aggrieved by the decision and recommendations of the Labour Officer or other person so authorised may appeal against such decision to the Engineer-in-Charge concerned within 30 days from the date of decision, but subject to such appeal, the decision of the officer shall be final and binding upon the contractor.

15. PROHIBITION REGARDING REPRESENTATION THROUGH LAWYER

- (i) A workman shall be entitled to be represented in any investigation or enquiry under these regulations by :
 - a) An officer of a registered trade union of which he is a member.
 - b) An officer of a federation of trade unions to which the trade union referred to in Clause (a) is affiliated.



- c) Where the employer is not a member of any registered trade union, by an officer of a registered trade union, connected with the industry in which the worker is employed or by any other workman employed in the industry in which the worker is employed.
- (ii) An employer shall be entitled to be represented in any investigation or enquiry under these regulations by :
 - a) An officer of an association of employers of which he is a member.
 - b) An officer of a federation of associations of employers to which association referred to in Clause(a) is affiliated.
 - c) Where the employers is not a member of any association of employers, by an officer of association of employer connected with the industry in which the employer is engaged or by any other employer, engaged in the industry in which the employer is engaged.
- (iii) No party shall be entitled to be represented by a legal practitioner in any investigation or enquiry under these regulations.

16. INSPECTION OF BOOKS AND SLIPS

The contractor shall allow inspection of all the prescribed labour records to any of his workers or to his agent at a convenient time and place after due notice is received or to the Labour Officer or any other person, authorised by the Central Government on his behalf .

17. SUBMISSION OF RETURNS

The contractor shall submit periodical returns as may be specified from time to time.

18. AMENDMENTS

The Central Government/AAI may from time to time add to or amend the regulations and on any question as to the application/interpretation or effect of those regulations the decision of the General Manager (Engg.) concerned shall be final.

2. We Bank, further agree that AAI shall be the sole judge of and as to whether the said Contractor has committed any breach or breaches of any of the terms and conditions of the said contract and the extent of loss, damage, costs, charges and expenses caused to or suffered by or that may be caused to or suffered by AAI on account thereof and the decision of AAI that the said Contractor has committed such breach and breaches and as to the amount or amounts of loss, damage, costs, charges and expenses caused to or suffered of that may be caused to or suffered by AAI from time to time shall be final and binding on us.

3. We, the said Bank, further agree that the Guarantee herein contained shall remain in full force and effect during the period that would be taken for the performance of the said contracts and till all the dues of AAI under the said contract or by virtue of any of the terms and conditions governing the said contract including compensation for delay if any as decided by AAI, have been fully paid and its claims satisfied or discharged and till the Accepting Authority of the contract certifies that the terms and condition and accordingly Contract have been fully and properly carried out by the said contractor and accordingly discharges this guarantee subject, however that AAI shall have no claim under this Guarantee after 90(Ninety) days from the date of expiry of the defects Liabilities periods or Final /Extension of Time grated by AAI as provided available in agreements clause no.....as provided in the said Contract, i.e.....(date) or from the date of cancellation of the said contract, as the case may be, unless a notice of the claim under this Guarantee has been served on the Bank before the expiry of the period in which case the same shall be enforceable against the Bank notwithstanding the fact, that the same is enforced after the expiry of the said period.



4. AAI shall have the fullest liberty without affecting in any way the liability of the bank under this Guarantee or Indemnity from time to time to vary any of the terms and conditions of the said contract or to extend time of performance by the said Contractor or to postpone for any time and from time to time any of the powers exercisable by it against the said Contractor and either to enforce or forbear from enforcing any of terms and conditions governing the said contract or securities available to AAI and the said Bank shall not be released from its liability under these present by any exercise by AAI of any liberty with reference to the matters aforesaid or by reason of time being given to the said contractor or any other forbearance, act or omission on the part by AAI or any indulgence by AAI to the said Contractor or any other matter or thing whatsoever which under the law relating to sureties would but for this provision have the effect of so releasing the Bank from its such liability.
5. It shall not be necessary for AAI to proceed against the contractor before proceeding against the Bank and the Guarantee herein contained shall be enforceable against the Bank, notwithstanding any security which AAI may have obtained or obtain from the Contractor at the time when proceedings are taken against the Bank hereunder be outstanding or unrealized.
6. We, the said Bank, lastly undertake not to revoke this Guarantee during its currency except with the previous consent of AAI in writing and agree that any charge in the Constitution of the said Contract or the said Bank shall not discharge our liability hereunder.

.....represented by of the other part, hereinafter called the “Bidder/Contractor “(which term shall unless excluded by or is repugnant to the context be deemed to include its heirs, representatives, successors and assigns of the Bidder/Contractor)

WHEREAS the Authority intends to award under laid down organizational procedures tender contract for The Authority, while discharging its functions on business principles, values proper compliance with all relevant laws and regulations, and the principles of natural justice, ethics, equity, fairness and transparency in its relations with the Bidders/Contractors.

WHEREAS the Authority is desirous to make its business mechanism more transparent, thus to ensure strict adherence of the aforesaid objectives/goals, the Authority hereby adopts the instrument developed by the renowned international non-governmental organization “Transparency International” (T I) headquartered in Berlin (Germany). The Authority will appoint an Independent External Monitor (IEM) who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

AND WHEREAS the Bidder is submitting a tender to the Authority forIn response to the NIT (Notice Inviting Tender) dated..... Contractor is signing the contract for execution ofNOW, therefore, To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to Enabling the Authority to obtain the desired said stores/equipment/execution of works at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and Enabling Authority to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the Authority will commit to prevent corruption, in any form, by its officials by following transparent procedures. The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

1. Commitments of the Authority;

- 1.1 The Authority undertakes that no official of the Authority, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.
- 1.2 The Authority will, during the pre-contact stage, treat all BIDDERS alike, and will provide to all BIDDERS the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERS.
- 1.3 All the officials of the Authority will report to the appropriate authority office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.
- 1.4 In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the Authority with full and verifiable facts and the same is prima facie found to be correct by the Authority, necessary disciplinary proceedings or any other action deemed fit including criminal proceedings may be initiated by the Authority and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the Authority the proceedings under the contract would not be stalled.

1. Commitments of Bidders/Contractor.

- The Bidder/Contractor commits itself to take all measures necessary to prevent corrupt practice, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following.
- 2.1 The Bidder/Contractor will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- 2.2 The Bidder/Contractor further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Authority for showing or

23 The Bidder / Contractor has not entered and will not enter with other bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specification, certifications, subsidiary contracts, submission or non-submission of bids or any actions to restrict competitiveness or to introduce cartelization in the bidding process.

24 The Bidder/Contractor shall, when presenting his bid, disclose the name and address of agents and representatives and Indian BIDDERS shall disclose their foreign principals or associates.

If BIDDERS has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.

27 The Bidder/Contractor, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made or has committed to or intends to make to officials of the Authority or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.

28 The Bidder/Contractor will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

29 The Bidder/Contractor will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.

2.10 The Bidder / Contractor shall not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the Authority as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The Bidder / Contractor also under takes to exercise due and adequate care lest any such information is divulged.

2.11 The Bidder/Contractor will inform to the Independent External Monitor.

- 3.2 The Bidder/Contractor agrees that if it makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason and he may be considered for debarment for future tender/contract processes.
- 3.3 That the Bidder/Contractor undertakes to get this Pact signed by the subcontractor (s) and associate(s) whose value of the work contribution exceeds Rs 0.5 Cr. (Rupees zero point five Cr.) and to submit the same to the Authority along-with the tender document/ contract before contract signing.
- 3.4. That sub-contractor(s)/ associate(s) engaged by the Contractor, with the approval of the Authority after signing of the contract, and whose value of the work contribution exceeds Rs 0.5 Cr. (Rupees Zero point five Cr.) will be required to



sign this Pact by the Contractor, and the same will be submitted to the Authority before doing/ performing any act/ function by such subcontractor(s) / associate(s) in relation to the contract/ work.

3.5 That the Authority will disqualify from the tender process all Bidder(s) who don't sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority

3.6 That if the Contractor(s) does/ do not sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority. Authority will terminate the contract and initiate appropriate action against such Contractor(s).

4. Earnest Money, Security Deposit, Bank Guarantee, Draft, Pay order or any other mode and its validity i/c Warranty Period, Performance Guarantee/Bond.

While submitting bid, the BIDDER shall deposit an EMD/SD/BG/DRAFT/PAY ORDER ETC I/C WARRANTY PERIOD, PG/BOND, VALIDITY etc., which is as per terms and conditions and details given in NIT / tender documents sold to the Bidders.

5. Sanctions for Violations/Disqualification from tender process and exclusion from future Contacts.

5.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it causing loss to itself (which will be without the knowledge of the BIDDER) shall entitle the Authority to take all or any one of the following actions, wherever required:

- i) To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- ii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- iii) If the Authority has disqualified / debarred the Bidder from the tender process prior to the award under section 2 or 3 or 4, the Authority is entitled to forfeit the earnest money deposited/bid security.
- iv) To recover all sums already paid by the Authority, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the Authority in connection with any other contract or any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.



- v) To en-cash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.
- vi) To cancel all or any other Contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the Authority resulting from such cancellation/rescission and the Authority shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- vii) To debar the BIDDER from participating in future bidding processes for a minimum period of three years, which may be further extended at the discretion of the Authority.
- viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- ix) In case where irrevocable Letters of Credit have been received in respect of any contract signed by the Authority with the BIDDER, the same shall not be opened.
- x) Forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- xi) That if the Authority have terminated the contract under section 2 or 3 or 4 or if the Authority is entitled to terminate the contract under section 2 or 3 or 4, the Authority shall be entitled to demand and recover from the contractor damages equivalent to 5% of the contract value or the amount equivalent to security deposit or performance bank guarantee, whichever is higher.
- xii) That the Bidder / Contractor agrees and undertakes to pay the said amount without protest or demur subject only to condition that if the Bidder/Contractor can prove and establish to the satisfaction of the Authority that the disqualification / debarment of the bidder from the tender process or the termination of the contract after award of the contract has caused no damage to the Authority.

5.2 The Authority will be entitled to take all or any of the actions mentioned at para 5.1 above.

5.3 (i) to (xii) of this Pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.

- 5.4 That if the Bidder/Contractor applies to the Authority for premature revocation of the debarment and proves to the satisfaction of the Authority that he has installed a suitable and effective corruption prevention system and also restored/recouped the damage, if any, caused by him, the Authority may, if thinks fit, revoke the debarment prematurely considering the facts and circumstances of the case, and the documents/evidence adduced by the Bidder/Contractor for first time default.
- 5.5 That a transgression is considered to have occurred if the Authority is fully satisfied with the available documents and evidence submitted along with Independent External Monitor's recommendations/suggestions that no reasonable doubt is possible in the matter.
- 5.6 The decision of the Authority to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent External Monitor(s) appointed for the purpose of this Pact.
6. **Allegations against Bidders/Contractors/ Sub-Contractors/Associates:**
- That if the Authority receives any information of conduct of a Bidder/ Contractor or Sub- Contractor or of an employee or a representative or an associate of the Bidder, Contractor or Sub- Contractor which constitute corruption, or if the Authority has substantive suspicion in this regard, the Authority will inform the Vigilance Department for appropriate action.
7. **Independent External Monitor(s),**
- 7.1. That the Authority has appointed competent and credible Independent External Monitor(s) for this Pact.
- 7.2. The task of the Monitor(s) is to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact. He will also enquire into any complaint alleging transgression of any provision of this Pact made by the Bidder, Contractor or Authority.
- 7.3. That the Monitor(s) is not subject to any instructions by the representatives of the parties and would perform his functions neutrally and independently. He will report to the Chairperson of the Board of the Authority.
- 7.4. That the Bidder / Contractor accepts that the Monitor(s) has the right to access without restriction to all project documentation of the Authority including that provided by the Bidder/Contractor. The Bidder/Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation including minutes of meeting. The same is applicable to Sub - Contractors and Associates. The Monitor is under obligation to treat the information and documents of the Authority and Bidder/ Contractor / Sub- Contractors/ Associates with confidentiality.
- 7.5. That as soon as the Monitor notices, or believes to notice, a violation of this Pact, he will so inform the management of the Authority and request the management



to discontinue or heal the violation, or to take other relevant action. The Monitor(s) can in this regard submit his recommendations/ suggestions. Beyond this, the Monitor(s) has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.

7.6 That the Authority will provide to the Monitor(s) sufficient information about all meetings among the parties related to the project provided such meetings could have an impact on the contractual relations between the Authority and the Contractor / Bidder. The parties offer to the Monitor(s) the option to participate in such meetings.

7.7 That the Monitor(s) will submit a written report to the Chairperson of the Board of the Authority within 2 weeks from the date of reference or intimation to him by the Authority and, should the occasion arise, submit proposals for correcting problematic situations.

7.8 That if the Monitor(s) has reported to the Chairperson of the Board a substantiated suspicion of an offence under relevant Anti- Corruption Laws of India and the Chairperson has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Vigilance Department, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India.

7.9 The word 'Monitor' would include singular and plural.

8. **Facilitation of Investigation.**

In case of any allegation of violation of any provisions of this Pact or payment of commission, the Authority or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of such Examination.

9. **Law and Place of Jurisdiction.**

That this Pact is subject to provisions under Indian Law. The place of performance and jurisdiction is the Corporate Headquarter /the Regional Headquarter / office of the Authority, as applicable.

10. **Other Legal Actions**

10.1 That the changes and supplements as well as termination notice need to be made in writing.

10.2 That if the Bidder / Contractor are a partnership or a consortium, this Pact must be signed by all the partners and consortium members or their authorized representatives.



11. Pact duration(Validity)

- 11.1 That this Pact comes into force when both the parties have signed it. It expires for the Contractor 12 months after the final payment under the respective contract, and for all other Bidders 3 months after the contract is awarded.
- 11.2. That if any claim is made / lodged during this period, the same shall be binding and continue to be valid despite the lapse of this Pact as specified herein before, unless it is discharged/determined by Chairman of the Authority.
- 11.3 That should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.

12. Company Code of Conduct

Bidders are also advised to have a company code of conduct (clearly rejecting the use of bribes and other unethical behavior) and a compliance program for the implementation of the code of conduct throughout the company.

WHEREAS by an agreement dated(hereinafter called the said agreement) the contractor has agreed AND WHEREAS the Contractor has applied to the AAI that he may be allowed advances on the security of materials absolutely belonging to him and brought by him to the site of the work as he has undertaken to execute at rates fixed for the finished work (inclusive of the cost of materials and labour and other charges) AND WHEREAS the AAI has agreed to advances to the Contractor the sum of Rupees on the security of materials the quantities and other particulars of which are detailed in Accounts of Secured Advances attached to the Running Accounts Bill for the said works signed by the Contractor on

..... and the AAI has reserved to himself the option of making any further advance or advances on the security of other materials brought by the Contractor to the site of the said works . Now THIS INDENTURE WITNESSETH that in pursuance of the said agreement and in consideration of the sum of Rupees on or before the execution of these presents paid to the Contractor by the AAI (the receipt whereof the Contractor doth here by acknowledge) and of such further advances (if any) as may be made to him as aforesaid the Contractor both hereby covenant and agree with the AAI to declare as follows:

- (1) That the sum of Rupees so advanced by the AAI to the Contractor as aforesaid and all or any further sum or sums advanced as aforesaid shall be employed by the Contractor in or towards expediting the execution of the said works and for no other purpose what so ever.
- (2) That the materials detailed in the said Account of Secured Advances which have been offered to and accepted by the AAI as security are absolutely the Contractor's own property and free from encumbrances of any kind and the contractor will not make any application for or receive a further advance on the security of materials which are not absolutely his own property and free from encumbrances of any kind and the Contractor indemnifies the AAI against all claims to any materials in respects of which an advance has been made to him as aforesaid .
- (3) That the materials detailed in the said Account of Secured Advances and all the other materials on the security of which any further advance or advances may hereafter be made as aforesaid (here in after called the said materials) shall be used by the Contractor solely in the execution of the said works in accordance with the directions of the Engineer-in-Charge of the project (hereinafter called Engineer-in-Charge) and in the term of the said agreement.
- (4) That the Contractor shall make at his own cost all necessary and adequate arrangements for the proper watch, safe custody and protection against all risks of the said materials and that until used in construction as aforesaid the said materials shall remain at the site of the said works in the Contractor's custody and on his own responsibility and shall at all times be open to inspection by the Engineer-in-Charge or any officer authorized by him. In the event of the said materials or any part there of being stolen , destroyed or damaged or becoming deteriorated in a greater degree than is due to reasonable use and wear thereof the Contractor will forthwith replace the same with other materials of like quality or repair and make good the same as required by the Engineer-in-Charge .



- (5) That the said materials shall not on any account be removed from the site of the said works except with the written permission of the Engineer-in-Charge or an officer authorized by him on that behalf.
- (6) That the advances shall be repayable in full when or before the Contractor receives payment from the AAI of the price payable to him for the said works under the terms and provisions of the said agreement. Provided that if any intermediate payments are made to the Contractor on account of work done then on the occasion of each such payment the AAI will be at liberty to make a recovery from the Contractor's bill for such payment by deducting there from the value of the said materials then actually used in the construction and in respect of which recovery has not been made previously, the value for this purpose being determined in respect of each description of materials at the rates at which the amounts of the advances made under these presents were calculated.
- (7) That if the Contractor shall at any time make any default in the performance or observance in any respect of any of the terms and provisions of the said agreement or of these presents the total amount of the advance or advances that may still be owing to the AAI shall immediately on the happening of such default be repayable by the Contractor to the President together with interest there on at twelve percent per annum from the date of respective dates of such advance or advances to the date of repayment and with all costs charges, damages and expenses incurred by the President in or for the recovery thereof or the enforcement of this security or otherwise by reason of the default of the contractor and the contractor hereby covenants and agree with the President to repay and pay the same respectively to him accordingly.
- (8) That the Contractor hereby charges all the said materials with all repayment to the President of the said sum of Rupees and any further sum or sums advanced as aforesaid and all costs charges, damages and expenses payable under these presents PROVIDED ALWAYS and it is hereby agreed and declared that notwithstanding anything in the said agreement and without prejudice to the powers contained therein if and whenever the covenant for payment and repayment herein before contained shall become enforceable and the money owing shall not be paid in accordance therewith the AAI may at any time there after adopt all or any of the following courses as he may deem best :-
- Size and utilize the said materials or any part thereof in the completion of the said works on behalf of the Contractor in accordance with the provisions in that behalf contained in the said agreement debiting the Contractor with the actual cost of effecting such completion and the amount due in respect of advances under these presents and crediting the Contractor with the value of work done as if he had carried it out in accordance with the said agreement and at the rates thereby provided. If the balance is against the Contractor, he is to pay same to the AAI on demand.
 - Remove and sell by public auction the seized materials or any part thereof and out of the moneys arising from the sale retain all the sums aforesaid repayable or payable to the AAI under these presents and pay over the surplus (if any) to the Contractor.
Deduct all or any part of the moneys owing out of the security deposit or any sum due to the Contractor under the said agreement.
- (9) That except in the event of such default on the part of the Contractor as aforesaid interest on the said advance shall not be payable.
- (10) That in the event of any conflict between the provisions of these presents and the said agreement the provisions of these presents shall prevail and in the event of any dispute or difference arising over the construction or effect of these presents the settlement of which has not been herein before expressly provided for the same shall be finally resolved as per provisions of clause 25 of the contract.

SPECIAL CONDITIONS OF CONTRACT CIVIL WORKS

1.0 GENERAL

- 1.1** Bidders are advised to read Notice Inviting tender (NIT) and mandatory documents required to be submitted along with the bid. This work is of urgent nature and to be completed within the given time frame. Hence, AAI is not bound to ask for any missing documents not submitted in original tender bid under the 'short-fall' provisions. Hence, it is once again advised to all bidders to read carefully NIT conditions and submit all required documents at the time submission of their Bid. AAI shall reject the tender bid of the tenderer if any of the required document not found in their E-Tender bid and no communication shall be further initiated from this office for short-fall.
- 1.2** General Conditions of contract (GCC) from Page 001 to 144 must be read.
- 1.3** Special conditions of Contract shall be read in conjunction with General Conditions of Contract, Technical Specifications, Drawings and any other documents forming part of this contract wherever the context so requires.
- 1.4** Notwithstanding the sub-division of the documents into these separate sections and volume every part of each shall be deemed to be supplementary to and complementary of every other part and shall be read with and into the CONTRACT so far as it may be practicable to do so.
- 1.5** Where any portion of the General Condition of Contract is repugnant to or at variance with any provisions of the Special Conditions of Contract, unless a different intention appears, the provisions of the Special Conditions of Contract shall be deemed to over-ride the provisions of the General Conditions of Contract and shall to the extent of such repugnancy, or variations, prevail.

2.0 COMPLETION SCHEDULE

- 2.1.** The works shall be executed strictly as per time schedule mentioned in NIT. Contractor shall have to plan his construction programme and activities so as to complete the work in the stipulated period by working in multiple shifts if required. The period of completion given includes the time required for mobilization as well as testing, rectifications, if any, re-testing and completion in all respects to the entire satisfaction of Engineer-in-Charge.
- 2.2.** No additional payment shall be made to the contractor for any multiple shift work or other incentive methods contemplated by him in his work Schedule even though the time schedule is approved by the Engineer-in-Charge
- 2.3.** During the currency of schedule on mile stone the work the contractor is expected to adhere to the time and total completion and this adherence will be a part of Contractor's performance under the contract.
- 2.4.** Handing over of land for the subject work is to be handed over by Engineer-In-Charge, the site to the contractor may be made available in phases. Contractor shall take up the work as per availability of site and shall be liable to dismantle/ relocate any of the structures fouling with the proposed site as per instruction by the Engineer-in-Charge.

3.0 MINIMUM WAGES, EPF & ESIC REQUIREMENTS

- 3.1** The contractor has to ensure that in any cases or circumstances, the wages paid to the workers should not be less than the minimum wages as notified by the Govt. bodies. The agency shall submit the affidavit on non-judicial stamp paper of value Rs. 100/- (the cost of stamp paper shall be borne by the contractor) declaring that he/she shall fully adhere to the minimum wages Act, 1948. Similarly, deductions of provident fund amount at the prescribed rate and its timely deposit to the PF account is a legal obligation under the contract labour (regulation and abolition) Act, 1970 and Agency is fully observing the aforementioned legal obligations.
- 3.2** The contractor shall intimate his PF account code no. allotted by regional PF commissioner and ESI registration no. allotted by ESI Corporation & service tax registration number after issue of work order, failing which no payment will be released to the contractor. The contractor shall provide a list of contract Workers engaged for contract work along with their PF Account NO. & ESI Registration No.
- 3.3** The contractor shall provide copies of PF & ESI challans of monthly contributions in respect of all contract workers engaged for contract work on month to month basis. AAI will reimburse the actual amount of PF & ESI to the contractor after submission & verification of documentary proof i.e. PF & ESI challans to the AAI.
- 3.4** The agency has to pay regular bonus to his employee / workers under THE PAYMENT OF BONUS ACT, 1965 with subsequent amendments. The quoting agency will be responsible for compliance of all statutory provisions relating to minimum wages, Provident Fund and Employees State Insurance etc. in respect of the persons deployed by it in this Department.

4.0 DRAWINGS AND DOCUMENTS

- 4.1** The drawings accompanying the tender document (If enclosed) are of indicative nature only and issued for tendering purpose with the purpose to enable the tenderer to make an offer in line with the requirement of the AAI.
- 4.2** However, no extra claim whatsoever shall be entertained for non – availability of drawing in tender document or variation in the “Approved for Construction” and “Tender drawing” regarding and changes. The execution of work shall be as per approved drawings and detailed specifications.

5.0 TEMPORARY WORKS

- 5.1** The Tenderer should see the approaches and conditions of the same. If any approach from main road is required at site or existing approach is to be made and maintained for cartage of materials etc. by the Contractor, the same shall be provided, improved and maintained by the Contractor at his own cost.
- 5.2** All Temporary and ancillary works including enabling works connected with the work shall be responsibility of the Contractor and the price quoted by them shall be deemed to have included the cost of such works which shall be removed by the contractor at his cost, immediately after completion of the work.

6.0 PAYMENTS

- 6.1** The bill shall be submitted each month on or before the date fixed by the Engineer-in-Charge for all the works executed in previous month in accordance with provision of clause 7 on page GCC-20-21. The contractor shall submit all the bills on the proforma prescribed by the Engineer-in-Charge, preferably through computerized billing in triplicate.
- 6.2** Contractor shall pay wages to labour by Cheque/DD or RTGS to individual bank account of labour and has to submit copy of proof of labour payment alongwith wage register.
- 6.3** Payment shall be made after deduction of security deposit and taxes as per statutory requirements prevailing at the time of payment.
- 6.4** The final bill shall be paid to the agency after disbursement of all the payment to the workers including bonus. No dues certificate duly signed by each worker need to be submitted in this regard.
- 6.5** The payment due to the contractor shall be made within 30 days of the submission of the bill by the contractor and the measurements shall be verified by the Engineer-in-Charge or his representative within 10 days of submission of the bill. The payment shall be made in ERP-SAP Module from the AAI Office at Bhopal. (As per Clause 6A GCC Page No. 26 – 27.)
- 6.6** Labour cess as per rules and regulations in force shall be deducted from the bills of the contractors and deposited with designated authorities

7.0 WATER

- 7.1** Contractor shall make his own arrangements of suitable water supply for the work and his staff and workmen at his own cost. The testing charges of water shall be borne by the contractor.
- 7.2** Generally, water required for the work shall not be given by AAI and same has to be arranged by the Contractor. In case AAI water source is available near the work site and water can be spared to the contractor as per discretion of the Engineer-in-Charge, the Contractor may draw water from the AAI source as approved by Engineer-in Charge.
- 7.3** Wherever AAI water source used by the Contractor. 1% of gross bill amount (work done) shall be deducted from the running/final bill.

8.0 POWER SUPPLY

- 8.1** Generally, electricity required for the work shall not be given by AAI and same has to be arranged by the Contractor. In case AAI electricity source is available near the work site and electricity can be spared to the contractor as per direction of Engineer-in-charge. The contractor may draw electricity from the AAI source as approved by Engineer-in-charge.

- 8.2 Necessary meter and connection from the source as approved by Engineer-in-charge shall be arranged by the contractor. No extra payment towards meter and connection arrangement shall be paid by AAI
- 8.3 Wherever AAI's source of electricity is used by the contractor. Charges as fixed by AAI for per unit shall be charged from the Contractor.

9.0 CONTRACT AGREEMENT

- 9.1 The contract agreement shall be executed on a non-judicial stamp paper of value Rs.500/- and cost of the stamp paper shall be borne by the Contractor.
- 9.2 Contractor's tender including the letters of clarifications between the contractor and the AAI prior to the award of contract shall form a part of the Contract Agreement to the extent they have been accepted by AAI.

10.0 INSPECTION OF SITE AND TESTING

- 10.1 The Engineer-in-Charge or his authorized representative shall have full power to inspect any portion of the work, examine the materials and workmanship at the contractors works site or at any other place from where the material is obtained. Acceptance of any material shall in no way relieve the contractor of his responsibility for meeting the requirement of the specifications.
- 10.2 Routine type tests for the various items of material shall be performed at the contractor's works and test certificates furnished. The contractor shall permit the Engineer-in-Charge or his authorized representative to be present during any of or all the tests. In case the work does not meet the full extent of the specifications it shall be rectified by the Contractor at no extra cost and the contractor shall bear all the expenses for any further tests considered necessary.
- 10.3 All tools, instruments, plants and labour/operating personnel for the test shall be provided by the contractor at his own cost. The contractor shall have to facilitate required testing equipment at site as desired by engineer-in-charge time to time.
- 10.4 The Engineer-in-Charge may at his discretion, check the test results obtained at contractors laboratory by independent tests at an approved laboratory. The cost of such material, transport, cost of testing etc. shall be borne by the contractor.
- 10.5 It is made clear that cost of testing, cost of material for testing, all field apparatus required for sampling and testing as per CPWD/IS codes and manpower incident to such testing will be provided along with necessary transport arrangement to and fro to the approved testing agency or laboratory by the Contractor during the construction phase of the work and defect liability period. The expenditure in this regard shall be borne by the Contractor and nothing extra shall be payable by AAI on this account.
- 10.6 The Contractor or his accredited representative shall be present during sampling/testing and signify his concurrence for sampling/ testing carried out by signing the test records. The Contractor shall be liable of all actions consequent to the test and their results as if he himself attended to the tests. The Contractor is duly

advised to be present himself for sampling and testing or in the alternative, have fully qualified duly authorized Engineer for this purpose.

- 10.7 Failure of the Representative of the Engineer-in-Charge to disapprove any work or materials shall not prejudice the power of the Engineer-in-Charge thereafter to disapprove such work or materials and to order the pulling down, removal or breaking up thereof

11.0 STORES AND MATERIALS

No storage accommodation will be arranged by AAI, Contractor shall make all such arrangements at his own cost to the satisfaction of Engineer-in-Charge. Defense Authorities may allow the storage of construction materials at designated places at their discretion.

12.0 BY-LAWS

- 12.1 The contractor shall comply with all bye-laws and regulations of local and statutory authorities having jurisdiction over the works and shall be responsible for payment of all fees and other charges and for giving and receiving of all necessary notices and keeping the Engineer-in-Charge, informed of the said compliance with the bye-laws, payments made, notices issued and received.
- 12.2 The contractor shall indemnify the AAI against all claims in respect of patent rights, design, trade marks of name or other protected rights in respect of any plant, machine, work or materials used for or in connection with the work or temporary works and from and against all claims, demands proceedings, cost, charges and expenses whatsoever in respect of or in relation thereto. The contractor shall defend all actions arising from such claims and shall himself pay all royalties license fees, damages, costs and charges of all and every sort that may be legally incurred in respect thereto.

13.0 SITE PRECAUTIONS

- 13.1 Any materials or T & P etc. found lying outside the sites approved by the Engineer-in-Charge, shall be removed by the Engineer-in-Charge at the risk and cost of the contractor.
- 13.2 With regard to construction safety measures, the contractor shall adhere to all Indian Standard Codes of Practice, requirements of Provincial Government and local Municipal Authority wherever the provisions of the latter two agencies shall be more stringent than the provisions of the former. When these codes do not exist, the contractor shall adhere to such safety measures as directed by the Engineer-in-Charge.
- 13.3 Every transport vehicle shall carry a permit issued by the Airport Director or authorized agencies concerned and shall be produced on demand by him or his authorized agent. All vehicles entering the Airport limits shall follow the routes prescribed by the Airport Director of Airport for entering the airport areas.

- 13.4 The contractor shall take all precautions to avoid all accidents by exhibiting necessary caution boards day and night, speed limit boards, red flags, red lights and providing barriers. He shall be responsible for all damages and accidents caused due to negligence on his part. No hindrance shall be cause to traffic during the execution of the work. Nothing extra will be payable on this account.
- 13.5 The contractor shall be responsible for any damage, resulting from his operations, either to buildings, structures, airport fixtures etc. The contractor shall restore, replace or repair any such damage to the complete satisfaction of the Engineer-in-Charge and in default the Engineer-in-Charge may cause the same to be made good by any other means and deduct the expenses from any sums due to contractor.
- 13.6 No payment will be made to the contractor for damage caused by rains or other natural calamities during the execution of the work and no such claim on this account will be entertained.
- 13.7 The work shall be carried out in phases if required in such a way that there is least obstruction to the airport working. The phasing shall be decided by the Engineer- in-Charge, who will be at liberty to change the phasing to suit the requirements. The contractor shall have to abide by these instructions and nothing extra shall be paid to him on this account
- 13.8 After the closure of day's work, all equipment and stock piled materials must be cleared from the site
- 13.9 The Contractor shall provide and maintain at his own expense all lights, guards, fencing and watching when and where necessary or required by the Engineer-in-Charge for the protection of the Works or for the safety and convenience of those employed on the Works

14.0 PRICES

The rates / Percentage quoted shall be inclusive of taxes, duties, cess, fee and charges levied under any statute but EXCLUSIVE OF GST as specified at relevant pages of NIT, labours, tools & plants, packing freight/transportation of items from factory up to the installation site & insurance up to the site, loading, unloading and hoisting arrangement for installation, testing cost, inspection, fee(s) payable for obtaining statutory license/approval etc. from concerned department. GST shall be paid to bidder for any taxable supply/services against a valid tax invoice.

Final bill will be worked out at the accepted tender rates and also with quoted rates of second lowest. The amount of final bill to be paid will be restricted to the lowest of the two.

15.0 STORAGE OF MATERIAL: -

- 15.1 Materials brought to the site by the contractor shall be stored by the contractor in a safe and dry storage space. The contractor shall be responsible for safe custody of materials at site till such time; the installation is commissioned and handed over to the Engineer-in-Charge.
- 15.2 Cement bags shall be stored in separate godowns to be constructed by Contractor at his own cost as per dimensions approved by engineer-in-charge with weather proof roofs and walls. Each godown shall be provided with a single door with two locks, the keys of one lock shall remain with AAI Engineer-in-Charge of work and that of the other lock with the authorized agent of the contractor at the site of work so that the cement is removed from the godown according to the daily requirement with the knowledge of both the parties and the account maintained in the Performa approved by the Engineer-In-Charge.
- 15.3 The contractor is required to submit the bill receipt for cement, lime, paint and any other item incorporated in works for which Engineer-in-charge directs.

16.0 SITE CONDITIONS AND REQUIREMENTS

- 16.1 The contractor shall be responsible for the true and proper setting out of the work and for the correctness of the positions levels and dimensions and alignments of all parts of the works and for the provisions of all necessary applications and labour in connections therewith.
- 16.2 If any time during the progress of the work any error may appear or arise in the position, levels, dimension or alignments of any part of the work the contractor on being required to do so by the Engineer-in-Charge shall at his own expense rectify such errors to the satisfaction of the Engineer-in-Charge
- 16.3 The checking or any setting out of any line by the Engineer-in-Charge or his representative shall not relieve in any way the contractor of responsibility for the correctness thereof and shall carefully project and preserve all bench mark site rails, pegs and other things used in the set is out of work.
- 16.4 The contractor shall also keep proper record of such permanent bench marks established denoting therein their correct levels.
- 16.5 All such bench marks established by the contractor shall be subjected to check and approval of the Engineer-in-Charge or duly representative and valuations noticed in the work as a result of improper establishment of maintenance of such bench marks shall be at the contractor's risk and expense.
- 16.6 The contractor has to adjust his work and progress to work in co-ordination with other agencies working at site.

17.0 SITE FOR STACKING OF MATERIALS, INSTALLATION OF T&P AND LABOUR CAMPS ETC.

- 17.1 The contractor shall be allowed to install plants and machineries, stores and material within Airport premises . However, installing crushing plant within AAI area will not be permitted.

- 17.2 The contractor shall not be permitted to enter on other than for inspection purpose or take possession of the site until instructed to do so by the Engineer-in-Charge in writing. The portion of the site to be occupied by the contractor shall be defined and/or marked on the site plan. In respect of any land allotted to the contractor for purpose of or in connection with the contract, the contractor shall be a licensee subject to the following and such other terms and conditions as may be imposed by the licensor:
- 17.3 License Fee for land.
- a) Land/ space (Paved/ Unpaved/ Covered – AC or Non – AC), to the extent allotted to contractors during execution of work for the purpose of installation of plants, labour camps, cement godown, site office stacking of materials shall be provided at free of cost up to completion of work
 - b) A security deposit at the rate of Rs. 500.00/- per sqm in the form of DD/ BG shall be deposited by the contractor. In case contractor do not deposit security deposit same shall be deducted from 1st Running Account Bill.
 - c) Such security deposit shall be released only after allotted land has been fully vacated by the contractor to entire satisfaction of Engineer – In – Charge. If contractor fails to vacate the allotted land / space (Paved/ Unpaved/ Covered – AC/ Non – AC) after completion of work
- 17.4 That such use or occupation shall not confer any right of tenancy of the land to the contractor. That the contractor shall be liable to vacate the land on demand by the Engineer-in-Charge.
- 17.5 That the contractor shall have no right to any construction over this land without the written permission of the Engineer-in-charge. In case, he is allowed to construct any structure he shall have to demolish and clear the same before handing over the completed work unless agreed to the contrary .

18.0 WORK IN OPERATIONAL AREA

- 18.1 Entry is restricted for the work in operational area. Agency has to get issued entry passes for manpower, material, vehicle etc. from the Airport Security authorities (such as BCAS, DGCA, AAI security etc. as the case may be) after submission and verification of documents with applicable fee as per the prevailing rule and law.
- 18.2 Agency is supposed to know and well familiar about the rules related to issuing of passes in Airport Operational Area before quoting rates and submitting tender. It is the responsibility of contractor to obtain such passes from the concerned authority and AAI has no role or responsibility on getting passes issued for the contractor. Nothing shall be paid extra on this effect. Bidders should read carefully about the 'Guideline for issue of passes for Airport Operational Area' enclosed with this tender document.
- 18.3 For the work to be carried out in operational area, whenever necessary, the work shall be carried out in the non-operational period or night also.

- 18.4 The contractor shall have to co-ordinate with the ATC Tower and other Airport Authority offices for locating T&P and stacking of materials, issuing passes etc. Nothing extra shall be paid to the contractor for the entire above factor.
- 18.5 Work shall be closed during VVIP movement and also other exigencies, if directed by the Engineer – In – Charge. No compensation shall be entertained on this account from the contractor.
- 18.6 The contractor shall ensure that his men will work in areas/ zones allotted, to them. Passes shall be deposited with Engineer – In – Charge on demand and in any case immediately after completion of work.
- 18.7 The contractor his staff/ workman shall observe all the rules promulgated from time to time by the concerned authorities such as prohibition of smoking & lighting, search of persons on entry and exit, keeping to specified routes etc. any person found violating the security rules laid down by the authorities either shall be fined as listed in Annexure – I and / or will be expelled from the area without assigning any reason whatsoever and contractor shall have no claim on this account.
- 18.8 Nothing extra shall be payable by AAI on account of working restricted to non – operational hours and in restricted working conditions.

19.0 SPECIFICATIONS

- 19.1 For items not covered under CPWD specifications mentioned the work shall be done as per latest relevant standards/codes published by B.I.S. inclusive of all amendments issued there to or revision there of, if any, upto the date of receipt of tenders.
- 19.2 In case B.I.S. codes/specifications are not available, the decision of the Engineer-in-charge based on acceptable sound engineering practice and local usage shall be final and binding on the contractor.
- 19.3 Materials shall be approved by the Engineer-in-charge as may be necessary.

20.0 ARRANGEMENT TO BE MADE BY THE CONTRACTOR AT SITE

- 20.1 Necessary registers and stationeries required for entering data and test results shall be provided by the contractor at his own cost as directed by the Engineer-in-charge.
- 20.2 In addition to the tools and plants and equipments/apparatus and instruments required for laboratory and execution of the work as per C.P.W.D. Specifications & Technical Specifications of the NIT to be arranged by the contractor at his own cost within Fifteen days of stipulated date of start of work.
- 20.3 Agency has to make his own arrangement of transportation of their engineers, supervisors and labors at agencies cost. Stray walking is not allowed inside ops area.
- 20.4 The agency is entitled to take away all the movable items like equipment, furniture, machinery etc. provided by the agency for the project after completion of the work and release of final bill.

21.0 ROYALTY OF MATERIALS

- 21.1 Royalty at the rates wherever payable, shall have to be paid by the contractor on the boulders, metal, shingle, sand, good earth, bajri etc. or any other materials collected by him for the work direct to the revenue authority of the District/ State/ Central Government concerned.

22.0 OBLIGATIONS TO THE CONTRACTOR

In order to ensure that the contract work is executed strictly in accordance with this Agreement and in time, the Contractor shall have the following obligations at no extra cost to the Engineer-in-Charge in addition to other obligations and responsibilities as have been specified elsewhere in this Contract-

- 22.1 Provision of adequate number of constructional T&P and machinery for mechanized system of construction, handling and transportation;
- 22.2 Fulfill all the Contractor's labour regulations i.e fair wages, display of notices regarding wages, payment of wages, labor records, attendance cards-cum-wage slips, labour welfare etc. as per standard practices and norms applicable at site;
- 22.3 All fossils, gold, silver, oil and other minerals, precious stones, coins, article of value, of antiquity and structures and other remains/things of geological or archaeological interest discovered on the site of the works shall be notified by the Contractor immediately to the Engineer-in-Charge for onward information to the concerned authorities
- 22.4 The contractor shall keep indemnified AAI against all loose and claims for injuries or damage to any person or any property what so ever, which may arise out of or in consequence of the construction and maintenance of the works by them and against all claims, demands, proceedings of or in relation thereof.
- 22.5 The Contractor shall take all reasonable precaution to prevent his workmen or any other person from removing or damaging any such article(s) or thing(s) and protect the same till the removal as per the instructions of the Engineer-in-Charge.
- 22.6 Clearance of the site of all rubbish, debris, vats, tanks, materials, temporary structures, plant and machinery, scaffoldings and filling of all pits, excavation and hand over the site in a tidy and cleaned condition after completion of work.
- 22.7 Opening up of covered work if instructed by the Engineer, if such covering was done before inspection by the Engineer or without permission/approval from the Engineer-in-Charge.
- 22.8 The quoting agency shall also be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to the Department to the concerned tax collection authorities from time to time as per extant rules and regulations on the matter. Any deduction / payment under PF workmen's compensation Act, Labour (Regulation and Abolition Act), Minimum wages Act, Maternity Benefit Act, labour cess etc. shall be the sole responsibility of the Contractor.
- 22.9 The quoting agency shall maintain all statutory registers under the applicable law. The agency shall produce the same, on demand, to the concerned authority of this Department or any other authority under law.

- 22.10 The contractor has to follow the local security/safety rules and regulations and such instructions on restricted hours of work as may be imposed on him by the department/ local authorities, while working in security restricted zones and no claim whatsoever on account of loss of worker / idle worker etc. can be entertained.
- 22.11 It shall be the responsibility of the contractor the all necessary safety measures and precautions are invariably ensured while performance of the contract work and AAI shall not be responsible for any injuries / accidents suffered by contract worker.
- 22.12 The contractor shall be responsible for any damage caused to any equipment's, building installation and also personal due to the negligence of the contract worker. The same shall be made good by the contractor at his own cost.
- 22.13 Any incident/ mishap of contractor's workers shall be the contractor's responsibility.
- 22.14 If any worker engaged is found to be not suitable for the position, the contractor has to remove the worker from the site immediately and has to depute his substitute.
- 22.15 The contractor has to maintain attendance register & wage register for his employees and has to be produced for verification to Engineer-In-Charge on monthly or as and when required.
- 22.16 In case, the person employed by the successful Company/Firm/Agency commits any act omission/commission that amounts to misconduct/ indiscipline/ incompetence, the successful Bidder Firms/companies/Agencies will be liable to take appropriate disciplinary action against such persons, including their removal from the site of work or as required by the Department.
- 22.17 The Bidder Firms/companies/Agencies shall replace immediately any of its personnel, who are found unacceptable to this Department because of security risks, incompetence, conflict of interest, improper conduct etc. upon receiving a notice from this Department.
- 22.18 For all intents and purpose the service providing agency shall be the "Employer" within the meaning of different Labour Legislations in respect of persons so employed and deployed in this Department. The persons deployed by the agency in the Department shall not have claims of Master and Servant relationship nor have any principal and agent relationship with or against the Department.
- 22.19 The Service providing agency shall be solely responsible for the redressal of grievances/resolution of disputes relating to person deployed. The Department shall, in no way be responsible for settlement of such issues whatsoever.
- 22.20 This Department shall not be responsible for any damages, losses, claims, financial or other injury to any person deployed by service providing agency during the course of their performing the functions/duties, or for payment towards any compensation.
- 22.21 The person deployed by the service providing agency shall not have any claim or be entitled to pay, perks and other facilities admissible to casual, ad-hoc, regular/confirmed employees of this Department during the currency or after expiry of the contract.
- 22.22 In case of termination of this contract on its expiry or otherwise, the persons deployed by the service providing agency shall not be entitled to and will have no claim for any absorption nor for any relaxation for absorption in the

regular/otherwise capacity in the Department .

22.23 The Final bill shall be paid to the agency after disbursement of all the payment to the workmen. No dues certificate duly signed by each worker, if asked by the Engineer-in-charge, need to be submitted in this regard.

22.24 It will be responsibility of the Contractor to liaise with the local bodies like Electricity Board/ authority water supply sanitation/authority, Horticulture Department, Dog/Animal Squads etc. to get the emergency service attended immediately by the concerned agency at no extra cost.

23.0 Goods & Services Tax (GST)

23.1 The agency should have mandatory registered with GST.

23.2 All tendered rates shall be EXCLUDING of GST. The rate quoted by the bidders/ tenderers shall be inclusive of any taxes, duties, cess, fee and charges levied under any statute but exclusive of GST.

23.3 GST shall be paid to bidder for any taxable supply/services against a valid tax invoice. Contractor must raise GST invoice showing his GSTIN, HSN code/SAC, Address of contractor, Cost of work done, CGST/SGST/IGST (as applicable) etc. so that input credit can be availed under GST regime.

23.4 An undertaking from the bidder shall be given that they are registered under GST and compliant of GST provision.

23.5 In case of non-compliance of GST provisions and blockage of any input credit, the bidder shall be responsible to indemnify AAI for the losses, if any, suffered by AAI. AAI may stop payments of running bill and/or release of security deposit or any dues in case of non-compliance of GST provisions or non-payment of GST to concerned department as per the regulated time intervals.

23.6 The bidder is required to provide tax type and tax percentage.

23.7 As per the Govt. of India Notification No. 50/2018, with effect from 01/10/2018, a TDS of 2% is to be deducted from the GST under section 51 of the GST Act. Hence it will be applicable on this work.

23.8 Terms and conditions in respect of indirect taxes (excise, VAT, Sale Tax, Purchase Tax etc) if mentioned in this tender document shall be considered deleted.

23.9 Any modifications in rules or notification issued time to time by government of India or any clarification received on GST rules, it shall supersede all the tax related clauses mentioned herein this tender document.

23.10 In case of change in rate of tax or any provision relating to levy of tax resulting in increase in burden of tax on the contractor, the contractor shall be entitled to receive any compensation for such increase in quantum of tax payable by the contractor. Similarly recovery shall be made from the contractor on account of decrease of rate of tax or any provision relating to levy tax.

23.11 In case of irregular deposits of GST and thereby losses of AAI towards non-availing input credit, AAI may foreclose the agreement at any time and forfeit all payable to agency like pending payments , SD etc. The decision of Engineer – In – Charge shall be final and binding.

23.12 The tax invoice for the supply of the mentioned good/services/both has to be raised in pursuance of section 31 of CGST act of the concerned unit , which has actually

received such supply, implying thereby that where the goods/services are supplied to a unit, the invoice must be raised to such unit.

24.0 COMPARISON WITH FIRST LOWEST

The total amount of final bill worked out at the accepted tender rates, if found to be more than the amount worked out at the quoted rates of second lowest, the contractor shall be paid lower of the two.

25.0 MODE OF COMMUNICATION:

All following mode of communication related to site / work related information, decisions or instructions shall be valid and binding to agency –

- (i) Printed or hand written letter signed by Engineer-in-charge or his authorized representative send either via post or courier to their official address given in data sheet or by-hand after taking receiving from agency authorized site representative,
- (ii) Any letter written directly to agency by DGM Engg-Civil/Electrical, Jt. GM Engg-Civil/Electrical, GM Engg-Civil/Electrical/Project, ED Engineering of Airports Authority of India (AAI) related to this work,
- (iii) Instructions given in Site order Book or Work Diary,
- (iv) Letters or communication send via email on official email ID of agency declared in data sheet and /or to MD/director of the company,
- (v) SMS or Whatsapp message sent by EIC or his authorized representative to the mobile number of MD/ Director of the company or mobile number of Site - In Charge officially deputed at site.

26.0 PRICE REFERENCE TO PUBLIC ENTERPRISES:

The Accepting authority reserves to him self the right to allow to the public enterprises prices preference facilities as admissible under the existing policy.

27.0 SPECIFICATIONS TO BE FOLLOWED:

In the absence of any definite provision in the technical specifications contained herein, reference may be made to the latest CPWD, MORTH, IRC, AAI, ICAO Specifications and IS codes, in that order. Wherever these are silent, the construction and completion of the works shall conform to sound engineering practice and in case of any dispute arising out of the interpretation of the above, the decision of the Engineer-in-Charge (EIC) shall be final and binding on the Contractor. All the codes of practice, standards and specifications applicable shall be the latest editions with up to date correction slips.

30.0 GUIDELINE FOR ISSUE OF PASSES FOR AIRPORT OPERATIONAL AREA

NOTE : *This Guideline has been issued by BCAS (Bureau of civil aviation security) subject to modification time to time for issue of passes for the labours, workers, supervisors etc to work inside operational area. The issue of passes is sole responsibility of BCAS after due verification of documents of applicant and AAI is restricted only to recommend and forward the pass application.*

30.1 GUIDELINE FOR ISSUE AEP (Airport Entry Pass):

- I. Agency/ Contractor has to register immediate themselves with BCAS on e-sahaj portal (<https://esahaj.gov.in>) under 'Auxilliary Service Provider' section to fill online application form for security clearance.
- II. Printed copy of acknowledgement of security clearance application downloaded from above portal alongwith following documents in duplicate to be submitted to get temporary pass for initial 30 days in AAI security office.
 - a) Format – A as per Annexure – I
 - b) Format – A1 as per Annexure- II
 - c) ID and Address proof of owner/ director/ key persons
 - d) Certificate of Incorporation
 - e) Memorandum of association & Articles of Association

- f) Form 32/ DIR – 12
 - g) Company profile (Brief description about company, Goal of the company, Business plan, Details of Registered office/ corporate office/ branch office, client list)
 - h) Agreement Copy
 - i) Any other security clearance from BCAS
 - j) Authorized signatory Letter
 - k) Declaration regarding no criminal case against company and its directors.
 - l) Aviation Security Programme.
- III. The person who has to get temporary Entry passes has to mandatory undergo aviation security programme (AVSEC) as and when conducted by the concerned authority.
- IV. For the initial 30 days temporary airport entry pass shall be issued by AAI security section. Within 15 days the applicant has to submit prescribed application form as per Annexure – III to be submitted to the BCAS alongwith necessary documents:
- a) Filled-up Application form Police verification form
 - b) Copy of work order
 - c) Appointment letter by the company
 - d) ID and Address proof
 - e) Photograph- 2 no
 - f) AVSEC Training certificate
 - g) Copy of old AEP (if issued earlier)
 - h) Applicable fee (₹ 75) subject to revision time to time.

30.2 GUIDELINE FOR ISSUE LABOUR PASSES:

- I. Web based temporary entry passes will be issued for casual labour as per following guidelines:-**
- a) Labour form vide Annexure – IV dully filled up to be submitted.(Page No. AEP-8)
 - b) Photograph of casual labour dully attested by the employer with stamp.
 - c) Copy of work order
 - d) Photograph ID proof and address proof of casual worker
 - e) Copy of Pass (if earlier issued)
 - f) Pass fee (₹ 75 – subject to revision time to time)
- II. Rules to be followed related to labour pass:**
- a) Contractor will hand over labour pass to worker daily and collect it in the evening or end of the day work.
 - b) Agency has to maintain a register of handing over daily labour pass to casual worker which will be checked by security officer time to time.
 - c) The contractor or there supervisor must have valid airport entry pass (AEP) and there will be maximum 20 casual labour pass holder could work under him. All responsibility related to casual labour shall be rest with the contractor.
 - d) Contractor/ Supervisor must follow strictly security and safety norms of operational area and terminal building.

30.3 .GUIDELINE FOR ISSUE OF VEHICLE PASSES:

Necessary documents required for vehicle permits alongwith vehicle form AEP-10

- a) Copy of notification regarding requirement of vehicle in operational area
- b) Registration copy
- c) Insurance papers
- d) Pollution check

The vehicle shall be inspected by the safety officer before issuance of permit after checking on the following aspects –

- Vehicle in road worthy conditions
- Obstacles light or flag in accordance with airport rules
- Speed governors in the vehicle to restrict speed of vehicle
- Vehicle marking ensured logo of company / agency

Approximate cost of Issue of **Airport Entry Permits(AEP)** are as below (It is indicative only subject to revision time to time during actual execution of work) –

The charges of temporary vehicle permit for a duration of maximum one year (light commercial vehicle). Calculated pro-rata on monthly basis.	₹ 1000/-
The charges of temporary vehicle permit for a duration of maximum one year (Heavy commercial vehicle). Calculated pro-rata on monthly basis.	₹ 1500/-
The charges for issue of ADP (Airport Driving Permit) for a maximum period of one year.	₹ 200/-

In addition to the aforesaid charges, Taxes, GST etc shall be applicable as per the prevalent rates. The entry of vehicles and manpower will however continue to be regulated as per already laid down norms.

30.4 Safety Standard of construction equipment vehicle in operational area.

The construction equipment/ vehicle deployed inside operational area shall be accompanied by an initial certificate of pavement/ road worthiness and fitness issued by the manufacturer. Subsequently after expiry of the initial certificate, manufacturer or his authorised agency shall issue fitness certificate including servicing and calibration on yearly basis for the safe operation of the construction equipment in operational area.

31.0 ADDITIONAL SAFETY ARRANGEMENTS TO BE DONE AT SITE :

Following safety criteria will be strictly followed –

31.1 All vehicles, Machines deployed inside operational area shall display RED CHECKED FLAG on the top.

31.2 All Labours, Supervisors, Engineers should wear FLORESCENT SAFETY JACKET all the time during their stay inside operational area / site.

31.3 NO LABOUR, SUPERVISOR, ENGINEER, VEHICLE, CONSTRUCTION MACHINES ETC. SHALL ENTER INTO RUNWAY WITHOUT PERMISSION OF ATC (AIR TRAFFIC CONTROL TOWER). PENALTY FOR EACH VIOLATION SHALL BE RECOVERED AS @ Rs 5,000/- PER INCIDENT.

32.0 DELAY PENALTY FOR NON-SUBMISSION OF INSURANCE UNDER CLAUSE 46 GCC P-72

- 32.1** Contractor All Risk (CAR) policy and Workman Compensation Policy (WCP) required to be mandatory taken separately with compliance of all conditions as per the tender document clause 46 mentioned at page GCC-72 before commencement of execution of work. Cost of premium shall be borne by the agency and nothing shall be reimbursed on this account.
- 32.2** Policies should be valid till expiry of the Defect Liability Period (DLP) plus three months. Hence, it is advisable to submit above insurance policies valid for the period equivalent to agency's assess time taken to complete the work/project + DLP (generally one year if not mentioned otherwise) + Three additional months to save in cost of premium and avoid penalty thereof.
- 32.3** Policies must be submitted within the scheduled date of start of work as would be mentioned in the work award letter issued.
- 32.4** **Engineer-in-charge reserves the right of withhold payment of running bill on account of non-submission of insurance policies.**
- 32.5** If,for any reason whatsoever, work is abnormally delayed and insurance policies expired before the completion of the work/project, agency has to extend the policies by paying extra premium by their own (without any reminder). A **penalty @ Rs 100/- per day** shall be recovered for any delay in compliance in this case. No claim for any reimbursement shall be entertained by this office on this account.

SUPPLEMENTARY ADDITIONAL CONDITIONS (MAINTAINANCE WORKS)

1. GENERAL:

1.1 The scope of works includes -

- 1.1.1 Annual day to day maintenance contract work for the operational area of this Airport. Job involve rectification of defects, supply of man power as and when required by Engineer-In-Charge.
- 1.1.2 The operational area include runway, eco taxi way, other taxi way, perimeter road, perimeter wall, new apron, old apron, ATC tower, Fire station, MT, Electric substation at old power house and other vital installations within perimeter wall etc.

1.2 The following special condition shall be read in conjunction with general condition of contract (GCC) with Addendums and amendments corrections thereto. If there are any provisions in these special conditions which are at variance with the provision in the GCC and Amendments, the provision in these special supplementary conditions shall take precedence.

1.3 Wherever, it is applicable in **DSR-2023 (Vol 1 & 2) Items as well as in schedule-A (part II) items, **Lead upto 50 m and lift upto 1.5 m, shall be read as – all leads and lifts within Airport premises unless otherwise specified and as directed by engineer-in- charge.****

2. SITE CUM ENQUIRY OFFICE:

2.1 A site office and an attached store yard have to be established by the contractor at a suitable location when directed by the Engineer-in-Charge. In case any vacant room and store yard of AAI is available, same will be handed over to the contractor for use as site office and store yard and shall recovered a nominal license fee for use and occupation of the same from running bills. Such use occupation shall not be conferring any right of tenancy of the land/room/store yard to the Contractor. The Contractor shall be liable to vacate the occupied Land/room/store yard within 15 days after completion of work or on demand by the Engineer-Charge.

2.2 Necessary furniture, like table, chair, almirah, racks etc. for running the enquiry office and store shall be provided by the Contractor and no extra payment for these shall be paid by AAI. On expiry of the contract, the furniture may be taken back by the contractor.

2.3 The agency shall deploy a **minimum of one qualified full time supervisor with mobile phone at site for the co-ordination and attending complaints. Nothing extra shall be paid by AAI in this regard. The supervisor staff shall report to Airport Operational Area Maintenance Office every day except Sundays and national holidays. In the event of any**

failure, **recovery as applicable per day (Minimum Rs 1000/-per day)** shall be recovered from bills.

- 2.4 Store Ledger, complaint register, Site order book, Attendance Register and other stationeries as directed by the engineer-in-charge shall be provided by the Contractor and no extra payment for these shall be paid by AAI.
- 2.5 ELECTRICITY FACILITY: In case, if it is possible to provide temporary electric connection to agency to help execute certain civil work/complaints, same can be made available to him on chargeable basis as decided by engineer-in-charge in consultation with his electrical counter-part. Agency has to submit a formal request in this regard along with 'Electric Meter' (duly approved by AAI), wires of required length, switch-boards, plugs etc. however, providing electricity connection is not a liability on part of AAI and agency shall have no excuse or plea on it for not doing or attending any complaints

3. ATTENDING COMPLAINTS/WORK, PERMISSIBLE TIME LIMIT AND PENALTIES:

- 3.1 For ordering the various works on the Contractor, a register for complaint/works shall be maintained at site an appropriate location as directed by the Engineer-in-Charge.
- 3.2 Complaints as conveyed to the agency by any means like through complaint books, by email, by SMS / WhatsApp message or by letter from engineer-in-charge should be treated as work-order to attend related complaints. Same should also be recorded in the complaints register by the supervisor and get countersigned by Engineer-in-charge or his authorized representative. The Contractor shall also sign the same as a token of having received the work order.
- 3.3 Complaints shall be categorized in **THREE** categories –

3.3.1 Non critical or General complaints

e.g., repair of doors, windows, minor constructions, minor painting, marking etc. which are not affecting flight operations or category of works not defined in complaint books.

3.3.2 Critical complaints

e.g., related to water supply, sewage lines, boundary wall repair etc.as categorized by engineer-in-charge.

3.3.3 Highly critical complaints

Related to Emergency Runway and taxiway repair, critical water supply, urgent boundary wall repair, complaints related to aircraft operations, safety and security etc. as categorized by engineer-in-charge.

- 3.4 All day to day maintenance complaints or General Complaints shall be attended by the contractor in totality to the entire satisfaction of the complainant and Engineer-in-charge or his authorized representative **within maximum FIVE days** of their registration or within the specific time period if provided in the complaint register. Failing which **Penalty @ Rs. 100/- per day** will be levied as penalty for each complaint per day beyond the specified time limit. The decision of Engineer-in-Charge shall be final and binding.
- 3.5 All **CRITICAL** nature of complaints as so entitled by the Engineer-in-charge or his authorized Representative shall be attended to the entire satisfaction of the complainant and Engineer-in-Charge or his authorized Representative **within TWO days or within the specific time period** if provided in the complaint register. Failing which **Penalty @ Rs. 200/- per day** will be levied as penalty for each complaint per day beyond the specified time limit. The decision of Engineer-in-Charge shall be final and binding in all respect i.e., on the type of complaints and amount of penalty imposed.
- 3.6 In case of EMERGENCY and HIGHLY CRITICAL NATURE of complaints as certified by the Engineer-in-charge or his authorized Representative, the complaint shall be attended **immediately without loss of time** in totality to the entire satisfaction of the complaint and Engineer-in-charge or his authorized representative and to be completed **within the time frame** ordered in writing to the agency. Failing which **Penalty @ Rs. 1,000/- per day or higher compensation which would be linked with flight operation delay** and / or passenger movement obstructions **shall** be levied. The decision of Engineer-in-Charge shall be final and binding in all respect i.e., on the type of complaints and amount of penalty imposed
- 3.7 However, if Engineer-in-charge or his authorized representative feels that the contractor is not taking any appropriate action for attending the day to day complaints as mentioned above intentionally or closed his office temporarily, the same complaint will be attended by AAI by engaging other agency and **4(four) times** the actual expenditure incurred by AAI for that work shall be deducted from the contractor's bill as compensation. This is over and above the deduction mentioned in Penalty clauses as well as action to be taken under other relevant clauses of this agreement. Decision of Engineer-in-charge and his authorized representative is final and binding to the contractor
- 3.8 Wages payment to all workers, supervisors, engineers etc. shall be done on or **before 7th working day of following month** failing which a penalty of **Rs. 100.00 per day per employee and will be paid by the contractor to his employee along with salary**. Delay, if any, of payment of running bills should not be a reason for delay in payment to their staff. No any excuse on part of agency shall be entertained.

- 3.9 In a eventuality of abnormal delay in payment of wages, AAI had to intervene and pay wages to the workers, as per the relevant clauses of agreement, the paid amount shall be subsequently recovered from the agency's dues including **penalty with simple interest @ 18% per annum calculated per day for the delay period** till the date of actual recovery of dues.
- 3.10 AAI reserves the right to withhold minimum amount **@ 6 % of running account payment** [*Instead of 3% as mentioned in clause 20(A) GCC Page 56*] during the period considered **if PF / ESI contributions are not deposited** by the contractor in the concerned authority and proofs of that effect have not been produced.
- 3.11 **IMPORTMENT**: Attending complaints related to Flight operation, running of airport infrastructure like runway, apron, ATC tower etc. are utmost important and essence of this contract. Determination of contract shall be applicable on not attending complaints within specified time frame implied as **poor performance** of work by the contractor. If contractor is **(a)** Not fulfilling its obligation to rectify complaints and showing reluctance towards attending complaints frequently or **(b)** Fails to attend and rectify 100% complaint(s) of **highly critical nature (REDcolour)** as marked in the complaint register within the given time-period or **(c)** Contractor is not attending 90% of complaints of non-critical nature as registered in complaint books within specified time-frame, than the engineer-in-charge on behalf of chairman AAI, shall have powers to determine the contract so far as performance of work by the contractor is concerned. The determination notice in writing to the contractor under the hand of engg-in-charge shall be conclusive evidence. Upon such determination, **the Earnest Money Deposit (EMD) and Security deposit(SD)already recovered shall be liable to be forfeited. The contractor whose contract is determined, shall not be allowed to participate in the tendering process of this type of works (Annual Maintenance works) at Bhopal Airport for the current financial year as well as for next subsequent THREE financial years.** Other provisions of GCC clause 3 /page 20 shall also be applicable in above context. In the event of above course of action being adopted by engineer-in-charge, the contractor shall have no claim to compensation for any loss sustained by him by reasons whatsoever.

4. MANPOWER & PEMITS:

- 4.1 **The agency should well aware of various charges of the cost of Airport entry permit of labour, all types of vehicles, Airport driving permit etc. (Please refer SCC under relevant clauses) as mention in relevant pages of this tender document. The above charges are included in the rate quoted by the agency and nothing extra or No claim in this regard shall be entertained.**
- 4.2 The contractor or his authorized site representative (which have full financial and administrative power) must possess valid and working MOBILE PHONE and must be available on contact every day for 24 hrs. Failing which, Engineer-in-charge shall have full power to impose any penalty on the agency depending on the severity of the situation thus arrived if any.

5.0 SCHEDULE OF ITEMS & PAYMENT -

5.1 Schedule of Items applicable under this tender bid / contract shall be entire items of CPWD Delhi schedule of rates (DSR) 2023 Vol. 1 and Vol. 2 as well as Additional Miscellaneous Items Listed in pages SOQ 1 to 11.

5.3 Agency has to submit their bid / offer in **PERCENTAGE (%) TERM** over or below with respect to rates printed in **DSR (Delhi schedule of rates) 2023**. As the rates mentioned in DSR 2023 is inclusive of GST, hence the final rate payable shall be over the DSR 2023 rates after removal of GST impact before applying contractor's quoted percentage. The methodology of calculation is explained below. **The single value of quoted percentage shall be applied and valid on all items of DSR 2023 (Vol 1&2) and Additional Items as listed in SOQ wherever applicable.** Not more than one quoted percentage shall be entertained and bid shall be rejected in case of quoting two or more percentage value of different items of DSRs.

5.4 METHODOLOGY OF PAYMENT ON THE BASIS OF QUOTED PERCENTAGE OVER DSR 2023 -

1. Assume the percentage quoted by agency (*inclusive all taxes, duties, cess, fee, royalty charges etc. levied under any statute but excluding GST*) = X%

2. Removing GST impact on DSR 2023 rates and additional items(if any) (Y) = $R/1.2127$

(Where R = DSR 2023 Rates as well as additional Misc. Items wherever applicable)

3. Rate to be considered for payment = $(Y) \times [(100+X)/100]$

(Where Y = $R/1.2127$ and X = quoted percentage by the bidder)

4. GST shall be paid extra on all items as per applicable rates.

6. SUMMARY OF PENALTIES TO BE IMPOSED IN MAINTAINANCE WORKS:

There are few provisions of penalties to be imposed on agency in the event of failure to fulfill agreement provisions. Some of them are summarized below for a ready reference in addition to same already mentioned in various clauses of agreement. If there is any contradiction, the penalty mentioned in this clause will supersede others.

PARTICULAR ITEM'S SPECIFICATION

27.1 setting up of Civil Operational area maintenance office.....

1. Designated office space shall be allotted to the agency for the setting up of operational area maintenance office for which applicable rent shall be deducted from subsequent running bills.
2. As part of maintenance of operational area and various buildings & structures situated inside operational area and operational boundary wall, agency has to execute every kind including urgent nature of operational related complaints just like quick repair of operational boundary wall, RWY, Apron etc., attending water logging problems during rains, urgent water supply problems, security related any problem raised by CISF and security department, repairs of pot holes etc. Accordingly, full setup of operational area maintenance required within the airport premises.
3. Following provisions to be made by the agency at the **Civil Operational Area Maintenance office** for smooth and speedy attending various maintenance related minor complaints.

3.1 Minimum Furniture availability at Maintenance Office: Table (01 No). Bench/Chairs (03 No), Steel Almirah small size (01 No), Lockable toolbox Trunk or sandook (02 no), Cooler (01 No), One computer system with printer for making CMB / other civil Engg. works and other requirement as asked by Engg-in-charge to made available. Agency shall be permitted to remove these infrastructures after completion of contract period.

3.2 Minimum man power deployment: Following manpower to be deployed on round of the clock (as Bhopal Airport is a 24 hrs operation) on all working days (except Sundays and national holiday) at Bhopal Airport -

- (a) **01 Nos. Engineer**
- (b) **02 Nos. Supervisor**
- (c) **01 Nos. Skilled Manpower**

The above manpower shall directly report to Engineer – In – Charge or his representative and any particular manpower not fit for airport operational area job have to replace with suitable one. E-I-C shall have final authority on all such decisions.

3.3 Loading transport vehicle: The agency has to mandatory deploy in civil operational area maintenance office one **Loading vehicle minimum 5 seater** like *Mahindra Bolero Pickup truck / camper/ TATA 207 yodha* or similar equivalent vehicle not more than 5 (Five) years old in good running condition with valid commercial registration or as compatible with BCAS norms, valid fitness certificate, regular pollution checks(PUC) etc.

alongwith driver and required fuel etc all complete on all working days for 24 hrs. and monthly running upto 2500kms. This loading vehicle shall be used for quick attending of complaints anywhere inside operational area, inside as well as outside periphery of operational boundary wall for the purpose of transportation of material (like cement, sand, aggregate, bricks etc) in small quantities, labours etc. It shall be used in regular inspection of operational boundary wall, Runway, Taxiways, Drainage outlets etc. Agency has to bear the cost of ADP (Airport Driving Permit), AEP (Airport Entry Passes/Permit) and other charges.

Engg-in-charge shall have final authority on deployment of vehicle and its usage.

*A sum of **Rs 2700/- per day** shall be deducted in absence of said vehicle during working days.*

4. **Tools (T&P) to be made available at Maintenance office:** Drill Machine(masonry), Tile cutting machine, Hand trolley, Concrete breaker (niddle), Tractor trolley, Vibrator (niddle), Mason's tools, Car-painter's tools, Plumber's tools, Taslas & Fawdas in sufficient numbers, broom (Jhadu) used for runway sweeping, ladders (Folding) etc. Any other tools as and when required by engineer-in-charge have to arrange time to time.
