1. Item Rate e-tenders are invited through the e-tendering CPP Portal by Dy. General Manager(E-E) on behalf of Chairman, AAI from the eligible contractors for the work of **“Work Contract for Operation and Maintenance of all Type of E&M Installations at Cooch Behar Airport for Two Years (2026-28).”** at an estimated cost of Rs. 1,26,98,970/- (Excluding GST) with completion period of 24 (Twenty-Four) months.

The tendering process is online at CPP-portal URL address <https://etenders.gov.in/eprocure/app> or www.aai.aero. Prospective Tenderers may download and go through the tender document.

- ix) Bidders other than propriety firm shall submit, scanned copy of Authorization Letter/Power of Attorney along with copy of Certificate of Incorporation of the Company under Companies Act showing CIN/LLPIN/Name of Directors of the Company & Copy of Board Resolution regarding Authority to assign Power of Attorney. Proprietary firm shall submit scanned copy of Authorization Letter/Power of Attorney only if the tender is processed by a person other than proprietor.
- x) PQ Performa duly filled.
- xi) Digitally signed Tender document.

B. Qualifying requirements of contractors / tenderers containing the following:

- i) Should have successfully completed or substantially completed three works, each of ₹ 25,39,794/- or two works, each of ₹ 31,74,743/- or one work of ₹ 50,79,588/- in single contract of similar nature i.e. **"Work related to Annual Maintenance Contract of E&M installations by deputing required Manpower"** during last 07 (seven) years ending last day of month previous to the one in which tenders are invited.

The details of similar works completed during last seven years in the given format. Form-A with supporting documents issued by client.

Note:

1. *The Experience Certificates of works completed pre GST era, Completion amount will be divided by 1.12 (to exclude pre GST taxes) to make it at par with experience certificates of post GST era but excluding GST.*
2. *The Tenders invited for Annual Rate Contracts for O&M/ AMC/ CMC works, agency having experience of completed AMC contract of more than one year shall be counted for the value of work for a completed one year on pro-rata basis. However, the agency who has completed one year of work in running AMC contract of more than one year, may be counted for the value of work for a completed one year on pro-rata basis.*
3. *Experience gained by executing work on back-to-back contract/ Sub-contract basis is acceptable in the following conditions:*
 - (a) *Work should be actually executed by the second agency (sub-contractor) with due concurrence of the owner as tripartite agreement/ written approval. It should be backed by valid agreement and experience certificate.*
 - (b) *Payments received by second agency should be reflected in TDS certificates.*
4. *Experience gained in composite works for the specialized nature of works were executed by main contractor either by in-house expertise & experience or by engaging the specialized agencies with the approval of main client as per contract conditions. In such cases, main contractor as well as specialized agency both get the experience certificate for the same work from their respective client(s) i.e. main contractor for composite work along with specialized works from owner and specialized agency for specialized work(s) from the main contractor. In this situation, the experience certificate of either specialized agency or main agency having in-house expertise & experience, who has actually executed the specialized work(s), shall be considered for Technical /Pre-qualifying*

criteria in similar specialized nature of work(s).

5. Substantial completion shall be based on 80(eighty) percent of awarded cost or more value wise works completed under the contract. Substantial completion should not be defined in terms of percentage completion and it should be based on functional consideration. Certificate (Issued by Client) for 'substantial completion' of project / work / asset should contain two parts.

- a. Part -I shall contain 'financial value of work done'*
- b. Part-II shall contain 'certificate of functional completion of project / work / asset'.*

“The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to date of bid opening (Cover-I/ Technical bid).

- i) Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. **Tenderers showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.**
- ii) Should have Average Annual Financial Turnover of Rs. 22,47,718/- on construction works during last three years ending 31st march of the previous financial year. The financial information shall be submitted in the given format (**Form – B**). Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- iii) The tenderer should have minimum net worth of Rs. 9,52,423/- issued by certified Chartered Accountants. The certificate should be submitted in the given format (**Form – C**).

Envelope-II: - The Financial e-Bid through CPP portal.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected.

3. Refund of EMD:

EMD deposited by all the bidders except the confirmed lowest bidder shall be returned within one week from the date of opening of the financial bid. EMD of the successful bidder shall be returned on receipt of Security Deposit equivalent to EMD amount/ performance bank guarantee.

4. Bid Submission:

The tenderer shall submit their application only at CPP Portal: <https://etenders.gov.in/eprocure/app>. Tenderer/Contractor are advised to follow the instructions provided in the tender document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered. **Hard copy of application shall not be entertained.**

5. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

6. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website <http://etenders.gov.in/eprocure/app>, shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AAI.

7. **Bids Opening Process is as below:**

Envelope-I (Technical bid and Pre-qualification):

Envelope-I containing documents as per Para 2 (A) and (B) (uploaded by the tenderers) shall be opened on date & time mentioned in CRITICAL DATA SHEET.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope – I, he will be asked to provide it through CPP portal, if required. The tenderer shall upload the requisite clarification/documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/rejection of their bids will be intimated to the tenderers through CPP portal.

Envelope-II (Financial Bid):

Envelope-II containing financial bid of the tenderers found to be meeting the technical criteria and qualifying requirements shall be opened on date & time mentioned in CRITICAL DATA SHEET. **(In case the date and time for opening of Envelope-II (Financial bid) is required to be changed, the same shall be intimated through CPP Portal).**

8. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.

9. AAI reserves the right to disallow the working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/Temporary or Permanent debarment/black listing by any department of AAI. **AAI reserves the right to verify the credential submitted by the tenderer at any stage (before or after the award the work). If at any stage, any information /documents submitted by the applicant is found to be incorrect/false or have some discrepancy which disqualifies the tenderer then AAI shall take the following action:**

a) **Forfeit the entire amount of EMD submitted by the tenderer.**

b) **The tenderer shall be liable for debarment for a period up-to two years from tendering in AAI, including termination of the contract apart from any other appropriate contractual/legal action.**

10. Consortium/JV companies shall not be permitted.

11. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.

12. Concessions to Indian Micro & Small Enterprises (MSEs) units registered with DIC/NSIC/KVIC/KVIB/Directorate of Handicraft and Handloom etc., to be given as per the provisions of Public Procurement Policy for MSEs order 2012 with up to date amendments, shall be applicable for tenders of supply/services and shall not be extended to construction work.
13. Tenderers have to submit Unique Document Identification Number (UDIN) generated documents like Financial information (Turnover with loss/ profit), Net worth Certificate etc. as per NIT conditions duly certified by CA and having UDIN. The documents submitted by bidders without UDIN shall not be entertained.
14. Department of Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India, issued Public Procurement (Preference to Make in India), Order 2017 vide OM No. P-45021/2/2017-PP(BE-II) dated 16.09.2020 is applicable.
15. Requirement of registration by the Bidder from a country sharing land border with India based on order No. F No. 6/18/2019-PPD dated 23/07/2020 of Government of India, Ministry of Finance, Department of Expenditure (Public procurement Division) with up to date amendments, regarding restriction under Rule 144(xi) of the General Financial Rules (GFR) 2017 shall be applicable. Instructions for Online Bid Submission

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at:

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <https://etenders.gov.in/eprocure/app>) by clicking on the link “**Online bidder Enrollment**” on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS / e- mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such

standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use “My Space” or “Other Important Documents” area available to them to upload such documents. These documents may be directly submitted from the “My Space” area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.

Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 7) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) Upon the successful and timely submission of bids (i.e. after Clicking “Freeze Bid Submission” in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 9) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

In case the lowest tendered amount (worked out on the basis of quoted rate of Individual items) of two or more contractors is same, then such lowest contractors will be asked to submit revised offer quoting rate of each item of the schedule of quantity for all sub sections/sub heads as the case may be, but the revised quoted rate of each item of schedule of quantity for all sub sections/sub heads should not be higher than their respective original rate quoted already at the time of submission of tender. The lowest tender shall be decided on the basis of

		revised offer. If the revised tendered amount (worked out on the basis of quoted rate of individual items) of two or more contractors received in revised offer is again found to be equal, then the lowest tender, among such contractors, shall be decided by draw of lots in the presence of Jt. GM (Engg) / DGM (Engg) / AGM (Engg) / Sr. Manager (Engg) in-Charge of major and minor component(s) work and the lowest contractors those have quoted equal amount of their tenders. In case of any such lowest contractor in his revised offer quotes rate of any item more than their respective original rate quoted earlier at the time of submission of tender, then such revised offer shall be treated invalid. Such case of revised offer of the lowest contractor or case of refusal to submit revised offer by the lowest contractor shall be treated as withdrawal of his tender before acceptance and 50% of his earnest money shall be forfeited. In case all the lowest contractors those have same tendered amount (as a result of their quoted rate of individual items), refuse to submit revised offers, then tenders are to be recalled after forfeiting 50% of EMD of each lowest contractor. Contractor, whose earnest money is forfeited because of non-submission of revised offer, or quoting higher revised rate(s) of any item(s) than their respective original rate quoted already at the time of submission of his bid shall not be allowed to participate in the retendering process of the work. Note: Till the time software supports the above provisions, revised offers from tenderers forming the tie shall be obtained and procedure prescribed for "Restricted call of tenders" shall be adopted (for e-tenders).
4. (A)	Applicable for Percentage Rate Tender only.	In case of Percentage Rate Tenders, tenderer shall fill up the usual printed form, stating at what percentage below/above (in figures as well as in words) the total estimated cost given in Schedule of Quantities at Schedule-A, he will be willing to execute the work. The tender submitted shall be treated as invalid if; 1. The contractor does not quote percentage above/below on the total amount of tender or any section/sub-head of the tender. 2. The percentage above / below is not quoted in figures & words both on the total amount of tender or any section / sub-head of the tender. 3. The percentage quoted above/below is different in figures and words on the total amount of tender or any section / sub-head of the tender. Tenders, which propose any alteration in the work specified in the said form of invitation to tender, or in the time allowed for carrying out the work, or which contain any other conditions of any sort including conditional rebates, will be summarily rejected. No single tender shall include more than one work, but contractors who wish to tender for two or more works shall submit separate tender for each. Tender shall have the name and number of the works to which they refer, written on the envelopes. In case the lowest tendered amount (estimated cost + amount worked on the basis of percentage above/below) of two or more bidders is same, such lowest bidders will be asked to submit revised offer in the form of letter mentioning percentage above/ below on estimated cost of tender including all sub sections/sub heads as the case may be, but the revised percentage quoted above / below on tendered cost or on each sub-section/ sub head should not be higher than the percentage quoted at the time of submission of tender. The lowest tender shall be decided on the basis of revised offers. In case any of such contractor refuses to submit revised offer, then it shall be treated as withdrawal of his tender before acceptance and 50% of earnest money shall be forfeited. If the revised tendered amount of two more bidders received in revised offer is again found to be equal, the lowest tender, among such bidders, shall be decided by draw of lots in the presence of Jt. GM (Engg) / DGM (Engg) / AGM (Engg) /

		Sr. Manager (Engg) in Charge of work & the lowest bidders those who have quoted equal amount of their tenders. In case all the lowest bidders those have quoted same tendered amount, refuse to submit revised offers, then tenders are to be recalled after forfeiting 50% of EMD of each bidder. Bidders, whose earnest money is forfeited because of non submission of revised offer, shall not be allowed to participate in the re-tendering process of the work. Note: Till the time software supports the above provisions, revised offers from tenderers forming the tie shall be obtained and procedure prescribed for “Restricted call of tenders” shall be adopted.
4. (B)		In case the lowest tendered amount (estimated cost + amount worked on the basis of percentage above/below) of two or more contractor is same, such lowest contractor will be asked to submit sealed revised offer in the form of letter mentioning percentage above/below on estimated cost of tender including all sub section/sub heads as the case may be, but the revised percentage quoted above/below on tendered cost or on each sub section /sub head should not be higher than the percentage quoted at the time of submission of tender. The lowest tender shall be decided on the basis of revised offers. In case any of such contractor refuses to submit revised offer, then it shall be treated as withdrawal of his tender before acceptance and 50% of earnest money shall be forfeited. If the revised tendered amount of two more contractors received in revised offers is again found to be equal, the lowest tender, among such contractor, shall be decided by draw of lots in the presence of Jt.GM (Engg) / DGM (Engg), AGM (Engg) / Sr. Manager (Engg) in -Charge of major & minor component(s) of work & the lowest bidders those who have quoted same tendered amount of their tenders. In case all the lowest contractors those have quoted same tendered amount, refuse to submit revised offers, then tenders are to be recalled after forfeiting 50% of EMD of each bidder. Bidders, whose earnest money is forfeited because of non- submission of revised offer, shall not be allowed to participate in the re-tendering process of the work.
5.		The officer inviting tender or his duly authorized representative, will open tenders in the presence of any intending bidders who may be present at the time, and will enter the amounts of the several tenders in a comparative statement in a suitable form. In the event of a tender being accepted, a receipt for the earnest money shall thereupon be given to the contractor who shall thereupon for the purpose of identification sign copies of the specifications and other documents mentioned in Rule – I. In the event of a tender being rejected, the earnest money shall thereupon be returned to the contractor remitting the same, without any interest.
6.		The officer inviting tenders shall have the right of rejecting all or any of the tenders and will not be bound to accept the lowest or any other tender.
7.		The receipt of an accountant or clerk for any money paid by the bidder towards tender fee will not be considered as any acknowledgement or payment to the officer inviting tender and the bidder shall be responsible for seeing that he procures a receipt signed by the officer inviting tender or a duly authorized cashier.
8.		The memorandum of work tendered for and the schedule of materials to be supplied by the department and their issue-rates, shall be filled and completed in the office of the officer inviting tender before the tender form is issued. If a form is issued to an intending bidder without having been so filled in and incomplete, he shall request the officer to have this done before he completes and delivers his tender.

9.		The bidders shall sign a declaration under the officials Secret Act 1923, for maintaining secrecy of the tender documents drawings or other records connected with the work given to them. The unsuccessful bidders shall return all the drawings given to them.
9(A).		Use of correcting fluid anywhere in tender document is not permitted. Such tender is liable for rejection. If there is any correction it should be cut with a straight line and should be initialed and cello tape to be provided on all the rates quoted in case of physical tenders.
10.	Applicable for Item Rate Tender Only.	In the case of Item Rate Tenders, only rates quoted shall be considered. Any tender containing percentage below / above the rates quoted is liable to be rejected. Rates quoted by the bidder in item rate tender in figures and words shall be accurately filled in so that there is no discrepancy in the rates written in figures and words. However, - If a discrepancy is found between rates in figures and in words, then the rates which correspond with the amount worked out by the bidder shall unless otherwise proved be taken as correct. - If the amount of an item is not worked out by the bidder or it does not correspond with the rates written either in figures or in words, then the rates quoted by the contractor in words shall be taken as correct. - Where the rates quoted by the bidder in figures and in words tally, but the amount is not worked out correctly, the rates quoted by the contractor will unless otherwise proved be taken as correct and not the amount. - In event no rate has been quoted for any item(s) leaving space blank both in figure(s) and word(s) or cancelled the quoted rate in figure(s), and word(s) but the amount corresponding to the item(s) is worked out by the bidder and added to the grand total, then rate(s) of the item(s) shall be derived from the amount(s) quoted by the contractor against such item(s). - In event no rate has been quoted for any item(s), leaving space both in figure(s), word(s), and amount blank, it will be presumed that the bidder has included the cost of this/these item(s) in other items and rate for such item(s) will be considered as zero and work will be required to be executed accordingly. Sub Para i to iv above shall not be applicable in case of e-tendering.
	Applicable for percentage rate tender only.	In case of percentage Rate Tenders only percentage quoted shall be considered. Any tender containing item rates is liable to be rejected Percentage quoted by the bidder in percentage rate tender shall be accurately filled in figures and words, so that there is no discrepancy. However, if the bidder has worked out the amount of the tender and if any discrepancy is found in the percentage quoted in words and figures, The percentage which corresponds with the amount worked out by the bidder shall, unless otherwise proved, be taken as correct. If the amount of the tender is not worked out by the bidder or it does not correspond with the percentage written either in figures or in words, then the percentage quoted by the bidder in words shall be taken as correct. 11.		In the case of any tender where unit rate of any item / items appears unrealistic, such tender will be considered as unbalanced and in case the tenderer is unable to provide satisfactory explanation, such a tender is liable to be disqualified and rejected.
12.	Applicable for Item Rate Tender only.	All rates shall be quoted on the tender form. The amount for each item should be worked out and requisite totals given. Special care should be taken to write the rates in figures as well as in words and the amount in figures only, in such a way that interpolation is not possible. The total amount should be written both in



		figures and in words. In case of figures, the word 'Rs' should be written before the figure of rupees and word 'P' after the decimal figures, e.g. 'Rs. 2.15 P' and in case of words, the word 'Rupees' should precede and the word 'Paise' should be written at the end. Engineer in charge shall also give one reminder after 10 days of 1 st letter and if contractor still do not start the work on ALQ items, then bank guarantee i.e. QPBG should be encashed and work should be got executed through another agency at his risk and cost.
14		i. The bidder, whose tender is accepted, will be required to furnish performance uarantee of 5% (Five Percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of Fixed Deposit Receipts or Guarantee Bonds of any cheduled Bank but not co-operative or Gramin Bank, in accordance with the prescribed form, provided confirmatory advice is enclosed.



		ii. The bidder, whose tender is accepted, will also be required to furnish by way of Security Deposit for the fulfillment of his contract, an amount equal to 5% of the contract amount of the work. iii. In works where condition of submission of Performance Guarantee is not applicable, the security deposit @ 10% of the tendered value shall be deducted. iv. The Security deposit (under ii & iii above) will be collected by deductions from the running bills of the contractor at the rates mentioned above and the earnest money deposited at the time of tenders, will be treated as a part of the Security Deposit. v. 15.		On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer-in-Charge shall be communicated in writing to the Engineer-in-Charge.
16.		1. Rates to be quoted by the parties should be inclusive of all taxes, duties, CESS, fee, royalty charges etc. 2. However GST, as applicable, shall be paid to the contractor, for any taxable supply / services / construction rendered by the agency to AAI, against a valid GST invoice as per terms and conditions of the contract. 3. In case supplies /services / works involve imports; the same should be identified separately. Basic Custom Duty & IGST will be paid directly by AAI by utilizing EPCG license / Duty Credit Scrip under service Export from India Scheme (SEIS) of Govt. of India.
17.		The contractor/ bidder shall give a list of AAI employees related to him.
18.		The tender for the work shall not be witnessed by a contractor or contractors / bidders who himself / themselves has / have tendered or who may and has / have tendered for the same work. Failure to observe this condition would render, tenders of the contractors tendering, as well as witnessing the tender, liable to summary rejection.



19.		The tender for composite work includes, in addition to building work, all other works such as sanitary and water supply installations drainage installation, electrical work, horticulture work, roads and paths etc. The tenderer apart from being a registered contractor (B&R) of appropriate class, must associate himself with agencies of appropriate class which are eligible to tender for sanitary and water supply drainage, electrical and horticulture works in the composite tender.			
20.		The contractor/ bidder shall submit list of works completed in last 5 years*as well as which are in hand (In progress) in the following format for assessing bidding capacity of the bidders:-

21		The contractor/bidder shall comply with the provisions of the Apprentices Act 1961, and the rules and orders issued there under from time to time. If he fails to do so, his failure will be a breach of the contract and the Executive Director (Engg.) may in his discretion, without prejudice to any other right or remedy available in law, cancel the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation by him of the provisions of the said Act.			
22		If complete site is available for work, the work shall be completed in the manner specified here in special condition of contract and NIT specifications.			
23		Note: In such case para 23 below may be deleted by NIT approving authority If complete site is not available for taking up the work, the same shall be made available in phases. The scope of work covered in each phase, time for completion of work in each phase and methodology of taking over completed work in phased manner has been specified under special conditions of contract. The completion time for each phase shall be applicable as indicated in tender documents. The work shall also be taken over by Engineer In Charge in phases. The warranty for the works executed in each phase shall be applied independently w.e.f. date of completion /taking over of individual phase. Note: In such case para 22 above may be deleted by NIT approving authority			

Note: The additional clause i.e. 14(vi) is appended below:

Clause 1B: Additional Performance Security

- (a) The contractor shall submit an irrevocable additional performance security in the form of an irrevocable Insurance Surety bond, demand draft, bank guarantee issued from Scheduled Commercial Bank (i.e. Indian or Foreign Banks included in the Second Schedule of Reserve Bank of India Act, 1934 excluding Co-Operative/Regional Rural Banks, if the Bid price offered by the selected bidder is lower than 10% of the estimated cost put to tender, This clause shall be binding and enforceable in relation to all works, irrespective of their nature, scope, or value.
- (b) Performance security should be furnished within 30 days of issue of Letter of Intent and before award of work. In case the contractor fails to deposit performance guarantee within the stipulated period, tender shall be stand cancelled without any notice and further, EMD shall be forfeited and the contractor shall be liable for debarment upto a period of two (02) years.
- (c) The Performance Guarantee shall be initially valid up-to the stipulated date of completion plus 180 days beyond that. In case the time for completion of work gets enlarged, the contractor shall get the validity of Performance Guarantee extended to cover such enlarged time for completion of work. After recording of the completion certificate for the work by the competent authority, the performance guarantee shall be returned to the contractor, without any interest. However, in case of contracts involving maintenance of buildings and services / any other work thereafter, 50% of Performance Guarantee shall be retained as Security Deposit as per contract conditions. The same shall be returned on successful completion of commitment year wise proportionately.
- (d) The Engineer-in-Charge shall not make a claim under the performance guarantee except for amounts to which the AAI is entitled under the contract (not withstanding and/or without prejudice to any other provisions in the contract agreement) in the event of:
- (i) Failure by the contractor to extend the validity of the Performance Guarantee as described herein above, in which event the Engineer-in-Charge may claim the full amount of the Performance Guarantee.
 - (ii) Failure by the contractor to pay the Chairman, AAI any amount due, either as agreed by the contractor or determined under any of the Clauses / Conditions of the agreement, within 30 days of the service of notice to this effect by Engineer-in-Charge.
- (e) In the event of the contract being determined or rescinded under provision of any of the Clause/Condition of the agreement, the performance guarantee shall stand forfeited in full and shall be absolutely at the disposal of the Chairman, AAI.

Additional Performance Security Amount and Treatment:

The additional performance security shall be calculated as below:

- (i) **Where the bid price is below 10% but not below 20% of the project cost put to bid**, the additional performance security percentage shall be incremented by 0.25% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance security being 0.25% and this additional performance security percentage shall be applied on the bid price.
- (ii) **Where the bid price is below 20% but not below 25% of the project cost put to bid**, the additional performance security percentage shall be incremented by 0.50% for every percentage of bid price below 20% of the project cost put to bid starting at 21% with the additional bid performance security being 0.50% and this additional performance security percentage shall be applied on the bid price.
- (iii) **Where the bid price is below 25% but not below 30% of the project cost put to bid**, the additional performance security percentage shall be incremented by 0.75% for every percentage of bid price below 25% of the project cost put to bid starting at 26% with the additional bid performance security being 0.75% and this additional performance security percentage shall be applied on the bid price.
- (iv) **Where the bid price is below 30%**, the additional performance security percentage shall be incremented by 1% for every percentage of bid price below 30% of the project cost put to bid starting at 31% with the additional bid performance security being 1% and this additional performance security percentage shall be applied on the bid price.
- (v) The additional performance security percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
- (vi) All matters pertaining to validity, extension, claims, forfeiture, and any other conditions in relation to the additional performance security shall be governed by the provision as mentioned above.

CONDITIONS OF CONTRACT

Definitions:

1.		The contract means the documents forming the tender and acceptance thereof and the formal agreement / agreements executed between the competent authority(s) on behalf of the Chairman, Airports Authority of India and the Contractor, together with the documents referred to therein including these conditions, the specifications, designs, drawings and instructions issued from time to time by the Engineer-in-Charge and all these documents taken together, shall be deemed to form one contract / two contracts and shall be complimentary to one another. Contractor has to sign two agreements, one consisting BOQ for Civil works and another one for SITC and O&M / AMC / AICMC part. Engineer-in charge could be common for both the agreements. Separate invoices for the civil /construction works and SITC / O&M / AICMC / AMC works have to be raised by the agency referring to the respective agreements to facilitate AAI to claim input tax credit on such SITC / O&M / AICMC / AMC works as mentioned in Schedule 'F' para 2(v).
2.		In the contract, the following expressions shall, unless the context otherwise requires, have the meanings, hereby respectively assigned to them :-
		i. The expression works or work shall, unless there be something either in the subject or context repugnant to such construction, be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent, and whether original, altered, substituted or additional. ii. The site shall mean the land / or other places on, into or through which work is to be executed under the contract or any adjacent land, path or street through which work is to be executed under the contract or any adjacent land, path or street which may be allotted or used for the purpose of carrying out the contract. iii. The Contractor / tenderer / bidder shall mean the individual, firm or company whether incorporated or not, Joint Venture / Consortium undertaking the works and shall include the legal personal representative of such individual or the persons constituting such firm or company, or the successors of such firm or company and the permitted assignees of such individual, firm or company. iv. The Chairman means the Chairman Airports Authority of India and his Successors. v. The Engineer-in-Charge means the Engineering Officer who shall supervise and be in-charge of the work and who shall sign the contract on behalf of the Chairman, Airports Authority of India as mentioned in Schedule 'F' hereunder. vi. AAI or Airports Authority of India shall mean the Chairman Airports Authority of India. vii. The terms Member (Planning) means the head of Department of Engineering, Airports Authority of India. viii. Accepting Authority shall mean the authority mentioned in Schedule 'F'. ix. Excepted Risk are risks due to riots (other than those on account of contractor's employees), war (whether declared or not) invasion, act of foreign enemies, hostilities, civil war, rebellion revolution, insurrection, terrorism, military or usurped power, any acts of Airports Authority of India, damages from aircraft, acts of God, such as earthquake, lightening and unprecedented floods, and other causes over which the contractor has no control and accepted as such by the Accepting Authority or causes solely due to use or occupation by Airports Authority of India of the part of the works in respect of which a certificate of completion has been issued or a cause solely due to Airports Authority of India's faulty design of works. x. Market Rate shall be the rate as decided by the Engineer-in-Charge on the basis of the prevailing cost of materials and labour at the site where the work is to be executed plus the percentage mentioned in Schedule 'F' to cover, all overheads and profits. Provided that no extra overheads and profits shall be payable on the parts of works assigned to other agency(s) by the contractor as per terms of contract.

		xi. Schedule(s) referred to in these conditions shall mean the relevant schedule(s) annexed to the tender papers or the standard Schedule of Rates of the government mentioned in Schedule 'F' hereunder, with the amendments thereto issued upto the date of receipt of the tender. xii. Department means Airports Authority of India, which invites tender on behalf of Chairman, Airports Authority of India. xiii. Tendered value means the value of the entire work as stipulated in the letter of award.
3.	Scope and Performance	Where the context so requires, words imparting the singular only also include the plural and vice versa. Any reference to masculine gender shall whenever required include feminine gender and vice versa.
4.		Headings and Marginal notes to these General Conditions of Contract shall not be deemed to form part thereof or be taken into consideration in the interpretation or construction thereof or of the contract.
5.		The contractor shall be furnished, free of cost one certified copy of the contract documents except standard specifications, Schedule of Rates and such other printed and published documents, together with all drawings as may be forming part of the tender papers. None of these documents shall be used for any purpose other than that of this contract.
6.	Works to be carried out	The work to be carried out under the Contract shall, except as otherwise provided in these conditions, include all labour, materials, tools, plants, equipment and transport which may be required in preparation of and for and in the full and entire execution and completion of the works. The descriptions given in the Schedule of Quantities (Schedule – A) shall, unless otherwise stated, be held to include wastage on materials, carriage and cartage, carrying and return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion of the work as aforesaid in accordance with good practice and recognized principles.
7.	Sufficiency of Tender	The Contractor shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender for the works and of the rates and prices quoted in the Schedule of Quantities, which rates and prices shall, except as otherwise provided, cover all his obligations under the Contract and all matters and things necessary for the proper completion and maintenance of the works.
8.	Discrepancies and Adjustment of Errors	The several documents forming the Contract are to be taken as mutually explanatory of one another, detailed drawings being followed in preference to small scale drawing and figured dimensions in preference to scale and special conditions in preference to General Conditions.
8.1		In the case of discrepancy between the Schedule of Quantities, the Specifications and / or the Drawings, the following order of preference shall be observed: -
		i. Description of Schedule of Quantities. ii. Particular/ technical Specification and Special Condition, if any. iii. Drawings. iv. C P W D Specifications. v. Indian Standard Specifications of B I S / IRC Code of Practice / ASTM standards. vi. Sound Engineering practice as directed by the Engineer-in-charge, whose decision in this regard shall final and binding on the contractor.
8.2		If there are varying or conflicting provisions made in any one document forming part of the contract, the Accepting Authority shall be the deciding authority with regard to the intention of the document and his decision shall be final and binding on the contractor.

However, in case of contracts involving maintenance of buildings and services / any other work thereafter, 50% of Performance Guarantee shall be retained as Security Deposit as per contract conditions. The same shall be returned on successful completion of commitment year wise proportionately.
- (d) The Engineer-in-Charge shall not make a claim under the performance guarantee except for amounts to which the AAI is entitled under the contract (not withstanding and/or without prejudice to any other provisions in the contract agreement) in the event of:
- (i) Failure by the contractor to extend the validity of the Performance Guarantee as described herein above, in which event the Engineer-in- Charge may claim the full amount of the Performance Guarantee.
 - (ii) Failure by the contractor to pay the Chairman, AAI any amount due, either as agreed by the contractor or determined under any of the Clauses / Conditions of the agreement, within 30 days of the service of notice to this effect by Engineer-in-Charge.
- (e) In the event of the contract being determined or rescinded under provision of any of the Clause/Condition of the agreement, the performance guarantee shall stand forfeited in full and shall be absolutely at the disposal of the Chairman, AAI.

Additional Performance Security Amount and Treatment:

The additional performance security shall be calculated as below:

- (i) **Where the bid price is below 10% but not below 20% of the project cost put to bid**, the additional performance security percentage shall be incremented by 0.25% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance security being 0.25% and this additional performance security percentage shall be applied on the bid price.
- (ii) **Where the bid price is below 20% but not below 25% of the project cost put to bid**, the additional performance security percentage shall be incremented by 0.50% for every percentage of bid price below 20% of the project cost put to bid starting at 21% with the additional bid performance security being 0.50% and this additional performance security percentage shall be applied on the bid price.
- (iii) **Where the bid price is below 25% but not below 30% of the project cost put to bid**, the additional performance security percentage shall be incremented by 0.75% for every percentage of bid price below 25% of the project cost put to bid starting at 26% with the additional bid performance security being 0.75% and this additional performance security percentage shall be applied on the bid price.
- (iv) **Where the bid price is below 30%**, the additional performance security percentage shall be incremented by 1% for every percentage of bid price below 30% of the project cost put to bid starting at 31% with the additional bid performance security being 1% and this additional performance security percentage shall be applied on the bid price.
- (v) The additional performance security percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
- (vi) All matters pertaining to validity, extension, claims, forfeiture, and any other conditions in relation to the additional performance security shall be governed by the provision as mentioned above.

The Engineer-in-Charge or his authorized representative shall always have access to the works and to all workshops and places where work component is being prepared or from where materials, manufactured articles or machinery are being obtained for the works and the contractor shall afford every facility and every assistance in obtaining the right to such access. 6. The Engineer-in-Charge shall have full powers to require the removal from the premises of all materials which in his opinion are not in accordance with the specifications and in case of default, the Engineer-in-Charge shall be at liberty to employ at the expense of the contractor, other persons to remove the same without being answerable or accountable for any loss or damage that may happen or arise to such materials. Where piped water supply is available supply shall be at stand posts and where the supply is from wells or river, tanks which may be of metal or masonry, shall be provided. The contractor (s) shall also at his / their own cost make arrangements for laying pipe lines for water supply to his / their labour camp from the existing mains wherever available and shall pay all fees and charges therefor. iv. The site selected for the camp shall be high ground, removed from jungle. v. Disposal of Excreta: The contractor (s) shall make necessary arrangement for the disposal of excreta from the latrines by trenching or incineration which shall be according to the requirements laid down by the Local Health Authorities. If trenching or incineration is not allowed, the contractor (s) shall make arrangements for the removal of the excreta through the Municipal Committee / authority and inform it about the number of labourers employed so that arrangements may be made by such Committee / authority for the removal of excreta. All charges on this account shall be borne by the contractor and paid direct by him to the

		Municipality / authority. The contractor shall provide one sweeper for every eight seats in case of dry system. vi. Drainage The contractor (s) shall provide efficient arrangements for draining away sullage water so as to keep the camp neat and tidy. vii. The contractor (s) shall make necessary arrangements for keeping the camp area sufficiently lighted to avoid accidents to the workers. viii. Sanitation The contractor(s) shall make arrangements for conservancy and sanitation in the labour camps according to the rules of the Local Public Health and Medical Authorities.

The contractor shall arrange his programme of work according to the availability of the plant and machinery and no claim, whatsoever, will be entertained from him for any delay in supply by the department. iv. The hire charges shall be recovered at the prescribed rates from and inclusive of the date the plant and machinery made over upto and inclusive of the date of the return in good order even though the same may not have been working for any cause except major breakdown due to no fault of the contractor or faulty use requiring more than three working days continuously (excluding intervening holidays and Sundays) for bringing the plant in order. The contractor shall immediately intimate in writing to the Engineer-in-charge when any plant or machinery gets out of order requiring major repairs as aforesaid. The Engineer-in-charge shall record the date and time of receipt of such intimation in the log sheet of the plant or machinery. Based on this if the breakdown before lunch period or major breakdown will be computed considering half a day's breakdown on the day of complaint. If the breakdown occurs in the post lunch period of major breakdown will be computed starting from the next working day. In case of any dispute under this clause, the decision of the Executive Director (Engg) /General Manager (Engg) shall be final and binding on the contractor. v. The hire charges shown above are for each day of 8 hours (inclusive of the one hour lunch break) or part thereof. vi. Hire charges will include service of operating staff as required and also supply of lubricating oil and stores for cleaning purposes. Power fuel of approved type, firewood, kerosene oil etc. for running the plant and machinery and also the full time chowkidar for guarding the plant and machinery against any loss or damage shall be arranged by the contractor who shall be fully responsible for the safeguard and security of plant and machinery. The contractor shall on or before the supply of plant and machinery sign an agreement indemnifying the Department against any loss or damage caused to the plant and machinery either during transit or at site of work. vii. Ordinarily, no plant and machinery shall work for more than 8 hours a day inclusive of one hour lunch break. In case of an urgent work however, the Engineer-in-charge may, at his discretion, allow the plant and machinery to be worked for more than normal period of 8 hours a day. In that case, the hourly hire charges for overtime to be borne by the contractor shall be 50% more than the normal proportionate hourly charges (1/8th of the daily charges) subject to a minimum of half day's normal charges on any particular day. For working out hire charges for over time, a period of half an hour and above will be charged as one hour and a period of less than half an hour will be ignored. viii. The contractor shall release the plant and machinery every seventh day for periodical servicing and / or wash out which may take about three to four hours or more. Hire charges for full day shall be recovered from the contractor for the day of servicing / wash out irrespective of the period employed in servicing. ix. The plant and machinery once issued to the contractor shall not be returned by him on account of lack of arrangements of labour and materials, etc. on his part, the same will be returned only when they are required for major repairs or when in the opinion of the Engineer-in-charge, the work or a portion of work for which the same was issued is completed. x. Log Book for recording the hours of daily work for each of the plant and machinery supplied to the contractor will be maintained by the Department and will be countersigned by the contractor or his authorised agent daily. In

		case the contractor contests the correctness of the entries and / or fails to sign the Log Book, the decision of the Engineer-in-charge shall be final and binding on him. Hire charges will be calculated according to the entries in the Log Book and will be binding on the contractor. Recovery on account of hire charges for road rollers shall be made for the minimum number of days worked out on the assumption that a roller can consolidate per day and maximum quantity of materials or area surfacing as noted against each in the annexed statement (see attached annexure). xi. In the case of concrete mixers, the contractors shall arrange to get the hopper cleaned and the drum washed at the close of the work each day or each occasion. (a) In case rollers for consolidation are employed by the contractor himself, log book for such rollers shall be maintained in the same manner as is done in case of departmental rollers, maximum quantity of any items to be consolidated for each roller-day shall also be same as in Annexure to Clause 34(x). For less use of rollers, recovery for the less roller days shall be made at the stipulated issue rate. xii. The contractor shall be responsible to return the plant and machinery in the condition in which it was handed over to him and he shall be responsible for all damage caused to the said plant and machinery at the site of work or elsewhere in operation or otherwise or during transit including damage to or loss of parts, and for all losses due to his failure to return the same soon after the completion of the work for which it was issued. The Engineer-in-charge shall be the sole judge to determine the liability of the contractor and its extent in this regard and his decision shall be final and binding on the contractor. xiii. The contractor will be exempted from levy of any hire charges for the number of days he is called upon in writing by the Engineer-in-charge to suspend execution of the work, provided AAI's plant and machinery in question have, in fact, remained idle with the contractor because of the suspension. xiv. In the event of the contractor not requiring any item of plant and machinery issued by AAI though not stipulated for issue in Schedule 'C' any time after taking delivery at the place of issue, he may return it after two days written notice or at any time without notice if he agrees to pay hire charges for two additional days without, in any way, affecting the right of the Engineer-in-charge to use the said plant and machinery during the said period of two days as he likes including hiring out to a third party.

Minimum requirement of such technical representative (s) and their qualifications and experience shall not be lower than specified in schedule 'F'. Any such approval may at any time be withdrawn and in case of such withdrawal, the contractor shall appoint another such representative (s) according to the provisions of this clause. Decision of the tender accepting authority shall be final and binding on the contractor in this respect. Such a principal technical representative and other technical representative (s) shall be appointed by the contractor soon after receipt of the approval from Engineer in charge and shall be available at site before start of work. All the provisions applicable to the principal technical representative under the clause will also be applicable to other technical representative(s). The principal technical representative and other technical representative (s) shall be present at the site of work for supervision at all times when any construction activity is in progress and also present himself/themselves, as required to the Engineer in Charge and / or his designated representative to take instructions. Instructions given to the principal technical representative or other technical representative (s) shall be deemed to have the same force as if these have been given to the contractor. The Principal Technical Representative and other technical representatives shall be actually available at site fully during all stages of execution work, during recording / checking / test checking of measurements of works whenever so required by the Engineer in Charge and shall also note down instructions conveyed by the Engineer in Charge or his designated representative (s) in the site order book and shall affix his/their signature in token of noting down the instructions and in token of acceptance of measurements / checked measurements / test checked measurements. The representative (s) shall not look after any other work. Substitutes, duly approved by engineer in Charge of the work in similar manner as aforesaid shall be provided in event of absence of any of the representative (s) by more than two days. If the Engineer in Charge, whose decision in this respect is final and binding on the contractor, is convinced that no such technical representative (s) is/are effectively appointed or is/are effectively attending or fulfilling the provision of this clause, a recovery (non refundable) shall be effected from the contractor as

		specified in Schedule 'F' and the decision of the Engineer in Charge as recorded in the site order book and measurement recorded checked/test checked in Measurement Books shall be final and binding on the contractor. Further if the contractor fails to appoint suitable technical Principal technical representative and / or other technical representative (s) and if such appointed persons are not effectively present or are absent by more than two days without duly approved substitute or do not discharge their responsibility satisfactorily, the Engineer in Charge shall have full powers to suspend the execution of the work until such date as suitable other technical representative (s) is / are appointed and the contractor shall be held responsible for the delay so caused to the work. The contractor shall submit a certificate of employment of the technical representative (s) (in the form of copy of Form 16 or CPF deduction issued to the Engineer employed by him) along with every running account bill / final bill and shall produce evidence if at any times so required by the Engineer in Charge. ii. The contractor shall provide and employ on the site only such technical assistants as are skilled, and experienced in their respective fields and such foremen and supervisory staff as are competent to give proper supervision to the work. The contractor shall provide and employ skilled, semi-skilled and unskilled labour as is necessary for proper and timely execution of the work. The Engineer in Charge shall be at liberty to object to and require the contractor to remove from the works any person who in his opinion misconducts himself, or is incompetent or negligent in the performance of his duties or whose employment is otherwise considered by the Engineer in Charge to be undesirable. Such person shall not be employed again at works site without the written permission of the Engineer in Charge and the persons so removed shall be replaced as soon as possible by competent substitutes. iii. The contractor shall not change his engineer/supervisory staff after approval of the Engineer In Charge. If Contractor wants to replace any of his staff due to unavoidable circumstances, he will seek permission of Engineer In Charge indicating reasons for such change, qualification and experience of the alternative employee suggested by him. The qualification and experience of the alternative staff shall not be inferior to the person employed earlier.

A violation is considered to have occurred if the Authority is fully satisfied with the available documents and evidence submitted along with Independent External Monitor's recommendations / suggestions that no reasonable doubt exist in the matter. iii. Person signing IP shall not approach the Courts while representing the matters to IEMs and he / she will await their decision in the matter.

For any other material as per actual requirements. ii. Over the theoretical quantities of materials so computed a variation shall be allowed as specified in Schedule 'F'. The difference in the net quantities of material actually issued to the contractor and the theoretical quantities including such authorised variation, if not returned by the contractor or if not fully reconciled to the satisfaction of the Engineer in Charge within fifteen days of the issue of written notice by the Engineer in Charge to this effect shall be recovered at the rates specified in Schedule 'F', without prejudice to the provision of the relevant conditions regarding return of materials governing the contract. Decision of Engineer in Charge in regard to theoretical quantities of materials, which should have been actually used as per the Annexure of the standard schedule of rates and recovery at rates specified in Schedule 'F' shall be final and binding on the contractor. For non-scheduled items, the decision of the Engineer in charge regarding theoretical quantities of materials which should have been actually used, shall be final and binding on the contractor. g. The said action under this clause is without prejudice to the right of the AAI to take action against the contractor under any other conditions of contract for not doing the work according to the prescribed specifications. h. For materials brought by the contractor for use in item of work at site, similar theoretical consumption shall be prepared and submitted to the Engineer in Charge for verification. If it is found that material consumed in the work is less than the theoretical consumption after taking into account permissible minus variation, the recovery for corresponding material shall be effected as per rates specified in schedule 'F' under Clause 42.

The Contractor shall indemnify and keep indemnified AAI against all losses and claims for injuries or damage to any persons or any property whatsoever which may arise out of or in consequence of the construction and maintenance of Works and against all claims, demands proceedings, damage costs, charges and expenses whatsoever in respect of or in relation thereto. vi. Before commencing execution of the work, the Contractor shall, without in any way limiting his obligations and responsibilities under this condition, insure at his own cost against any damage, loss or injury which may occur to any AAI property, or to any person for at least the minimum amount of Rs. 1.00 lakh with unlimited number of occurrences (including any employee of AAI) by or arising out of carrying out of the Contract. vii. The aforesaid insurance policy / policies shall provide that they shall not be cancelled till the Engineer-in-Charge has agreed to their cancellation in writing. x. The Contractor shall prove to the Engineer-in-Charge from time to time that he has taken out all the insurance policies referred to above and has paid the necessary premiums for keeping the policies alive till expiry of the Defects Liability Period. A self-certified copy of such policies is required to be submitted to the Engineer-in-charge. xi. The Contractor shall ensure that similar insurance policies are taken out by his subcontractors (if any) and shall be responsible for any claims or losses to AAI resulting from their failure to obtain adequate insurance protection in connection thereof. The contractor shall produce or cause to be produced by his subcontractor (if any) as the case may be, the relevant policy or policies and premiums receipts as and when required by the Engineer-in-Charge. A self-certified copy of such policies is required to be submitted to the Engineer-in-charge. xii. If the Contractor and /or his subcontractor (if any) shall fail to effect and keep in force the insurance referred to above or any other insurance which he/they may be required to effect under the terms of the Contract then and in any such case AAI may, without being bound to, effect and keep in force any such insurance and pay such premium or premiums as may be necessary for that purpose and from time to time deduct the amount equivalent to 150% of premium or premiums as may be by AAI from any moneys due or which may become due to the Contractor or recover the same as a debt due from the Contractor only after issuing notice to contractor in this regard. Engineering-In-Charge shall ensure that all applicable insurances shall be in force without any break as per contract requirement to avoid any losses to AAI on account of non-availability of insurance policies and/or break in insurances policies. xiii. In case contractor takes Contractor All Risk (CAR) Policy in joint name of AAI and Contractor for full tendered value along with third party liability (max of 10% of tendered value or as applicable as per Insurance Regulatory Authority of India) then there is no requirement for taking separate insurance by sub-contractors. However, workmen compensation policy is required to be taken separately by main contractor and sub-contractor for workers employed by them.

Composite Contract and responsibilities of main agency	i. The tenders have been called for composite work consisting of civil construction and other associated specialized works. The pre qualification criteria shall be applicable for each subhead of work independently. The agency meeting PQ criteria for the main work shall be considered for execution of composite work. 		execute only those specialized subheads of works for which bidder meet PQ criteria individually. ii. The main contractor shall be permitted to execute only those works (covered under one or more subhead) for which he meets all requirements of pre-qualification including financial, technical and technological requirement specified in the PQ criteria. iii. Main contractor will associate expert agencies for the execution of specialized works under various subheads for which he himself has failed to meet PQ criteria. In such case he will appoint his associate for the execution of each specialized work with the approval of the NIT approving authority. The main contractor shall intimate the names of only those agencies who fully meet the PQ criteria for each specialized work for the acceptance of the department. iv. Main contractor shall not be permitted to change their associate agencies in the course of execution of work. If change of agency is inevitable then a request shall be submitted to the engineer in charge in writing giving full justification for change of agency. The proposal should include name of the alternate agency along with his financial, technical capabilities and work experience in the appropriate field. Such change shall be allowed only after receiving approval from the competent authority.

SAFETY CODE

1. Suitable Scaffolds should be provided for workmen for all works that cannot safely be done from the ground, or from solid construction except such short period work as can be done safely from ladders. When a ladder is used, an extra mazdoor shall be engaged for holding the ladder and if the ladder is used for carrying materials as well suitable footholds and hand-hold shall be provided on the ladder and the ladder shall be given an inclination not steeper than $\frac{1}{4}$ to 1 ($\frac{1}{4}$ horizontal and 1 vertical).
2. Scaffolding of staging more than 3.6m (12ft.) above the ground or floor, swung or suspended from an overhead support or erected with stationary support shall have a guard rail properly attached or bolted, braced and otherwise secured at least 90 cm. (3ft.) high above the floor or platform of such scaffolding on staging and extending along the entire length of the outside and ends thereof with only such opening as may be necessary for the delivery of materials. Such scaffolding or staging shall be so fastened as to prevent it from swaying from the building or structure.
3. Working platforms, gangways and stairways should be so constructed that they should not sag unduly or unequally, and if the height of the platform or the gangway or the stairway is more than 3.6 m (12ft.) above ground level or floor level, they should be closely boarded, should have adequate width and should be suitably fastened as described in (2) above.
4. Every opening in the floor of a building or in a working platform shall be provided with suitable means to prevent the fall of person or materials by providing suitable fencing or railing whose minimum height shall be 90 cm.(3ft.)
5. Safe means of access shall be provided to all working platforms and other working places. Every ladder shall be securely fixed. No portable single ladder shall be over 9m. (30ft.) in length while the width between side rails in rung ladder shall in no case be less than 29 cm. (11 $\frac{1}{2}$ “) for ladder upto and including 3m. (10ft.) in length. For long ladders, this width should be increased at least $\frac{1}{4}$ ” for each additional 30cm. (1 foot) of length. Uniform step spacing of not more than 30cm shall be kept. Adequate precautions shall be taken to prevent danger from electrical equipment. No materials on any of the site or work shall be so stacked or placed as to cause danger or inconvenience to any person or the public. The contractor shall provide all necessary fencing and lights to protect the public from accident and shall be bound to bear the expenses of defence of every suit, action or other proceedings at law that may be brought by any person for injury sustained owing to neglect of the above precautions and to pay any damages and cost which may be awarded in any such suit, action or proceedings to any such person on which may, with the consent of the contractor, be paid to compensate any claim by any such person.
7. a. **Excavation and Trenching** – All trenches 1.2 m. (4ft.) or more in depth, shall at all times be supplied with at least one ladder for each 30m. (100ft.) in length or fraction thereof, Ladder shall extend from bottom of the Trench to at least 90cm (3fts) above the surface of the ground. The side of the trenches which are 1.5 m. (5 ft.) or more in depth shall be stepped back to give suitable slope or securely held by timber bracing, so as to avoid the danger of sides collapsing. The excavated material shall not be placed within 1.5 m. (5 ft.) of the edges of the trench or half of the depth of the trench whichever is more. Cutting shall be done from top to bottom. Under no circumstances, undermining or undercutting shall be done.
- b. **Safety Measures for digging bore holes:** -
 - i. If the bore well is successful, it should be safely capped to avoid caving and collapse of the bore well. The failed and the abandoned ones should be completely refilled to avoid caving and collapse;
 - ii. During drilling, Sign boards should be erected near the site with the address of the drilling contractor and the Engineer-in-charge of the work;
 - iii. Suitable fencing should be erected around the well during the drilling and after the installation of

- the rig on the point of drilling, flags shall be put 50 Mtr all around the point of drilling to avoid entry of people/animals;
- iv. After drilling the bore well, a cement platform (0.50 Mtr x 0.50 Mtr x 1.20 Mtr) 0.60 Mtr above ground level and 0.60 Mtr below ground level should be constructed around the well casing;
 - v. After the completion of the bore well, the contractor should cap the bore well properly by welding steel plate, cover the bore well with the drilled wet soil and fix thorny shrubs over the soil. This should be done even while repairing the pump;
 - vi. After the bore well is drilled the entire site should be brought to the ground level;
7. Demolition – Before any demolition work is commenced and also during the progress of the work,
 - i) All roads and open areas adjacent to the work site shall either be closed or suitably protected.
 - ii) No electric cable or apparatus which is liable to be a source of danger or a cable or apparatus used by the operator shall remain electrically charged.
 - iii) All practical steps shall be taken to prevent danger to persons employed from risk of fire or explosion or flooding. No floor, roof or other part of the building shall be so overloaded with debris or materials as to render it unsafe.
 8. All necessary personal safety equipment as considered adequate by the Engineer-in-Charge should be kept available for the use of the person employed on the site and maintained in a condition suitable for immediate use, and the contractor should take adequate steps to ensure proper use of equipment by those concerned. The following safety equipment shall invariably be provided.
 - i) Workers employed on mixing asphaltic materials, cement and lime mortars shall be provided with protective footwear and protective goggles.
 - ii) Those engaged in white washing and mixing or stacking of cement bags or any material which is injurious to the eyes shall be provided with protective goggles.
 - iii) Those engaged in welding works shall be provided with welder's protective eye-shields. iv) ~~Stone-breaker shall be provided with protective goggles and protective clothing and seated at sufficiently safe intervals.~~
 - ~~v) When workers are employed in sewers and manholes, which are in active use, the contractors shall ensure that the manhole covers are opened and ventilated at least for an hour before the workers are allowed to get into the manholes, and the manholes so opened shall be cordoned off with suitable railing and provided with warning signals or boards to prevent accident to the public. In addition, the contractor shall ensure that the following safety measures are adhered to:-~~
 - ~~a) Entry for workers into the line shall not be allowed except under supervision of the Sr. Superintendent (Engg.) or any other higher officer.~~
 - ~~b) At least 5 to 6 manholes upstream and downstream should be kept open for at least 2 to 3 hours before any man is allowed to enter into the manhole for working inside.~~
 - ~~c) Before entry, presence of toxic gases should be tested by inserting wet lead acetate paper which changes colour in the presence of such gases and gives indication of their presence.~~
 - ~~d) Presence of Oxygen should be verified by lowering a detector lamp into the manhole. In case, no Oxygen is found inside the sewer line, workers should be sent only with oxygen kit.~~
 - ~~e) Safety belt with rope should be provided to the workers. While working inside the manholes, such rope should be handled by two men standing outside to enable him to be pulled out during emergency.~~
 - ~~f) The area should be barricaded or condoned off by suitable means to avoid mishaps of any kind. Proper warning signs should be displayed for the safety of the public whenever cleaning works are undertaken during night or day.~~
 - ~~g) No smoking or open flames shall be allowed near the blocked manhole being cleaned.~~
 - ~~h) The malba obtained on account of cleaning of blocked manholes and sewer lines should be immediately removed to avoid accidents on account of slippery nature of the malba.~~
 - ~~i) Workers should not be allowed to work inside the manhole continuously. He should be given rest intermittently. The Engineer in Charge may decide the time upto which a worker may be allowed to work continuously inside the manhole.~~

- j) ~~Gas masks with Oxygen Cylinder should be kept at site for use in emergency.~~
- k) ~~Air blowers should be used for flow of fresh air through the manholes. Whenever called for, portable air blowers are recommended for ventilating the manholes. The Motors for these shall be vapour proof and of totally enclosed type. Non sparking gas engines also could be used but they should be placed at least 2 meters away from the opening and on the leeward side protected from wind so that they will not be a source of friction on any inflammable gas that might be present.~~
- l) ~~The workers engaged for cleaning the manholes / sewers should be properly trained before allowing to work in the manhole.~~
- m) ~~The workers shall be provided with Gumboots or non sparking shoes bump helmets and gloves non sparking tools safety lights and gas masks and portable air blowers (when necessary). They must be supplied with barrier cream for anointing the limbs before working inside the sewer lines.~~
- n) ~~Workmen descending a manhole shall try each ladder stop or rung carefully before putting his full weight on it to guard against insecure fastening due to corrosion of the rung fixed to manhole well.~~
- o) ~~If a man has received a physical injury, he should be brought out of the sewer immediately and adequate medical aid should be provided to him.~~
- p) ~~The extent to which these precautions are to be taken depend on individual situation but the decision of the Engineer in Charge regarding the steps to be taken in this regard in an individual case will be final.~~
- (vi) The Contractor shall not employ men and women below the age of 18 years on the work of painting with products containing lead in any form. Wherever men above the age of 18 are employed on the work of lead painting, the following precaution should be taken:-
 - a) No paint containing lead or lead products shall be used except in the form of paste or readymade paint.
 - b) Suitable face masks should be supplied for use by the workers when paint is applied in the form of spray or a surface having lead paint is dry rubbed and scrapped.
 - c) Overall shall be supplied by the contractors to the workmen and adequate facilities shall be provided to enable the working painters to wash during and on the cessation of work.
- 9. An additional clause (viii)(i) of AAI Safety Code (iv) the Contractor shall not employ women and men below the age of 18 on the work of painting with product containing lead in any form, wherever men above the age of 18 are employed on the work of lead painting, the following principles must be observed for such use:
 - i) White lead, sulphate of lead or product containing these pigments, shall not be used in painting operation except in the form of pastes or paint ready for use.
 - ii) Measures shall be taken, wherever required in order to prevent danger arising from the application of a paint in the form of spray.
 - iii) Measures shall be taken, wherever practicable, to prevent danger arising out of from dust caused by dry rubbing down and scraping.
 - iv) Adequate facilities shall be provided to enable working painters to wash during and on cessation of work.
 - v) Overall shall be worn by working painters during the whole of working period.
 - vi) Suitable arrangement shall be made to prevent clothing put off during working hours being spoiled by painting materials.
 - vii) Cases of lead poisoning and suspected lead poisoning shall be notified and shall be subsequently verified by medical man appointed by competent authority of AAI. viii) AAI may require, when necessary medical examination of workers.
 - ix) Instructions with regard to special hygienic precautions to be taken in the painting trade shall be distributed to working painters.
- 10. When the work is done near any place where there is risk of drowning, all necessary equipments should be provided and kept ready for use and all necessary steps taken for prompt rescue of any person in danger and adequate provision, should be made for prompt first aid treatment of all injuries likely to be obtained during the course of the work.

11. Use of hoisting machines and tackle including their attachments, anchorage and supports shall conform to the following standards or conditions:
 - i) (a) These shall be of good mechanical construction, sound materials and adequate strength and free from patent defects and shall be kept repaired and in good working order.
 - (b) Every rope used in hoisting or lowering materials or as a means of suspension shall be of durable quality and adequate strength, and free from patent defects.
 - ii) Every crane driver or hoisting appliance operator shall be properly qualified and no person under the age of 21 years should be in charge of any hoisting machine including any scaffolding winch or give signals to operator.
 - iii) In case of every hoisting machine and of every chain ring hook, shackle swivel and pulley block used in hoisting or as means of suspension, the safe working load shall be ascertained by adequate means. Every hoisting machine and all gear referred to above shall be plainly marked with the safe working load. In case of a hoisting machine having a variable safe working load each safe working load and the condition under which it is applicable shall be clearly indicated. No part of any machine or any gear referred to above in this paragraph shall be loaded beyond the safe working load except for the purpose of testing.
 - iv) In case of departmental machines, the safe working load shall be notified by the Electrical Engineer-in-Charge. As regards contractor's machines the contractors shall notify the safe working load of the machine to the Engineer-in-Charge whenever he brings any machinery to site of work and get it verified by the electrical Engineer concerned.
12. Motors, gearing, transmission, electric wiring and other dangerous parts of hoisting appliances should be provided with efficient safeguards. Hoisting appliances should be provided with such means as will reduce to the minimum the risk of accidental descent of the load. Adequate precautions should be taken to reduce to the minimum the risk of any part of a suspended load becoming accidentally displaced. When workers are employed on electrical installations which are already energized, insulating mats, wearing apparel, such as gloves, sleeves and boots as may be necessary should be provided. The worker should not wear any rings, watches and carry keys or other materials which are good conductors of electricity.
13. All scaffolds, ladders and other safety devices mentioned or described herein shall be maintained in safe condition and no scaffold, ladder or equipment shall be altered or removed while it is in use. Adequate washing facilities should be provided at or near places of work.
14. These safety provisions should be brought to the notice of all concerned by display on a notice board at a prominent place at work spot. The person responsible for compliance of the safety code shall be named therein by the contractor.
15. To ensure effective enforcement of the rules and regulations relating to safety precautions the arrangements made by the contractor shall be open to inspection by the Labour Officer or Engineer-in-Charge of the department or their representatives.
16. Notwithstanding the above clauses from (1) to (15), there is nothing in these to exempt the contractor from the operations of any other Act or Rules in force in the Republic of India.

**MODEL RULES FOR THE PROTECTION OF
HEALTH AND SANITARY ARRANGEMENTS FOR WORKERS
EMPLOYED BY AAI OR ITS CONTRACTORS**

1. APPLICATION

These rules shall apply to all buildings and construction works in charge of AAI in which twenty or more workers are ordinarily employed or are proposed to be employed in any day during the period during which the contract work is in progress.

2. DEFINITION

Work place means a place where twenty or more workers are ordinarily employed in connection with construction work on any day during the period during which the contract work is in progress.

3. FIRST-AID FACILITIES

(i) At every work place, there shall be provided and maintained, so as to be easily accessible during working hours, first-aid boxes at the rate of not less than one box for 150 contract labour or part thereof ordinarily employed.

(ii) The first-aid box shall be distinctly marked with a red cross on white back ground and shall contain the following equipment.

(a) For work places in which the number of contract labour employed does not exceed 50 Each first –aid box shall contain the following equipments:

1. 6 small sterilized dressings
2. 3 medium size sterilized dressings
3. 3 large size sterilized dressings
4. 3 large sterilized burn dressings
5. 1 (30 ml) bottle containing a two per cent alcoholic solution of iodine.
6. 1 (30 ml) bottle containing salvolatile having the dose and mode of administration indicated on the label.
7. 1 snakebite lancet.
8. 1 (30 gms) bottle of potassium permanganate crystals.
9. 1 pair scissors.
10. 1 copy of the first-aid leaflet issued by the Director General, Factory Advice Service and Labour Institute, Government of India.
11. 1 bottle containing 100 tablets (each of 5 gms) of aspirin.
12. Ointment for burns.
13. A bottle of suitable surgical antiseptic solution.

(b) For work places in which the number of contract labour exceed 50. Each first-aid box shall contain the following equipments.

1. 12 small sterilized dressings.

2. 6 medium size sterilized dressings.
 3. 6 large size sterilized dressings
 4. 6 large size sterilized burn dressings.
 5. 6 (15 gms) packets sterilized cotton wool.
 6. 1 (60 ml). Bottle containing two per cent alcoholic solution iodine.
 7. 1 (60 ml) bottle containing salvolatile having the dose and mode of administration indicated on the label.
 8. 1 roll of adhesive plaster.
 9. 1 snake bite lancet.
 10. 1 (30 gms) bottle of potassium permanganate crystals.
 11. 1 pair scissors.
 12. 1 copy of the first-aid leaflet issued by the Director General Factory Advice Service and Labour Institute / Government of India.
 13. A bottle containing 100 tablets (each of 5 gms) of aspirin.
 14. Ointment for burns.
 15. A bottle of suitable surgical antiseptic solution.
- (iii) Adequate arrangements shall be made for immediate recoupment of the equipment when necessary.
- (iv) Nothing except the prescribed contents shall be kept in the First-aid box.
- (v) The first-aid box shall be kept in charge of a responsible person who shall always be readily available during the working hours of the work place.
- (vi) a person in charge of the First-aid box shall be a person trained in First-aid treatment in the work places where the number of contract labour employed is 150 or more.
- (vii) In work places where the number of contract labour employed is 500 or more and hospital facilities are not available within easy distance from the works. First-aid posts shall be established and run by a trained compounder. The compounder shall be on duty and shall be available at all hours when the workers are at work.
- (viii) Where work places are situated in places which are not towns or cities, a suitable motor transport shall be kept readily available to carry injured person or person suddenly taken ill to the nearest hospital.

4. DRINKING WATER

- i) In every work place, there shall be provided and maintained at suitable places, easily accessible to labour, a sufficient supply of cold water fit for drinking.
- ii) Where drinking water is obtained from an intermittent public water supply, each work place shall be provided with storage where such drinking water shall be stored.
- iii) Every water supply or storage shall be at a distance of not less than 50 feet from any latrine drain or other source of pollution. Where water has to be drawn from an existing well

which is within such proximity of latrine, drain or any other source of pollution, the well shall be properly chlorinated before water is drawn from it for drinking. All such wells shall be entirely closed in and be provided with a trap door which shall be dust and waterproof.

- iv) A reliable pump shall be fitted to each covered well, the trap door shall be kept locked and opened only for cleaning or inspection which shall be done at least once a month.

5. WASHING FACILITIES

- i) In every work place adequate and suitable facilities for washing shall be provided and maintained for the use of contract labour employed therein.
- ii) Separate and adequate cleaning facilities shall be provided for the use of male and female workers.
- iii) Such facilities shall be conveniently accessible and shall be kept in clean and hygienic condition.

6. LATRINES AND URINALS

- i) Latrines shall be provided in every work place on the following scale namely:
 - a) Where female are employed, there shall be at least one latrine for every 25 females.
 - b) Where males are employed, there shall be at least one latrine for every 25 males.
- ii) Provided that, where the number of males or females exceeds 100, it shall be sufficient if there is one latrine for 25 males or females as the case may be upto the first 100, and one for every 50 thereafter.
- iii) Every latrine shall be under cover and so partitioned off as to secure privacy, and shall have a proper door and fastenings.
- iv) Construction of latrines: The inside walls shall be constructed of masonry or some suitable heat-resisting nonabsorbent materials and shall be cement washed inside and outside at least once a year, Latrines shall not be of a standard lower than borehole system.
- v) (a) Where workers of both sexes are employed, there shall be displayed outside each block of latrine and urinal, a notice in the language understood by the majority of the workers "For Men only" or "For Women Only" as the case may be.
(b) The notice shall also bear the figure of a man or of a woman, as the case may be.
- vi) There shall be at least one urinal for male workers upto 50 and one for female workers upto fifty employed at a time, provided that where the number of male or female workmen, as the case may be exceeds 500, it shall be sufficient if there is one urinal for every 50 males or females upto the first 500 and one for every 100 or part thereafter.
- vii) (a) The latrines and urinals shall be adequately lighted and shall be maintained in a clean and sanitary condition at all times.
(b) Latrines and urinals other than those connected with a flush sewage system shall comply with the requirements of the Public Health Authorities.
- viii) Water shall be provided by means of tap or otherwise so as to be conveniently accessible in or near the latrines and urinals.
- ix) Disposal of excreta: Unless otherwise arranged for by the local sanitary authority, arrangements for proper disposal of excreta by incineration at the work place shall be made by means of a suitable incinerator. Alternately excreta may be disposed of by putting a layer of night soil at the bottom of a pucca tank prepared for the purpose and covering it with a 15 cm. Layer of waste or refuse and then covering it with a layer of earth for a fortnight (when it will turn to manure).
- x) The contractor shall at his own expense, carry out all instructions issued to him by the

Engineer-in-Charge to effect proper disposal of night soil and other conservancy work in respect of the contractor's workmen or employees on the site. The contractor shall be responsible for payment of any charges which may be levied by Municipal or Cantonment Authority for execution of such on his behalf.

7. PROVISION OF SHELTER DURING REST

At every place there shall be provided, free of cost, four suitable sheds, two for meals and the other two for rest separately for the use of men and women labour. The height of each shelter shall not be less than 3 meters (10 ft.) from the floor level to the lowest part of the roof. These shall be kept clean and the space provided shall be on the basis of 0.6 sq.m. (6 sft) per head. Provided that the Engineer-in-Charge may permit subject to his satisfaction, a portion of the building under construction or other alternative accommodation to be used for the purpose.

8. CRECHES

- i) At every work place, at which 20 or more women workers are ordinarily employed, there shall be provided two rooms of reasonable dimensions for the use of their children under the age of six years. One room shall be used as a play room for the children and the other as their bedroom. The rooms shall be constructed with specifications as per clause 19 H (ii) a, b & c.
- ii) The rooms shall be provided with suitable and sufficient openings for light and ventilation. There shall be adequate provision of sweepers to keep the places clean.
- iii) The contractor shall supply adequate number of toys and games in the play room and sufficient number of cots and beddings in the bed room.
- iv) The contractor shall provide one ayaa to look after the children in the crèche when the number of women workers does not exceed 50 and two when the number of women workers exceed 50.
- v) The use of the rooms earmarked as crèches shall be restricted to children, their attendants and mothers of the children.

9. CANTEENS

- i) In every work place where the work regarding the employment of contractor labour is likely to continue for six months and where in contract labour numbering one hundred or more are ordinarily employed, an adequate canteen shall be provided by the contractor for the use of such contract labour.
- ii) The canteen shall be maintained by the contractor in an efficient manner.
- iii) The canteen shall consist of at least a dining hall, kitchen, storeroom, pantry and washing places separately for workers and utensils.
- iv) The canteen shall be sufficiently lighted at all times when any person has access to it.
- v) The floor shall be made of smooth and impervious materials and inside walls shall be lime washed or colour washed at least once in each year. Provided that the inside walls of the kitchen shall be lime washed every four months.
- vi) The premises of the canteen shall be maintained in a clean and sanitary condition.
- vii) Waste water shall be carried away in suitable covered drains and shall not be allowed to accumulate so as to cause a nuisance.
- viii) Suitable arrangements shall be made for the collection and disposal of garbage.
- ix) The dining hall shall accommodate at a time 30 per cent of the contract labour working at a time.
- x) The floor area of the dining hall, excluding the area occupied by the service counter and any furniture except tables and chairs shall not be less than one square metre (10 sft) per diner to be accommodated as prescribed in sub-Rule (ix).
- xi) (a) A portion of the dining hall and service counter shall be partitioned off and reserved for women workers in proportion to their number. (b) Washing places for women shall be separate and screened to secure privacy.

- xii) Sufficient tables stools, chairs or benches shall be available for the number of diners to be accommodated as prescribed in sub-Rule (ix).
- xiii) (a) 1. There shall be provided and maintained sufficient utensils crockery, furniture and any other equipment necessary for the efficient running of the canteen.
2. The furniture utensils and other equipment shall be maintained in a clean and hygienic condition.
(b) 1. Suitable clean clothes for the employees serving in the canteen shall be provided and maintained.
2. A service counter, if provided, shall have top of smooth and impervious material.
3. Suitable facilities including an adequate supply of hot water shall be provided for the cleaning of utensils and equipments.
- xiv) The food stuffs and other items to be served in the canteen shall be in conformity with the normal habits of the contract labour.
- xv) The charges for food stuffs, beverages and any other items served in the canteen shall be based on 'No Profit, No loss' and shall be conspicuously displayed in the canteen.
- xvi) In arriving at the price of foodstuffs, and other article served in the canteen, the following items shall not be taken into consideration as expenditure namely :-
 - a) The rent of land and building.
 - b) The depreciation and maintenance charges for the building and equipments provided for the canteen.
 - c) The cost of purchase, repairs and replacement of equipments including furniture, crockery, cutlery and utensils.
 - d) The water charges and other charges incurred for lighting and ventilation.
 - e) The interest and amounts spent on the provision and maintenance of equipments provided for the canteen.
- xvii) The accounts pertaining to the canteen shall be audited once every 12 months by registered accountants and auditors.

10. ANTI-MALARIAL PRECAUTIONS

The contractor shall at his own expense, conform to all anti-malarial instructions given to him by the Engineer-in-Charge including the filling up of any borrow pits which may have been dug by him.

- 11.** The above rules shall be incorporated in the contracts and in notices inviting tenders and shall form an integral part of the contracts.

12. AMENDMENTS

AAI may, from time to time, add to or amend these rules and issue directions - it may consider necessary for the purpose of removing any difficulty which may arise in the administration thereof.

AIRPORTS AUTHORITY OF INDIA

Contractor's Labour Regulations

1. SHORT TITLE

These regulations may be called the AAI Contractors Labour Regulations.

2. DEFINITIONS

(i) **Workman** means any person employed by AAI or its contractor directly or indirectly through a subcontractor with or without the knowledge of the AAI to do any skilled, semiskilled or unskilled manual, supervisory, technical or clerical work for hire or reward, whether the terms of employment are expressed or implied but does not include any person: -

- a) Who is employed mainly in a managerial or administrative capacity: or
- b) Who, being employed in a supervisory capacity draws wages exceeding five hundred rupees per mensem or exercises either by the nature of the duties attached to the office or by reason of powers vested in him, functions mainly of managerial nature: or
- c) Who is an out worker, that is to say, person to whom any article or materials are given out by or on behalf of the principal employers to be made up cleaned, washed, altered, ornamental finished, repaired adopted or otherwise processed for sale for the purpose of the trade or business of the principal employers and the process is to be carried out either in the home of the out worker or in some other premises, not being premises under the control and management of the principal employer. No person below the age of 14 years shall be employed to act as a workman.

(ii) **Fair Wages** means wages whether for time or piece work fixed and notified under the provisions of the Minimum Wages Act from time to time.

(iii) **Contractors** shall include every person who undertakes to produce a given result other than a mere supply of goods or articles of manufacture through contract labour or who supplies contract labour for any work and includes a subcontractor.

(iv) **Wages** shall have the same meaning as defined in the Payment of Wages Act.

3. i) Normally working hours of an adult employee should not exceed 9 hours a day. The working day shall be so arranged that inclusive of interval for rest, if any, it shall not spread over more than 12 hours on any day.
- ii) When an adult worker is made to work for more than 9 hours on any day or for more than 48 hours in any week, he shall be paid over time for the extra hours put in by him at double the ordinary rate of wages.
- iii) a) Every worker shall be given a weekly holiday normally on a Sunday, in accordance with the provisions of the Minimum Wages (Central) Rules 1960 as amended from time to time irrespective of whether such worker is governed by the Minimum Wages Act or not.
- b) Where the minimum wages prescribed by the Central/State Government under the Minimum Wages Act are not inclusive of the wages for the weekly day of rest, the worker shall be entitled to rest day wages at the rate applicable to the next preceding day, provided he has worked under the same contractor for a continuous period of not less than 6 days.
- c) Where a contractor is permitted by the Engineer-in-Charge to allow a worker to work on a normal weekly holiday, he shall grant a substituted holiday to him for the whole day on one of the five days immediately before or after the normal weekly holiday and pay wages to such worker for the work performed on the normal weekly holiday at overtime rate.

4. DISPLAY OF NOTICE REGARDING WAGES ETC.

The contractor shall before he commences his work on contract, display and correctly maintain and continue to display and correctly maintain in a clear and legible condition in conspicuous places on the work, notices in English and in the local Indian languages spoken by the majority of the workers giving the minimum rates of wages fixed under Minimum Wages Act, the actual wages being paid, the hours of work for which such wage are earned, wages periods, dates of payments of wages and other relevant information as per Appendix' VIII'.

5. PAYMENT OF WAGES

- (i) The contractor shall fix wage periods in respect of which wages shall be payable.
- (ii) No wage period shall exceed one month.
- (iii) The wages of every person employed as contract labour in an establishment or by a contractor where less than one thousand such persons are employed shall be paid before the expiry of seventh day and in other cases before the expiry of tenth day after the last day of the wage period in respect of which the wages are payable.
- (iv) Where the employment of any worker is terminated by or on behalf of the contractor the wages earned by him shall be paid before the expiry of the second working day from the date on which his employment is terminated.
- (v) All payment of wages shall be made on a working day at the work premises and during the working time and on a date notified in advance and in case the work is completed before the expiry of the wage period, final payment shall be made within 48 hours of the last working day.
- (vi) Wages due to every worker shall be paid to him direct or to other person authorised by him in this behalf.
- (vii) All wages shall be paid in current coin or currency or in both.
- (viii) Wages shall be paid without any deductions of any kind except those specified by the Central Government by general or special order in this behalf or permissible under the Payment of Wages Act 1956.
- (ix) A notice showing the wages period and the place and time of disbursement of wages shall be displayed at the place of work and a copy sent by the contractor to the Engineer-in-Charge under acknowledgement.
- (x) It shall be the duty of the contractor to ensure the disbursement of wages in the presence of the Senior Superintendent Engg or authorised representative of the Engineer-in-Charge who will be required to be present at the place and time of disbursement of wages by the contractor to workmen.
- (xi) The contractor shall obtain from Engineer in charge or the authorised representative of the Engineer-in-Charge a certificate under his signature at the end of the entries in the "Register of Wages" or the "Wage-cum-Muster Roll" as the case may be in the following form:
 "Certified that the amount shown in column No. has been paid to the workman concerned in my presence onat....."

Note: In case of payment of wages paid through bank, the contractor shall submit a copy of bank statement for relevant period duly signed by him.

6. FINES AND DEDUCTIONS WHICH MAY BE MADE FROM WAGES

- (i) The wages of a worker shall be paid to him without any deduction of any kind except the following:
 - a) Fines
 - b) Deductions for absence from duty i.e. from the place or the places where by the terms of his employment he is required to work. The amount of deduction shall be in proportion to the period for which he was absent.
 - c) Deduction for damage to or loss of goods expressly entrusted to the employed person for custody, or for loss of money or any other deduction which he is required to account, where such damage or loss is directly attributable to his neglect or default.
 - d) Deduction for recovery of advances or for adjustment of overpayment of wages, advances granted shall be entered in a register.
 - e) Any other deduction which the Central Government may from time to time allow.
- (ii) No fines should be imposed on any worker save in respect of such acts and omissions on his part as have been approved of by the Chief Labour Commissioner.
Note: An approved list of Acts and Omissions for which fines can be imposed is enclosed at Appendix-XII.

- (iii) No fine shall be imposed on a worker and no deduction for damage or loss shall be made from his wages until the worker has been given an opportunity of showing cause against such fines or deductions.
- (iv) The total amount of fine which may be imposed in any one wage period on a worker shall not exceed an amount equal to three paise in a rupee of the total wages, payable to him in respect of that wage period.
- (v) No fine imposed on any worker shall be recovered from him by installment, or after the expiry of sixty days from the date on which it was imposed.
- (vi) Every fine shall be deemed to have been imposed on the day of the act or omission in respect of which it was imposed.

7. LABOUR RECORDS

- (i) The contractor shall maintain a Register of persons employed on work on contract in Form XIII of the CL(R&A) Central Rules 1971 (Appendix VI)
- (ii) The contractor shall maintain a Muster Roll register in respect of all workmen employed by him on the work under Contract in Form XVI of the CL (R&A) Rules 1971 (Appendix VII).
- (iii) The contractor shall maintain a Wage Register in respect of all workmen employed by him on the work under contract in Form XVII of the CL (R&A) Rules 1971 (Appendix VIII)
- (iv) **Register of accident** - The contractor shall maintain a register of accidents in such form as may be convenient at the work place but the same shall include the following particulars :
 - (a) Full particulars of the labourers who met with accident.
 - (b) Rate of Wages
 - (c) Sex
 - (d) Age
 - (e) Nature of accident and cause of accident
 - (f) Time and date of accident
 - (g) Date and time when admitted in Hospital
 - (h) Date of discharge from the Hospital
 - (i) Period of treatment and result of treatment
 - (j) Percentage of loss of earning capacity and disability as assessed by Medical officer
 - (k) Claim required to be paid under Workmen's Compensation Act.
 - (l) Date of payment of compensation
 - (m) Amount paid with details of the person to whom the same was paid
 - (n) Authority by whom the compensation was assessed.
 - (o) Remarks
- (v) The contractor shall maintain a **Register of Fines** in the Form XII of the CL(R&A) Rules 1971 (Appendix-XIII).
The contractor shall display in a good condition and in a conspicuous place of work the approved list of acts and omissions for which fines can be imposed (Appendix-XII)
- (vi) The contractor shall maintain a **Register of deductions for damage or loss** in Form XX of the CL (R&A) Rules 1971 (Appendix-XIV)
- (vii) The contractor shall maintain a **Register of Advances** in Form XXIII of the CL (R&A) Rules 1971 (Appendix-XV)
- (viii) The contractor shall maintain a **Register of Overtime** in Form XXIII of the CL (R&A) Rules 1971 (Appendix-XVI).

8. ATTENDANCE CARD-CUM-WAGE SLIP

- (i) The contractor shall issue an **Attendance card-cum-wage** slip to each workman employed by him in the specimen form at (Appendix-IX)
- (ii) The card shall be valid for each wage period.
- (iii) The contractor shall mark the attendance of each workman on the card twice each day, once at the commencement of the day and again after the rest interval, before he actually starts work.
- (iv) The card shall remain in possession of the worker during the wage period under reference.

- (v) The contractor shall complete the wage slip portion on the reverse of the card at least a day prior to the disbursement of wages in respect of the wage period under reference.
- (vi) The contractor shall obtain the signature or thumb impression of the worker on the wage slip at the time of disbursement of wages and retain the card with himself.

9. EMPLOYMENT CARD

The contractor shall issue an **Employment Card** in Form XIV of the CL (R&A) Central Rules 1971 to each worker within three days of the employment of the worker (Appendix-X).

10. SERVICE CERTIFICATE

On termination of employment for any reason whatsoever the contractor shall issue to the workman whose services have been terminated, a **Service certificate** in Form XV of the CL(R&A) Central Rules 1971.

11. PRESERVATION OF LABOUR RECORDS

All records required to be maintained under Regulations Nos. 6 & 7 shall be preserved in original for a period of three years from the date of last entries made in them and shall be made available for inspection by the Engineer-in-Charge or Labour Officer or any other officers authorised by the Ministry of Urban Development in this behalf.

12. POWER OF LABOUR OFFICER TO MAKE INVESTIGATIONS OR ENQUIRY

The Labour Officer or any person authorised by Central Government on their behalf shall have power to make enquiries with a view to ascertaining and enforcing due and proper observance of Fair Wage Clauses and the Provisions of these Regulations. He shall investigate into any complaint regarding the default made by the contractor or subcontractor in regard to such provision.

13. REPORT OF LABOUR OFFICER

The Labour Officer or other persons authorised as aforesaid shall submit a report of result of his investigation or enquiry to the Engineer-in-Charge concerned indicating the extent, if any, to which the default has been committed with a note that necessary deductions from the contractor's bill be made and the wages and other dues be paid to the labourers concerned. In case an appeal is made by the contractor under Clause 13 of these regulations, actual payment to labourers will be made by the Engineer-in-Charge after G.M. Engg. has given his decision on such appeal.

(i) Engineer-in-Charge shall arrange payments to the labour concerned within 45 days from the receipt of the report from the Labour Officer or the G.M. Engineer as the case may be.

14. APPEAL AGAINST THE DECISION OF LABOUR OFFICER

Any person aggrieved by the decision and recommendations of the Labour Officer or other person so authorised may appeal against such decision to the Engineer-in-Charge concerned within 30 days from the date of decision, but subject to such appeal, the decision of the officer shall be final and binding upon the contractor.

15. PROHIBITION REGARDING REPRESENTATION THROUGH LAWYER

- (i) A workman shall be entitled to be represented in any investigation or enquiry under these regulations by :
 - a) An officer of a registered trade union of which he is a member.
 - b) An officer of a federation of trade unions to which the trade union referred to in Clause (a) is affiliated.

- c) Where the employer is not a member of any registered trade union, by an officer of a registered trade union, connected with the industry in which the worker is employed or by any other workman employed in the industry in which the worker is employed.
- (ii) An employer shall be entitled to be represented in any investigation or enquiry under these regulations by :
 - a) An officer of an association of employers of which he is a member.
 - b) An officer of a federation of associations of employers to which association referred to in Clause (a) is affiliated.
 - c) Where the employers is not a member of any association of employers, by an officer of association of employer connected with the industry in which the employer is engaged or by any other employer, engaged in the industry in which the employer is engaged.
- (iii) No party shall be entitled to be represented by a legal practitioner in any investigation or enquiry under these regulations.

16. INSPECTION OF BOOKS AND SLIPS

The contractor shall allow inspection of all the prescribed labour records to any of his workers or to his agent at a convenient time and place after due notice is received or to the Labour Officer or any other person, authorised by the Central Government on his behalf .

17. SUBMISSION OF RETURNS

The contractor shall submit periodical returns as may be specified from time to time.

18. AMENDMENTS

The Central Government/AAI may from time to time add to or amend the regulations and on any question as to the application/interpretation or effect of those regulations the decision of the General Manager (Engg.) concerned shall be final.

In consideration of the Airport Authority of India having its head office at New Delhi [hereinafter called the “AAI” which expression shall unless repugnant to the subject or context include its administrator, successors and assigns) having agreed under the terms and condition of Contract Agreement No.dated made between.....and AAI in connection with the work of..... (hereinafter called the said contract) to accept Deed of Guarantee as herein provided for Rs.....(Rupees.....only) from a Nationalized Bank in lieu of the Security deposit to be made by the contractor or lieu of the amount withheld towards compensation for delay pending final extension of time to be made from the contractors contained in the said Contractor. We, the.....bank (hereinafter referred to as “the said Bank” and having our registered office at.....do hereby undertake and agree to identify and keep indemnified AAI from time to time to the extent of Rs..... (Rupees..... only) against any loss or damage, cost,, charges and expenses caused to or suffered by or that may be caused to or suffered by AAI by reason of any breach or breaches by the said Contractor of any of the terms and condition contained in the said contract and to unconditionally pay the amount claimed by AAI on demand and without demur to the extent aforesaid.
2. We..... Bank, further agree that AAI shall be the sole judge of and as to whether the said Contractor has committed any breach or breaches of any of the terms and conditions of the said contract and the extent of loss, damage, costs, charges and expenses caused to or suffered by or that may be caused to or suffered by AAI on account thereof and the decision of AAI that the said Contractor has committed such breach and breaches and as to the amount or amounts of loss, damage, costs, charges and expenses caused to or suffered of that may be caused to or suffered by AAI from time to time shall be final and binding on us.
3. We, the said Bank, further agree that the Guarantee herein contained shall remain in full force and effect during the period that would be taken for the performance of the said contracts and till all the dues of AAI under the said contract or by virtue of any of the terms and conditions governing the said contract including compensation for delay if any as decided by AAI, have been fully paid and its claims satisfied or discharged and till the Accepting Authority of the contract certifies that the terms and condition and accordingly Contract have been fully and properly carried out by the said contractor and accordingly discharges this guarantee subject, however that AAI shall have no claim under this Guarantee after 90(Ninety) days from the date of expiry of the defects Liabilities periods or Final /Extension of Time grated by AAI as provided available in agreements clause no.....as provided in the said Contract, i.e.....(date) or from the date of cancellation of the said contract, as the case may be, unless a notice of the claim under this Guarantee has been served on the Bank before the expiry of the period in which case the same shall be enforceable against the Bank notwithstanding the fact, that the same is enforced after the expiry of the said period.

4. AAI shall have the fullest liberty without affecting in any way the liability of the bank under this Guarantee or Indemnity from time to time to vary any of the terms and conditions of the said contract or to extend time of performance by the said Contractor or to postpone for any time and from time to time any of the powers exercisable by it against the said Contractor and either to enforce or forbear from enforcing any of terms and conditions governing the said contract or securities available to AAI and the said Bank shall not be released from its liability under these present by any exercise by AAI of any liberty with reference to the matters aforesaid or by reason of time being given to the said contractor or any other forbearance, act or omission on the part by AAI or any indulgence by AAI to the said Contractor or any other matter or thing whatsoever which under the law relating to sureties would but for this provision have the effect of so releasing the Bank from its such liability.
5. It shall not be necessary for AAI to proceed against the contractor before proceeding against the Bank and the Guarantee herein contained shall be enforceable against the Bank, notwithstanding any security which AAI may have obtained or obtain from the Contractor at the time when proceedings are taken against the Bank hereunder be outstanding or unrealized.

AND WHEREAS the Bidder is submitting a tender to the Authority for In response to the NIT (Notice Inviting Tender) dated Contractor is signing the contract for execution ofNOW, therefore, To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to Enabling the Authority to obtain the desired said stores/equipment/execution of works at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and Enabling Authority to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the Authority will commit to prevent corruption, in any form, by its officials by following transparent procedures. The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

1. Commitments of the Authority;

- 1.1 The Authority undertakes that no official of the Authority, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.

- 1.3 All the officials of the Authority will report to the appropriate authority office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.
- 1.4 In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the Authority with full and verifiable facts and the same is prima facie found to be correct by the Authority, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the Authority and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the Authority the proceedings under the contract would not be stalled.

- 21 The Bidder/Contractor will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- 22 The Bidder/Contractor further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Authority for showing or

forbearing to show favour or dis favour to any person in relation to the contract or any other contract with the Authority.

- 23 The Bidder / Contactor has not entered and will not enter with other bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specification, certifications, subsidiary contracts, submission or non-submission of bids or any actions to restrict competitiveness or to introduce cartelization in the bidding process.
- 24 The Bidder/Contractor shall, when presenting his bid, disclose the name and address of agents and representatives and Indian BIDDERS shall disclose their foreign principals or associates.
- 25 The Bidder/Contactor shall when presenting his bid disclose any and all the payments he has made or, is committed to or intends to make to agents/brokers or any other intermediary, in connection with this bid/contract.
- 26 The Bidder/Contractor further confirms and declares to the Authority that the BIDDER is the original manufacturer/integrator/ authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the Authority or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.
- 27 The Bidder/Contractor, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made or has committed to or intends to make to officials of the Authority or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- 28 The Bidder/Contractor will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- 29 The Bidder/Contractor will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.
- 210 The Bidder / Contactor shall not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the Authority as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The Bidder / Contractor also undertakes to exercise due and adequate care lest any such information is divulged.
- 211 The Bidder/Contractor will inform to the Independent External Monitor.
 - i) If he receives demand for an illegal/undue payment / benefit.

- ii) If he comes to know of any unethical or illegal payment/benefit.
- iii) If he makes any payment to any Authority's associate(s)
- 2.12 The Bidder/Contactor commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- 2.13 The Bidder/Contactor shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.
- 2.14 If the Bidder/Contractor or any employee of the Bidder/Contractor or any person acting on behalf of the Bidder/ Contractor, either directly or indirectly, is a relative of any of the officers of the Authority, or alternatively, if any relative of an officer of the Authority has financial interest/stake in the Bidder's/Contractor's firm, the same shall be disclosed by the Bidder/Contractor at the time filing of tender. The term 'relative' for this purpose would be as defined in Section 6 of the Companies Act 1956.
- 2.15 The Bidder/Contractor shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the Authority.
- 2.16 That if the Bidder/ Contractor, during tender process or before the award of the contract or during execution of the contract/work has committed a transgression in violation of section 2 or in any other form such as to put his reliability or credibility as Bidder/Contractor into question, the Authority is entitled to disqualify him from the tender process or to terminate the contract for such reason and to debar the BIDDER from participating in future bidding processes.

3. Previous Transgression

- 3.1 The Bidder/Contractor declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India that could justify Bidders's exclusion from the tender process.
- 3.2 The Bidder/Contractor agrees that if it makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason and he may be considered for debarment for future tender/contract processes.
- 3.3 That the Bidder/Contractor undertakes to get this Pact signed by the subcontractor (s) and associate(s) whose value of the work contribution exceeds Rs 0.5 Cr. (Rupees zero point five Cr.) and to submit the same to the Authority along-with the tender document/ contract before contract signing.
- 3.4. That sub-contractor(s)/ associate(s) engaged by the Contractor, with the approval of the Authority after signing of the contract, and whose value of the work contribution exceeds Rs 0.5 Cr. (Rupees Zero point five Cr.) will be required to

sign this Pact by the Contractor, and the same will be submitted to the Authority before doing/ performing any act/ function by such subcontractor(s) / associate(s) in relation to the contract/ work.

3.5 That the Authority will disqualify from the tender process all Bidder(s) who don't sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority

3.6 That if the Contractor(s) does/ do not sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority. Authority will terminate the contract and initiate appropriate action against such Contractor(s).

4. Earnest Money, Security Deposit, Bank Guarantee, Draft, Pay order or any other mode and its validity i/c Warranty Period, Performance Guarantee/Bond.

While submitting bid, the BIDDER shall deposit an EMD / SD / BG / DRAFT / PAY ORDER ETC I/C WARRANTY PERIOD, PG/BOND, VALIDITY etc., which is as per terms and conditions and details given in NIT / tender documents sold to the Bidders.

5. Sanctions for Violations/Disqualification from tender process and exclusion from future Contacts.

5.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the Authority to take all or any one of the following actions, wherever required:

- i) To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- ii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- iii) If the Authority has disqualified / debarred the Bidder from the tender process prior to the award under section 2 or 3 or 4, the Authority is entitled to forfeit the earnest money deposited/bid security.
- iv) To recover all sums already paid by the Authority, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the Authority in connection with any other contract or any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.

- v) To en-cash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.
- vi) To cancel all or any other Contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the Authority resulting from such cancellation/rescission and the Authority shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- vii) To debar the BIDDER from participating in future bidding processes for a minimum period of three years, which may be further extended at the discretion of the Authority.
- viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- ix) In case where irrevocable Letters of Credit have been received in respect of any contract signed by the Authority with the BIDDER, the same shall not be opened.
- x) Forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- xi) That if the Authority have terminated the contract under section 2 or 3 or 4 or if the Authority is entitled to terminate the contract under section 2 or 3 or 4, the Authority shall be entitled to demand and recover from the contractor damages equivalent to 5% of the contract value or the amount equivalent to security deposit or performance bank guarantee, whichever is higher.
- xii) That the Bidder / Contractor agrees and undertakes to pay the said amount without protest or demur subject only to condition that if the Bidder/Contractor can prove and establish to the satisfaction of the Authority that the disqualification / debarment of the bidder from the tender process or the termination of the contract after award of the contract has caused no damage to the Authority.

5.2 The Authority will be entitled to take all or any of the actions mentioned at para 5.1 above.

5.3 (i) to (xii) of this Pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.

- 5.4 That if the Bidder/Contractor applies to the Authority for premature revocation of the debarment and proves to the satisfaction of the Authority that he has installed a suitable and effective corruption prevention system and also restored/recouped the damage, if any, caused by him, the Authority may, if thinks fit, revoke the debarment prematurely considering the facts and circumstances of the case, and the documents/evidence adduced by the Bidder/Contractor for first time default.
- 5.5 That a transgression is considered to have occurred if the Authority is fully satisfied with the available documents and evidence submitted along with Independent External Monitor's recommendations/suggestions that no reasonable doubt is possible in the matter.
- 5.6 The decision of the Authority to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent External Monitor(s) appointed for the purpose of this Pact.
6. Allegations against Bidders/Contractors/ Sub-Contractors/ Associates:
That if the Authority receives any information of conduct of a Bidder/ Contractor or Sub- Contractor or of an employee or a representative or an associate of the Bidder, Contractor or Sub- Contractor which constitute corruption, or if the Authority has substantive suspicion in this regard, the Authority will inform the Vigilance Department for appropriate action.
7. **Independent External Monitor(s),**
 - 7.1. That the Authority has appointed competent and credible Independent External Monitor(s) for this Pact.
 - 7.2 The task of the Monitor(s) is to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact. He will also enquire into any complaint alleging transgression of any provision of this Pact made by the Bidder, Contractor or Authority.
 - 7.3. That the Monitor(s) is not subject to any instructions by the representatives of the parties and would perform his functions neutrally and independently. He will report to the Chairperson of the Board of the Authority.
 - 7.4 That the Bidder / Contractor accepts that the Monitor(s) has the right to access without restriction to all project documentation of the Authority including that provided by the Bidder/Contractor. The Bidder/Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation including minutes of meeting. The same is applicable to Sub - Contractors and Associates. The Monitor is under obligation to treat the information and documents of the Authority and Bidder/ Contractor / Sub- Contractors/ Associates with confidentiality.
 - 7.5. That as soon as the Monitor notices, or believes to notice, a violation of this Pact, he will so inform the management of the Authority and request the management

to discontinue or heal the violation, or to take other relevant action. The Monitor(s) can in this regard submit his recommendations/ suggestions. Beyond this, the Monitor(s) has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.

- 7.6 That the Authority will provide to the Monitor(s) sufficient information about all meetings among the parties related to the project provided such meetings could have an impact on the contractual relations between the Authority and the Contractor / Bidder. The parties offer to the Monitor(s) the option to participate in such meetings.
- 7.7 That the Monitor(s) will submit a written report to the Chairperson of the Board of the Authority within 2 weeks from the date of reference or intimation to him by the Authority and, should the occasion arise, submit proposals for correcting problematic situations.
- 7.8 That if the Monitor(s) has reported to the Chairperson of the Board a substantiated suspicion of an offence under relevant Anti- Corruption Laws of India and the Chairperson has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Vigilance Department, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India.
- 7.9 The word 'Monitor' would include singular and plural.

8. Facilitation of Investigation.

In case of any allegation of violation of any provisions of this Pact or payment of commission, the Authority or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of such Examination.

9. Law and Place of Jurisdiction.

That this Pact is subject to provisions under Indian Law. The place of performance and jurisdiction is the Corporate Headquarter /the Regional Headquarter / office of the Authority, as applicable.

10. Other Legal Actions

- 10.1 That the changes and supplements as well as termination notice need to be made in writing.
- 10.2 That if the Bidder / Contractor are a partnership or a consortium, this Pact must be signed by all the partners and consortium members or their authorized representatives.

11. Pact duration (Validity)

- 11.1 That this Pact comes into force when both the parties have signed it. It expires for the Contractor 12 months after the final payment under the respective contract, and for all other Bidders 3 months after the contract is awarded.
- 11.2. That if any claim is made / lodged during this period, the same shall be binding and continue to be valid despite the lapse of this Pact as specified herein before, unless it is discharged/determined by Chairman of the Authority.
- 11.3 That should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.

12. Company Code of Conduct

Bidders are also advised to have a company code of conduct (clearly rejecting the use of bribes and other unethical behavior) and a compliance program for the implementation of the code of conduct throughout the company.

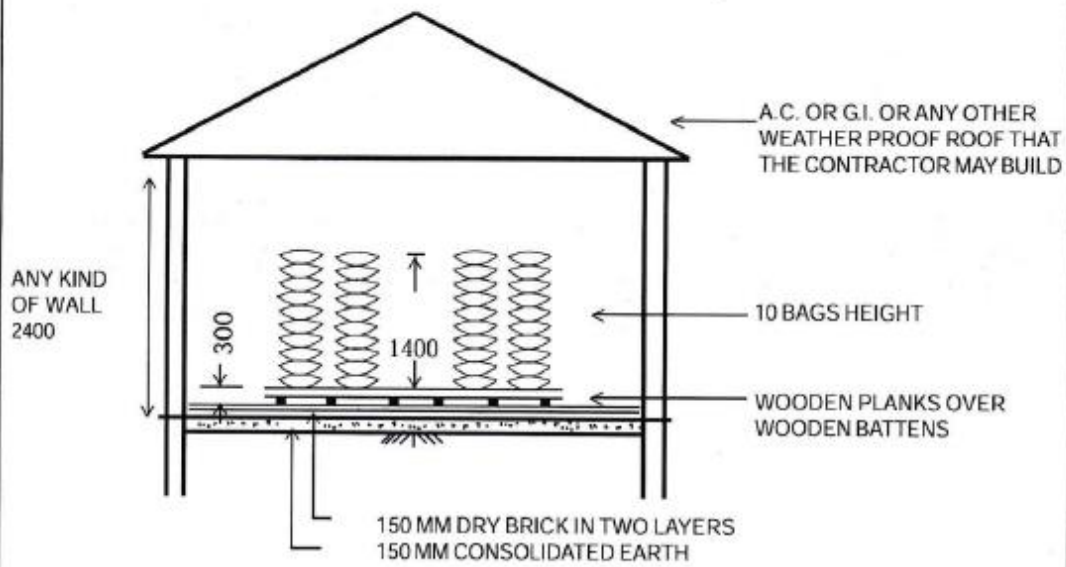

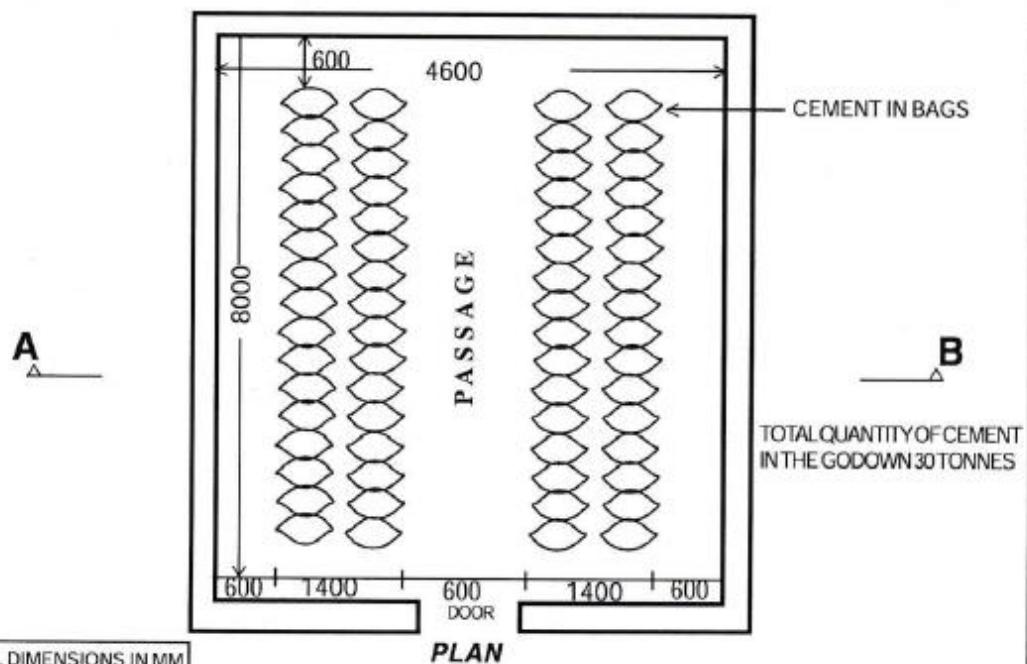

SPECIAL CONDITION **OF CONTRACT**

**SPECIAL CONDITION OF CONTRACT FOR GENERAL MAINTENANCE WORKS UNDER
ANNUAL MAINTENANCE CONTRACTS OF ELECTRICAL AND MECHANICAL
INSTALLATIONS.**

These special conditions of contract shall be read in conjunction with Airports Authority of India, General conditions of contract, if there are any provisions in the special conditions of contract which are at variance with the provisions of general conditions of contract, the provision in these special conditions shall take precedence.

1. **General Scope of Work:-** The Scope of work covers the following items:-
 - a) Providing operational & maintenance services of various E&M Installations, Conveyor, Air-Conditioners, Water Coolers / Purifiers, Fire alarm and firefighting installations etc.
 - b) Providing day to day maintenance services, general cleaning of various Installations as per maintenance schedule specified.
 - c) Specialised Miscellaneous works
 - d) Works as per CPWD schedule.

Note: Items of SH-II, SH-III, SH-IV & SH-V are to be executed on parts as per the instruction Engineer in Charge as and when basis.

2. **Period of Contract:-** The service contract shall be for a period of 24 (Twenty) months from the date of handing over the site. The contract period can be extended for further period of 06 months on the same terms and conditions of the agreement. AAI reserves the right to terminate the contract fully or partially by giving 30 days' notice in writing to the contractor. If in the opinion of the Engineer-in-Charge, it is observed that the contractor is not doing the works satisfactorily as per the terms and conditions of contract, then the contract can be terminated with immediate effect without giving any reasons thereof.
3. **Entry Pass:-** The work site lies in restricted area. The contractor shall apply in writing in advance for issue of necessary entry passes of workmen engaged by him. The office/ airport premises in an essential service covered under the maintenance of essential service Act and hence disruption of services rendered will be a statutory offence. The necessary police verification etc. as required for entry passes will be responsibility of the contractor. All expenditure towards arranging security passes shall be borne by the Agency.
4. **Security:-** The contractor and his employees shall abide by security regulation framed by AAI/BCAS or Police Authorities. Any worker of the contractor, whose presence is found undesirable in AAI premises, shall not be allowed to work. The contractor shall be fully responsible for the satisfactorily working of his staff.

“If Contractor or his authorized representative or his employed workers are found violating any of security regulations, suitable action be taken by AAI as per prevailing rules”.

All men and vehicles shall be permitted to enter the restricted / office area only on possession of the security passes. The contractor shall apply in writing in advance before commencement of work for issue of security passes and shall submit a list of personnel concerned with their addresses. The contractor shall ensure that his men are deployed only in those area where the security passes issued is valid for. Passes shall be deposited back with Engineer-In-Charge on demand and in any case immediately after completion of work. The contractor or his staff/ workmen shall observe all the rules promulgated from time to time by the concerned authorities. Any person found violating the security rules laid down by the authority will expelled from the area without assigning any reason whatsoever and contractor shall have no claim on this account.

5. **Statutory & Regulatory Clauses:-**

The contractor has to discharge all the obligations as provided under various statutory enactment including the EPF/ESI/ Contract Labour (Regulation and abolition)/ Minimum Wages / Payment of Wages/ Payment of Bonus / Payment of Gratuity / Workmen's compensation / Works Contract and other relevant Acts, Rules and Regulations in force and as amended from time to time in the State, as applicable.

The engagement and employment of workers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be violation of this contract. AAI may ask the contractor to produce documents to verify that these provisions / laws are complied by the contractor.

The contractor has to follow the local security / safety rules & regulations and such instructions on restricted hours of work as may be imposed on him by the department / local authorities, while working in security restricted zones and no claim whatsoever on account of this, will be entertained.

The contractor has to deploy their staff to run the system on all days (365 days) including Sundays and Gazetted holidays in shift as per BOQ for which nothing extra shall be paid.

Contractor has to submit the details of staff such as, qualification documents and experience letters of the staff, the CV and passport size coloured photograph along with copy of police verification (not older than six months on the date of start of work) before engaging them on work. All the documents should be self-attested by each worker and signed and stamped by contractor/ agency. The decision of Engineer-In-Charge, to accept or reject any candidate on the basis of lack of experience, qualification, lack of skills required for job, will be final and binding on the Agency.

6. **Uniform:-** The contractor / agency has to provide **every year** during the currency of the contract, 02 sets of uniform (Pant and Shirt complete set), 1 Pair of shoes & 03 Pair of socks and a sweater (for winter stations only) to his staff of approved colour (colour & quality of uniform to be get approved from EIC prior finalizing uniform distribution) during the contract period. Uniform sets to be provided to staff within one month from the date of award of work, failing which, AAI recover an amount of **Rs.200/- per person per week** till the compliance of the same from the contractor's running / final bill. In the event of non-compliance of wearing uniform & shoes by workers on daily basis a recovery of **Rs.50/- per day** per person shall be made from running bills. The workers should wear a badge on the left pocket of the shirt mentioning company's name. On 2nd year, Uniform set will be disbursed within one month of start of 2nd year.
7. No accommodation shall be arranged by the AAI for the staff / workers of the contractor. It is the responsibility of contractor to make his own arrangements for the facilities.
8. **Rates:-** The prices quoted shall be inclusive of all taxes but excluding GST & **exclusive of PF/ESI & Bonus. PF and ESI amount paid to the statutory authorities by the contractor shall reimbursed on actual basis throughout the contract period on submission of the documentary evidence in next bill or after the final bill.**

Bonus amount as per latest Govt. rules or 8.33% of annual salary whichever is higher will be paid to the deployed manpower by the contractor and the same shall be reimbursed on actual basis throughout the contract period on submission of the documentary evidence in next bill or after the final bill. In case of non payment of bonus, recovery / withheld shall be made @17% of annual salary from RA Bill / Final bill shall be made as decided by EIC and appropriate action will be initiated by AAI against the contractor. The decision of EIC is the regard will be final binding on the Agency.

9. **PF & ESIC Contribution:-**

- (i) The contractor shall register himself with Labour Licensing Authority and obtain Labour License Number in this regard.
- (ii) The contractor shall have to register with PF & ESIC (where ever applicable) for workmen engaged for the work & challans / deposit receipts of PF & ESI contribution shall be submitted in AAI office for verification/ reimbursement, at the time of submission of bill.
- (iii) **The PF dues (including EDLI and administrative charges) in respect of workers engaged by the contractor for AAI works to be deposited by the contractor every month by a challan and the documentary evidence in support of such payments along with employee wise details of the PF contribution (both Employee's share and the employer's contribution) needs to be submitted to the Engineer in charge for the work/ contract.**
- (iv) **ESI (wherever applicable) & EPF amount (contractor's contribution & administrative charges) paid to the statutory authorities by the contractor shall be reimbursed on actual basis on submission of documentary evidence.**
- (v) **If ESI not applicable, the agency shall provide minimum Rs. 2.0 Lacs Medclaim policy (per annum) to each staff engaged at the site including their dependent family members [Dependent Family members to be considered as per The Employees' State Insurance (Central) Rules, 1950 with latest amendments]. Premium in respect of Medclaim policy shall be reimbursed to the agency on submission of documentary evidence. Medclaim policy to be taken within 10 days after start of work.**
- (vi) **The contractor has to deposit PF & ESI / Medclaim as applicable, failing which recovery/ withheld @ 26% and 6% against PF and ESI (Medclaim) respectively from their RA bills / Final bill shall be made.**

10. **Labour Wages & Labour details:-**

- (i) The contractor has to pay the prevailing minimum wages issued by the office of Regional Labour Commissioner / Chief Labour Commissioner (whichever is higher), from time to time. However, the difference in minimum wages based on actual payment made to the labour and wages applicable at the time of submission of tender will be reimbursed including difference in EPF and ESI payment to the contractor on revision of minimum wages and no additional amount such as contractor's overhead and profit will be paid on this account.

Presently the Labour rates are as follows;

i. Highly Skilled	:	Rs. 918/-
ii. Skilled	:	Rs. 781/-
iii. Semi-Skilled	:	Rs. 650/-
iv. Un-Skilled	:	Rs. 556/-

In this regard the successful bidder shall submit an affidavit on non-judicial stamp paper of Rs.100/- as per Annexure before award of the work.

- (ii) For the purpose of admitting the claim for reimbursement of statutory increase in wages paid by him, the contractor has to produce the required documentary evidence to the satisfaction of Engineer-in-Charge.

- (iii) The payment to the workmen's engaged by the contractor is to be paid through NEFT/ RTGS on or before 7th of every month irrespective of Saturday, Sunday and bank holidays. **If any violation with respect to payment of wages for any two months in contract period, necessary action for cancellation of contract, debarring of the agency for participating in future contracts in AAI shall be initiated. The agency will not be allowed to participate in any of the tendering process in AAI till finalization of the decision. Also, the non-paid wages will be paid directly or through some other contract to the staff and the amount will be deducted from contractor's outstanding amount / SD amount.**

The deputed workmen should have experience of working in confined & secured areas like operational area of Airports.

The presently deputed workmen have experience and knowledge of working in operational area of cooch Behar Airport. Also, the existing workmen acquainted about all installations and their operation. Hence, the same workmen will be continued for the work. In case of any replacement of workmen, strictly the same will be made after getting written approval from Engineer In-charge of the work. Additional Manpower will be deployed after getting written approval from Engineer In-charge of the work.

Minimum Labour Deployment details provided in Point no.22 of Particular Specifications.

11. During the contract period if any new installations are added / replaced or modified the existing ones in these areas, which do not warrant any additional manpower, the maintenance services for these installations are also to be provided by the contractor without any extra cost.
12. **Qualification & Wages of Staff:-**The contractor should depute the persons as per the qualification given below for maintenance works. Each shift should be covered with highly skilled, skilled, Semi-skilled, Unskilled persons as required as per BOQ.
 - (i) **Highly skilled manpower (Site Engineer / Sr. Supervisor)** – shall be Diploma holders with 04 years' experience (Preferable) or Graduate engineer with min. 02 years of similar experience for overall supervision and administration of the contract and **shall be paid extra allowance of Rs.4000/- per month in addition to the minimum wages.**
 - (ii) **Highly skilled manpower (Supervisor)** – shall be Diploma holders with 02 years' experience / Graduate with 01 year experience (Preferable) or ITI Holder in Electrician / Wireman / Refrigeration / Fitter trade with 10 years' experience for supervision of manpower & works and **shall be paid extra allowance of Rs.2000/- per month in addition to the minimum wages.**
 - (iii) **Skilled manpower** – shall be I.T.I holder in Electrician / Wireman / Fitter with minimum 01 year experience in similar works or wireman trade license with minimum 02 year experience in similar works / field and shall be paid as per minimum wages.
 - (iv) **Unskilled manpower** - shall be min. VIIIth Class pass with good physique and shall have basic knowledge of similar electrical works and shall be paid as per minimum wages.

However, EIC reserve the rights to relax above mentioned educational requirement and experience criteria for any specialized skilled person suitable to site requirements & availability at that area.

13. In case of absence of staff from duty recovery will made by the department at the following rates, which shall be binding on the contractor.

But apart from daily wages, an amount of Rs.100/- will be recovered from the agency per person per shift for absenteeism of any worker as a penalty.

The EIC has full rights to instruct the agency of expel/ replace the person with the regular habit of taking unauthorized leaves frequently or continuously absent without proper justification or on the performance grading or on the behavioral ground which may impact the morale of co-workers.

14. It is the responsibility of the contractor to maintain and ensure 100% serviceability of the equipment's / installations under this contract, except for the reasons beyond the control of the contractor. The decision of engineer-in-charge is final and binding on the contractor in respect of establishment & "the reason beyond the control of the contractor". If the failure to maintain the serviceability of installations attributed to the contractors / agency, penalty to be imposed on the contractor as deemed fit by the Engineer in Charge.
15. In case the agency is not able to attend / rectify fault in the system within the stipulated time period, AAI reserves the rights to engage outside agency to check / inspect the faulty system, if the system is rectified by the outside agency or third party, the amount of checking, rectification along with suitable penalty towards delay in attending breakdown shall be recovered from the agency. Who otherwise is responsible for the up keeping of this equipments.
16. If agency does not take up any work which are in the BOQ after issuance of letter / e-mail by EIC; the same work will be made executed by other agency and the same amount will be deducted as Risk & Cost from RA / final bill. Also @20% of the Risk & Cost amount will be levied from the RA / final bills penalty.
17. There shall be no liability on the part of the AAI to pay any compensation arising out of the labour dispute, accident etc. at site. The contractor will be fully responsible for safety, security and coordination of the workers deployed at AAI site. Nothing extra will be paid to the Agency on this account.
18. Contractor or his authorized representative shall visit the site at least once in one month and as and when called by the Engineer-in-Charge or his representative and will report about satisfactory working of all equipment.
19. Any material taken out for the purpose of repair/ rectification/ replacement from the building or work premises shall have necessary permission from the EIC and security personnel / competent authority in the form of a Gate pass.
20. The timings of operation & maintenance / upkeep work etc. shall be as decided by Engineer-in-Charge from time to time depending upon operational & technical requirement.
21. If agency is doing any maintenance work as per schedule then they have to take prior approval for the same from EIC and also have coordination with other entities / wings (DTM/ATM/ CNS / Airlines etc.) as required.

22. **Handing / Taking over the Equipment/ Machines after contract: -**

All the equipment / installations / systems with accessories complete in all respect shall be checked by agency before taking over the site and the same has to be handed over AAI contractor in good running condition at the end of the contract. List of defects, if any notified during contract period shall be rectified by the agency before the closure of the contract. If the agency failed to rectify the defects notified to him (during contract period) the EIC shall rectified the defects at the contractor's risk & cost. The decision of EIC in this regard will be final & binding on the agency.

23. **For delay in attending maintenance schedules:-** All the preventive maintenance works shall be done as per schedule and complete records in those regards has to be prepared and submitted to AAI engineers, failing which recovery of Rs.5,000/- for monthly checks, Rs.10,000/- for quarterly maintenance, Rs.15,000/- for half yearly maintenance and Rs.20,000/- for yearly maintenance shall made from the bills for each set/ system of installations, subject to the shut down provided by AAI, which shall be Co-ordinate by the agency.

24. **The contractor has to deploy their staff to run the system on all days as per BOQ. If there are some labour under a court case that need to be deployed by the agency as directed by EIC.**

25. The work shall be carried out as per specifications and relevant applicable standard including ISI/CPWD specification.

26. **Safety & availability of Material: -**

(i) The firm / agency shall submit test certificates, wherever applicable as per CPWD/IS/ manufacturers practice and the department reserves the right to get them independently checked for the material supplied by contractor as required.

(ii) All debris due to works shall be removed and site shall be cleared by the contractor as soon as the task is completed. Non-removal of debris from site will attract a penalty of Rs.500/- per day from the running bill / final bill.

(iii) Issue of materials stipulated in the tender will be regulated to the actual needs from time to time. Unused materials shall be returned to the department failing which the recovery will be made at the penal rate i.e. double the market rate. Any damage caused to the materials during transit or under storage will be to the contractor's account.

(iv) If there is any requirement of material at site which is not available in AAI store then contractor has to procure from market as per approved makes with EIC permission and close the complaint as soon as possible. Contractor will provide the tax invoice/ bill for the same and the payment for such material will be given along with 15% OH & CP in running / final bill as an extra item.

27. **Guarantee: -** In case of supply of any material, the tenderer shall guarantee the equipment / material against all defects as per manufacturer. Any defects arising during the guarantee period shall be rectified by the Tenderer at his own expenses to the satisfaction of the EIC.

28. **Water, Electricity and Enquiry Room: -**The AAI will provide an enquiry room, water & electricity for maintenance purpose, free of cost.

29. **Make of Items: -** The contractor shall use / supply the material as per approved make of AAI or as per schedule of quantities or exact replacement of existing material suitable to site after taking permission from EIC/

authorized representative in writing in case makes are not defined for particular material and the department reserves the right to accept or reject any other makes offered by the contractor.

The contractor has to supply the materials as and when required / ordered by the Engineer-in-Charge or his representative during the currency of the contract.

30. Terms of payment: -

The Running payments for the work done shall be released By-Monthly by AAI only after salary payments to all workers & submitting the proof of disbursement and deducting the applicable taxes. The Security Deposit @ 10% shall be deducted from the running bills, which shall be released after successful completion of Defects Liability Period.

The following documents as applicable shall be produced and self-attested photo copy shall be submitted by the contractor during each running bills: -

- i. Delivery challan / copy of invoice of all the material supplied.
- ii. Test Certificate to confirm that the materials meet the contract specification and relevant standard in all respects.
- iii. NEFT/RTGS payment challans for workmen.
- iv. Monthly challan of EPF and ESI / Medclaim deposits up to previous month.
- v. Wages register signed by workers of each month
- vi. Bonus details received and signed by workers
- vii. Log books & attendance register.

Final Bill Payment: - The total amount of final bill worked out at the accepted tender rates, if found to be more than the amount worked out at the quoted rate of second lowest, the contractor shall be paid lower of the two.

The agency shall submit final bill along with all the documents related with PF, ESIC / Medclaim & Bonus to AAI in addition to all maintenance schedule registers, documents etc. related to the work. The agency also formally handover the list of equipment in good working condition, without any damage as handed over to them by AAI.

31. The contractor shall be responsible for any damage caused to any equipment's / building of AAI due to the negligence of the staff. The same shall be made good by the contractor at his cost.
32. Agency has to submit the Preventive Maintenance Activity Plan within 15 days of award of work in line with the Preventive Maintenance Schedule, considering site requirement for approval of Engineer-in-Charge or his authorized representative.
33. The agency shall provide minimum 01 no. mobile phone with active 01 no. SIM to for official use during the currency of the contract, nothing extra will be paid on this account. The bill payment for network connection for each month will be done by the agency. This phone will be returned to the agency after completion of the work. This items to be supplied within one month of commencement of the work otherwise Rs.3000/- per month will be deducted from the RA Bill / Final bill.

34. **Dismantled materials: -**

- (i) The contractor shall make entry of all the materials issued for the work, time to time in the material issue register (to be separately maintained by the contractor).
- (ii) After completion of the work necessary entries shall also be made in the register indicating the location where the materials are installed and the balance materials left out need to deposited to AAI store after completion of work.
- (iii) The dismantled materials shall be duly handed over to Engineer in Charge or his authorized representative and necessary endorsement shall be obtained in both material issue register and also the dismantled material register.

35. **Equipment's for Night Working: -**

In case, it appears, at any stage that the work may not be completed within the stipulated period due to restricted working hours in the day in view of any reasons, the contractor shall execute the work during the night as and when required. Nothing extra shall be payable to contractor for working in night time.

36. **Consumables: -** All the consumables such as insulation tape, Test Lamps, Cotton waste, soap, dusters, grease, Petroleum jelly, hack-saw blade etc. will be provided by the contractor. Stationeries such as log books, work diaries to workmen, printed maintenance records, logbook of various installations, various registers, preventive maintenance schedules as per AAI format and as per the instructions of Engineer-in-Charge will be provided within the 15 days of award of contract and maintained by the contractor at the site. Reserve Stock quantity to be decided by the EIC & nothing extra payment will be made in this regard and the agency has to keep minimum quantity of consumables for one month in stock depending on the actual requirement failing which the material will be arranged by the AAI and the expenditure will be recovered from the agency with 15% over head.**(Consumables to be provided as per List of consumables mentioned).**

37. **Tools and Tackles: -**

The contractor shall provide all the tools and tackles for the works including Measuring instruments and safety gadgets for attending breakdown of equipments. Cost of transportation of labour and material to Airport / office premises shall have to be borne by the contractor.

- (i) Each Skilled manpower will be provided with the following tools of reputed brand (Make: Taparia or equivalent) along with carrying bag for routine maintenance works:-

- Electric drilling machine - 02
- Blower - 02

(iii) The following instruments / items shall be provided by the agency at power house for use of maintenance and breakdown works: -

- Multi – meter (VAO Meter) - 02
- Megger (500V & 2500V) - 01 + 01
- Earth Tester - 01
- Clip-on-meter - 02
- Cell Tester - 01
- Safety Gloves - 04
- Rechargeable torch light - 04
- Safety Helmet - 02

The above mentioned tools & instruments to be supplied within fifteen days of commencement of the work otherwise Rs.20,000/- per month will be deducted from the RA Bill / Final bill. In case of any one tool & instrument not supplied; Rs.1000/- per tool/ instrument will be deducted from the RA Bill / Final bill.

(iv) Agency has to supply one Colour Laser Printer with Cartridge & extra two set Cartridge (i.e. each year one), office Almirah for execution of office work. These items will be returned to the agency after completion of the work. Amount for the same is considered in AOR of Item no. 1. This items to be supplied within one month of commencement of the work otherwise Rs.70,000/- will be deducted from the RA Bill / Final bill.

38. Guidance To Tenderer: -

The contractor shall quote the tender based on the expenditure towards providing of manpower (based on minimum wages) Tools & Plants, Uniform to workers, Statutory items, consumables, PIC Charges Cost of consumables, Miscellaneous expenses, taxes & duties etc.

39. Penalty Clauses: -

No total Breakdown is acceptable. In case of total Breakdown due to negligence of the contractor or his workmen, suitable recovery proposed by Engineer-in-Charge will be final and binding on the contractor. Special care is required in attending the faults for the equipments where no standby is available.

Note: In any case the total penalty at any point of time on account of any or all the categories put together shall not exceed 15% of the total contract value per month.

If any equipment damaged due to the negligence of the manpower, the agency shall repair the same and nothing extra shall be paid on this account by the AAI.

Once the total penalty reaches this limit, the contract shall be liable for review / rescind as per the provisions of the contract agreement and the decision of Engineer-in-charge in this regard shall be final and binding on the contractor.

40. The work shall be got executed through contractors having Electrical License from local authorities for executing LT & HT works.
41. The agency shall take Labour License from Local Labour office.
42. In BOQ, Item Sl. No.-16, Item as per CPWD DSR (E&M) 2025 chapter 01 to 12 & 28, DAR (E&M) 2025 and latest CPWD specifications will be executed, for which an amount Rs. 3,00,000.00 has been considered and this amount has been mentioned in description of item.

Please note that rates DSR(E&M) 2025 are inclusive of GST. However, for determining the rate for payment of DSR items executed under this item, To obtain Cost excluding GST, the cost worked out on DSR (E&M)-2025 and DAR (E&M)-2025 shall be divided by a factor of 1.18. On the rate derived excluding GST as above, the rate quoted by bidder will be applied. GST, as applicable, will be paid over and above the derived rate.

43. Work Excluded from the Contract

- a) Arrangement of heavy tools and plants (like cable fault locators, ladders beyond 4m. height etc.
- b) Installation of new equipment as a part of original work.
- c) Rewinding of motors and replacement of bearings.
- d) Major maintenance of diesel engine and overhauling of pumps including spares i.e impeller etc.
- e) Replacement of batteries.
- f) Replacement of Cards, smoke detectors, heat detectors, hooters, RI & MCP.
- g) Replacement of pipe lines i.e Valves.
- h) HSD for operation of diesel pump.

44. Particulars Specifications

- a) The work shall be carried out as per the AAI specifications for the Electrical works (copies available with Engineer-in-charge), where AAI specification is not available CPWD specifications /Indian Electricity Rules as applicable shall be followed. The work shall be carried out as per the instructions of engineer-in-charge.
 - b) The original installations shall not be disturbed/modified without instructions in writing by Engineer-in-charge.
 - c) The timings of operation / maintenance work etc. shall be as decided by Engineer-in-charge from time to time depending up on operational & technical requirement.
46. In addition to the Preventive Maintenance Schedule prescribed for various installation, if required, other maintenance activities by which the performance of all installations may improve and as desired by the Engineer-in-charge or his authorized representatives shall be carried out free of cost by the Contractor.
47. The Minor modifications/alterations in the existing system of wiring/cabling shall be carried out by the Contractor at no extra cost as per instructions of the EIC.
48. The details of all the parameters pertaining to power supply system and DG Sets shall be recorded in the registers. The printed registers shall be arranged by contractor.
49. The repair and maintenance activity of DG sets, transformers, HT/LT switch gears, etc. other than the preventive and daily maintenance schedule shall be recorded in respective maintenance registers. All the other registers other than those supplied by AAI shall be arranged by the Contractor.
50. Minor repairs and day-to-day maintenance of synchronizing panels of DG Sets, control panel of HT/LT equipment's shall be carried out.
51. The material required for the preventive maintenance/breakdown/daily maintenance activities shall be supplied free of cost by the department as and when required. Proper accounting register of material receipt/consumption and dismantled items shall be properly maintained. If there is any discrepancy in the material issued and used, then the cost of the items for which proper account could not be maintained shall be recovered at double the prevailing market rate of the item(s).
52. The battery bank for the trip circuits of the HT breakers shall be maintained properly to avoid failure of the same. Any deficiency noted during routine maintenance shall be brought to the notice of the EIC.
53. The level of electrolyte in the battery bank shall be maintained and battery voltage, value of specific gravity shall be recorded in the battery maintenance registers which will be counter signed by the EIC

or his representatives on a regular basis.

54. The Contractor shall test all safety devices of all the equipment's under the scope of this contract and submit a report on their serviceability on or before 25th of every month, failing which, the work shall be carried out at the risk and cost of the Contractor.
55. Replacement of HT fuses, insulators, stringing of conductor and all other maintenance activities shall be carried out as and when required as per the direction of the Engineer-in-Charge.
56. The Substation, Pump rooms, DB rooms shall be always maintained in a neat and clean condition.

Safety Rules

- a) The safety rules are made for the general guidance of the Contractor. These rules shall not relive the Contractor of his obligations, under statutory safety rules and regulations.
- b) If the contractor is not following the safety rules, AAI reserves the right to cancel the tender as per terms and conditions and no compensation shall be entertained, should there be any untoward incident.
- c) All the safety regulations issued from time to time by various government bodies shall be followed in total by the Contractor.
- d) The contractor or his supervisor shall bring to the notice of the Engineer-in-charge if there is any accident to the contract labour only on duty immediately after the incident. It shall be followed by a detailed report.
- e) A report shall be made in accordance with rule 44 A of the Indian Electricity rules 1956 in case of the electrical accidents which shall be in the format as per Annexure XIII of the same rules. The report shall be submitted to the Engineer-in-charge as early as possible but not later than 48 hours.
- d) First Aid box with ingredients as per Red Cross Society/St. John's Ambulance Brigade shall be arranged by the contractor immediately after taking over the site and he should brief the workers how to provide first aid. He also should ensure proper medical care of injures persons.

The following paragraphs deal with the general requirement, special conditions and specifications for execution of AMC of E & M installations (hereinafter called AMC works), which will be binding on the contractor apart from General & Special conditions of Contract and other conditions of Contract laid down in the N.I.T. and shall be read in conjunction with the same. If there are any provisions in these special conditions, which are at variance with the provisions in the above-mentioned documents; the provisions in these particular specifications shall take precedence.

- b) Should there be any difference / discrepancy or contradiction in the provision of the specification of item of work and the description of the item given in the schedule of quantities. The scope of the items shall be taken according to the following order of preference: -

- ◆ Nomenclature of the items as given in the schedule of quantities.
- ◆ Technical specifications/Special Condition of Contract.
- ◆ Particular Specifications
- ◆ Drawings / sketch enclosed, (if any).
- ◆ CPWD specifications with up to date amendment.
- ◆ Indian Standard Specifications / Code of Practice.
- ◆ International specifications / Code of Practice.
- ◆ Sound Engineering practices.

In overall, direction of Engineer-in-charge's decision shall be final and binding on the

Any reference made to any of Standards / Specifications shall imply the latest version of that standard, including revisions / amendments issued up to last date of receipt of tender. The contractor shall keep, at his own cost, all such publications of relevant standards applicable to the work at site.

- c) **Requirement for specialized agencies:** - The Contractor shall himself meet the eligibility criteria stipulated in 'Appendix-A', in order to carry out all / any electrical package / sub-head of the contract by himself. Otherwise he shall associate and engage the OEM/ Authorized service dealer/specialized agency meeting the eligibility criteria as per 'Appendix-A', to execute the respective electrical subhead of contract.

The contractor shall submit the credentials of different agencies other than OEM/Authorized service dealer accordingly and engage agency only after approval of Engineer-in-charge, whose decision based on the credentials of the agencies on the matter shall be final & binding. The contractor has to submit the details of specialized agency / OEM at the time of actual start of work for approval of AAI. Failing which necessary recovery will be imposed on the basis of Justified /Estimated/Quoted rate (whichever is higher) for those items.

After finalization/approval of OEM/Authorized service dealer/specialized agency by AAI, a separate back to back agreement to be made with OEM/Authorized service

dealer/specialized

agency as one of the party (as second party) with agency (as first party) for AMC/ CMC for the specialized electrical package as mentioned in 'Appendix-A' and same agreement copy shall be submitted to AAI. All the payments in this regard shall be made by Contractor. All the follow-up and liasioning or periodical and routine maintenance with the OEM/ Authorized service dealer / specialized agency shall be made by the contractor.

2. **Award of Work:** -The works will be awarded to the Agency who is evaluated as lowest quoting agency considering cost applicable to AAI.
3. **Applicable GST:** - The work is considered as service contract for electrical services and 18% GST shall be payable by AAI as per present provisions.
4. **Site Order Book and Compliance by agency:** - For the successful operation and day to day maintenance, upkeep, maintenance of records, scheduling for preventive and breakdown Agency maintenance and any work found essentially required to keep the system maintained and in proper running condition and getting services as per scope of work mentioned in the contract, site order books shall be maintained at site in the custody of AAI. The site order books will be submitted to the Principal Supervisor / representative of Agency

for noting of instructions given to the Agency through the site order book. Compliance of the instruction as per time schedule given shall be binding to the Contractor. Contractor may write his comments in appropriate place of the site order books making the same communicative to both AAI and Agency for proper monitoring and compliance of the mutual obligations.

In case of execution of any item, found essential for proper compliance of the work which is included in the contract, rate for same shall derived as per provision of Clause 12 of GCC and time for execution of the extra / substitute item (i.e. item not included in the contract) shall be arrived in accordance with provision in the contract.

Failing to comply with the requirement by execution of the extra item shall attract provisions under Clause 3 and Clause 4 of GCC besides imposing penalty as applicable under this contract.

5. **Security Deposit:** - The Agency has to submit security deposit @10% of quoted amount in advance or in the form of Bank Guarantee(from nationalized bank)(shall not be less than Rs.5 lakh) within 10 days after issuing Work Order and before making Agreement, otherwise @10% of gross value of the bill will be deducted from the running bills and the same will be refunded to the contractor after successful completion of defect liability period i.e SIX MONTHS from the certified date of completion of the contract.
6. Any Govt. Instruction/Circular issued from time to time shall also be applicable for this Contract.
7. **Precedence of Conditions of Contract:** - These conditions of the contract shall be read in conjunction with the General conditions of contract document issued together with the amendments, corrections, enclosures, etc. along with the tender document and the provisions of these conditions shall take precedence over the general conditions.
8. If on account of any legislation/notification labour, award the minimum wages rate for labours are increased at time or times after date of submission of tender the contractor has to pay increased minimum wages due to such increase.
9. No advance payment will be made to the Contractor. However, Bi-monthly payment will be made by AAI against submission of bills for the actual work done by the contractor.
10. The spare parts required for the works shall be issued by AAI, other than specified in tender documents.
11. AAI shall reimburse to the contractor the actual difference of the amount of wage paid and justified rates calculated during submission of tender on submission of documentary evidence, if on account of any legislation/ notification the minimum rate of wages for labour are increased.

15. SCOPE OF WORK

Following activities are involved in the Scope of Work on all days including Sundays & Holidays during the contract period for the following area

- 1) Terminal Building,
- 2) Administrative Building,
- 3) Power House,
- 4) Pump House
- 5) Operational Area
- 4) AAI/CISF accommodations
- 5) Parking/approach Area & Others.

- Operation of various E&M systems as defined in SOQ and Special Conditions of Contract and Particular Specifications of Contract.
- Internal & External Electrical Works. – These works are to be carried out as per CPWD Internal & External specifications and materials to be used in accordance with standard AAI list of ‘Approved Makes’. If any item not available in the list, the same is to be decided by the EIC.
- Operation and Maintenance of E&M installations like Internal/ External EI, GLF installations, LT panels, earthing system, cables, switchgears, etc. as per PMI schedule.
- CMC of various type split ACs as defined in SOQ and Special Conditions of Contract and Particular Specifications of Contract: -
 - As per enclosed AAI maintenance schedules.
 - As per OEM’s recommendations.
 - As per the instructions of AAI from time to time.
- CMC of Water Coolers & Water purifier from OEM/Authorized Dealer and separate agreement will be made between Agency & OEM/Authorized Dealer for the same.
- Service/breakdown visit of Fire alarm detection system/ Fire fighting system by OEM/Specialized agency and separate agreement will be made between Agency & OEM/Specialized agency for the same.
- AMC of Conveyor belt system from OEM and separate agreement will be made between Agency & OEM for the same.

16. BREAKDOWN REPAIRS:

- Any breakdown of E&M installations shall be attended immediately.
- Breakdown of services in critical areas shall be attended to and restored immediately without loss of time on top priority. One or more registers in the standard format shall be maintained for recording the breakdown / faults by the contractor representative on duty. The same shall clearly indicate the time / mode of receipt of fault report, location and nature of fault, materials used and cause of fault.
- Failure to attend and rectify equipment / Air-conditioners in breakdown within appropriate time as instructed by the EIC shall attract penalty as defined under special heads mentioned below or in absence as defined and communicated by the EIC.
- Any breakdown of Feeder MCCBs, ACBs, VCBs shall be attended immediately, power breakdown to be avoided following alternative / standby routes and switches and taking temporary arrangements as required and guided by the EIC. Restoration plan for the defective VCBs /ACBs/ MCCBs, Busbar, CTs to be submitted immediately. Procurement action to be finalized with the EIC and necessary offers for materials procurement etc. to be submitted to the EIC within 02 (two) days. Systems to be reconditioned within 03 (three) days of the material delivery schedule accepted by the EIC. Rates will be finalized in accordance with applicable tender clause.
- Dismantling of old / defective mountings / accessories, proper storage of dismantled materials in AAI identified store / area & installation of new ones.
- Maintenance of Records / Documents and submission of Reports.
- Co-ordination in carrying out the works with other agencies working at the Airport.
- Carriage of materials issued by AAI from their stores to various work site for carrying out various works. (including arrangement of necessary vehicles with manpower).
- Ensuring all necessary electrical & fire safety procedures, precautions while carrying out the work including making use of safety gadgets like hand gloves, torch light, rain coat, leather shoes, gum boots etc. as per site requirements.
- Meeting the requirement of labour regulations / registration, Local laws / by-laws etc. making insurance for the employees.
- Any other works assigned by AAI time to time by Engineer-in-charge.

17. Comprehensive Maintenance of Split Air-conditioners: -

- Job includes monitoring for satisfactory working, periodical maintenance and all major & minor repairs of the split type Air conditioners as when required.
- Supply and replacement of defective components like capacitors, relay, thermostats, fan blades, blowers, selector switches, air filters etc including making suitable inter connection and rewiring of the unit etc.
- Condenser, evaporator coil cleaning, leak testing, gas charging, replacement of capillary, oil charging etc.

- Replacement of failed compressor with new/ manufacturer repaired compressor of similar model and make whenever repaired, including gas charging etc. Original documents like delivery challan and invoice from manufacturer or his authorized dealer indicating serial number of compressors shall be submitted to the Engineer-in-charge for approval before installing the compressor.
- Replacement of damaged drain pipes, insulation, etc. as and when required.
- Any other work related to the proper maintenance specifically not mentioned herein.
- The transport of A/C units, accessories, men and materials from various site to the workshop for repair and replacing these units back in these installations including loading and unloading is included in the scope of work and has to be provided by the agency.
- All the materials - battery for remote, paint, marker, tape, flexible conduit, wires/ components – nuts, bolts, washers, fuse/ cleaning material – old cloth, detergent, etc. what so ever required is included in the scope of work and shall be arranged by the contractor. Nothing is excluded except power supply socket, MCB/switch and wiring up to the socket outlet from DB. However, the successful tenderer shall intimate the Engineer-in-Charge about any deficiency in power supply, which will affect the performance of the unit.
- Minor complaints like replacement of capacitors, thermostats, relays, fault in wiring, filters etc. shall be attended immediately and within 24 hours from the occurrence of fault. Complaints like gas charging in split A/C units or water coolers and repairs to voltage stabilizers shall be attended and completed within two days from the date of occurrence of fault. In case of failure of this, penalty @ **Rs. 500/-** per day per machine will be imposed to the agency.
- Alternatively, spare serviceable units shall be provided by the contractor without any cost to AAI till the defective unit is made serviceable. Burnout compressors shall be repaired/ replaced as applicable and the unit commissioned within 15 days of the failure. In case of failure of this, penalty @ **Rs. 1000/-** per week will be imposed to the agency.
- Minimum materials/spares should be available at site for avoiding any kind of breakdown of existing installations, failing which necessary recovery shall be made as decided by EIC.

NOTE: All the equipment/installations shall always be kept in good and trouble-free operating Conditions. All the required record for break-downs/repairs and maintenance etc. shall be maintained as per directions of EIC or his representative.

All the maintenance works shall be carried out in accordance with the manufacturer's specifications and Instructions of the EIC or his representative.

- **CONSUMABLES:** - The rates shall be all inclusive of spares and consumables as per schedule of Work. The contractor is required to assess the probable quantity of all types of spares and consumables Likely to be required for

replacement for keeping all the installations in good working conditions and Include the lump sum cost of these spares & consumables. Nothing extra on any account shall be Payable over and above the approved all-inclusive comprehensive rates of the contract.

All spares and consumables shall be arranged by the contractor for which nothing extra shall be Payable. Replaced parts/ spares, used brunt oil etc. will be property of agency. It is his responsibility to disposed of immediately.

- **PENALTY CLAUSE:-** If work is not done as per above schedule or any system is not functioning except mother board then a penalty @ rate Of Rs.500 /- per day shall be imposed on contractor for each location separately and will be Deducted from the CMC amount due to the contractor and if unsatisfactory performance is Continued for more than two days as felt by the EIC and CMC is liable to be terminated and final decision for this shall rest with the EIC.
If the contractor is NOT able to locate and rectify the fault and the reasons attributable to non-Performance of contractor as assessed by officials nominated by agency, the penalty clause is applicable as System remained non-functional for 8 hrs. or more. The penalty will be Rs.500/-Per day.
If contractor is not able to rectify the fault then the same may be got done through some other Agency at the risk and cost of contractor failing which the same amount will be deducted from AMC bill in addition to the penalty as stipulated above will also be imposed.
- **Detailed Terms and Conditions for providing CMC & All-Inclusive maintenance for ACs:** - The contractors shall be responsible for the safety of his/her man power, all the items of Furniture, plants, office equipment and other fittings provided in the premises and shall be liable to make good any loss to the same if damaged during the execution of their duties which shall be recoverable from their bill or other dues payable to the contractors by the company.
The contractor shall be responsible for the good conduct and behavior of his employees. If any Employee of the contractor is found misbehaving with the supervisory staff or any other staff Member, the contractor shall terminate the services of such employees at their own risk and Responsibility on the recommendation of the EIC or any other officer.
- **Additional Terms and Conditions:** - The contractors should visit the site and acquaint themselves of the conditions existing, the contractor should submit list of spare parts required to carry out repairs and maintenance Works well in advance to EIC or is authorized representative. They shall be responsible for any periodic statutory inspection to be carried out on the Equipment necessary test report and certificate rectification of defects, pointed during such Inspection etc. Contractors should follow all safety norms and provide necessary safety equipment at their own Cost. In case of any accident during the maintenance of the equipment leading to injuries / Damages to human being equipment and / or loss of life, the contractor shall be fully responsible for setting all claims and indemnify the Centre against any claims arising out of such Accidents. Consequent damages to other systems will however be recoverable from the Contractor. This contract can be terminated by the EIC without assigning any reasons by giving a Notice period of 30 days at any time

during the period of contract. No claim for any Compensation will however be entertained due to such termination prior to the expiry of Stipulated period of contract.

➤ **Exclusions of Work in this CMC Contract: -**

- Repair / replacement of electrical main incoming switch (Switch fuse unit- outside the A/C machine), Main incoming cable, fuses, control transformers & indicating lamps.
- Major work on ducting, Dampers, Duct lining, grills, etc.
- Any work related to false ceiling, any kind of masonry / structural work.
- Replacement of condenser and cooling coil.
- Replacement of sheet metal parts.

18. SCOPE OF WORK for CMC of Water Coolers, Water Cooler & Water purifier system:

- **A.** Periodical maintenance of water purifier installed at the various locations of Cooch Behar Airport, as per following details: -

- The agency shall maintain required register and record of maintenance of Water Coolers & Water purifier as per the instruction of EIC.
- During the contract period supply and replacement of all defective components except iron remover cartridge, main chassis is to be provided by the agency for which no payment will be given by AAI.
- Agency shall depute skilled and qualified workmen sufficient enough to maintain all the units in working condition including periodical observations, repair and maintenances.
- Any other work related to the proper maintenance specifically not mentioned herein. The agency shall attend the break down call within 48 hours. Failing which @ 200/- will be deducted per day basis.

B. Agency shall record all work carried out and serviceability of the Water Coolers & Water purifier and submit monthly basis.

C. The agency shall ensure the maintenance of all the Water Coolers & Water purifier unit in a better physical appearance by regular cleaning of units.

D. Transportation of Water Coolers & Water purifier unit, accessories, men and materials from various installations at Airport to the workshop or replacing these units back in these installations including loading and unloading is included in the scope of work. No vehicle shall be arranged by AAI for this purpose. Before the unit / any component is taken out from the premises of AAI the agency shall obtain the gate pass indicating the description of the component / unit with the serial number from the concerned site in charge as authorized by E-I-C.

E. A part from deputing the workmen required for performing the work, agency or his authorized representative capable of monitoring the maintenance activities to be carried out and take directions from E-I-C.

F. Agency shall make the work site clean and tidy after completing the work and no waste materials or dust shall be left in the work site.

- G. At the end of completion of contract all the units shall be handed over to AAI in good working condition.
- H. Agency shall be responsible for any damage caused due to his negligence and he will have to make good the loss and damages at his risk and cost.
- I. Agency has to arrange his own tools and plant required for the maintenance purpose for which nothing extra will be paid.
- J. AAI reserved the right to cancel the contract at any time by giving one month notice if the performance is found unsatisfactory.
- K. Any other clearance such as meter connection if necessary from Govt. bodies shall be arranged by the contractor from the concerned authorities for which no payment will be made separately.
- L. Agency shall make a back to back Comprehensive Maintenance Contract agreement with OEM/Authorized service dealer.
- M. All the payments in this regard shall be made by Contractor.
- N. All the follow-up and liaison or periodical and routine maintenance with the OEM shall be made by the contractor.

19. SCOPE OF WORK of Firefighting and Fire Alarm System: -

A. SCOPE OF WORK:

- 1) The Scope of work will include all types of preventive as well as break-down maintenance of Fire detection cum alarm system and Fire Fighting system of Terminal Building, Technical Block including Fire Hydrant system of Terminal Building.
- 2) Spares replacement if required will be paid extra and Replacement to be done with prior approval of EIC.
- 3) To carry out daily, monthly, quarterly, half yearly and annual check/test of the equipment as per attached schedule and maintaining logbooks for each building and each system.
- 4) Any maintenance routine/breakdown done through specialized agency, service report from specialized fire agency/OEM must be submitted counter signed by contractor failing which penalty @ 1000/- per service report.
- 5) Replacement of minor parts like ICs, resistors capacitors and LED etc. will be borne by agency, no extra amount will be paid to agency.
- 6) Battery charging, and cleaning of terminals of all the batteries installed for different installations.
- 7) To attend unlimited break down calls (if any).
- 8) Additional area if included in the area of work in due course of time due to expansion and modification in terminal building will be covered in this work with no additional cost.
- 9) Agency to carry out the PMI checks and to attend the breakdown calls and will submit monthly serviceability report of entire system covered under this contract apart from maintaining log book for various other maintenance activity carried out.
- 10) The replacement of defective/ damaged heat/ smoke detector, response, indicator,

batteries will be carried out only with written consent for EIC. The cost of all such items will be paid to the contractors by AAI.

- 11) The contractor shall not dismantle and remove any items without the knowledge of EIC. Dismantled material shall be the property of the AAI.
- 12) The contractor should have necessary tie up with the manufacturers/specialized fire agencies of the major critical equipment for special repairs and supply of genuine spare parts as and when required and same should be mentioned in their agreement (made between Agency & OEM/Specialized agency).
- 13) Agency shall be responsible for any failure / misshapen occurs from fire alarm system of Terminal/Technical building due to negligence of agency and the cost of losses of installation / any equipment will be borne by agency as per decision of Engineer-In-Charge
- 14) The contractor should visit the work site and familiarize him about the equipment installed
and magnitude of the job and should quote after clear understanding the scope of work. The rates quoted shall be valid throughout the period of the contract. No escalation will be permitted on any account after acceptance of the contract.
- 15) In case Fire Officer/ Engineer-in-charge finds that contractor is not attending the defects then the contractor shall be liable for action. Decision of the Engineer-in-charge shall be final and the work would be got done departmentally and/or through other agencies at risk and cost of the contractor.
- 16) **TEST & INSPECTION:** Fire officer/ Engineering-in-charge or his authorized site representative may carry out periodic or surprise test and inspection of entire system under contract. The contractor shall have obligations to ensure that the system is working at its optimum performance criteria.
- 17) All the equipment of fire alarm system complete in all respect shall be made fully functional within one month time and the combined testing and commissioning will be carried out before handing over the entire system for preventive maintenance. List of defects and equipment not working shall be prepared at the time of handing over. The contractor shall hand over all the machines/ equipment in perfect condition to the next contractor or AAI officials on expiry of the contract as the case maybe as handed over to the agency.
- 18) **PENALTY/ RECOVERY:** A sum of **Rs.1,000/-** (amount to be decided based on quality of equipment) shall be recovered if any of the equipment i.e. detection system, alarm system and other installations under contract is not operative on account of any fault continuously for a period of more than 2 (Two) days. If the fault rectification is likely to take time on account of any reason beyond the control of the contractor, then the firm must confirm in writing to the Engineer-in-charge. The recovery amount can be waived off if the reasons of delay given by the contractor are found satisfactory. The decision of the Engineer-in-charge shall be final.
- 19) **RECORD KEEPING:** The contractor will maintain the following records:
 - i. Monthly record of break down calls and will submit the reports to the maintenance & Engineer-in-charge every month w.e.f the serviceability of the systems.
 - ii. Record of inspection of units will be maintained and shown to the Officer.

- iv. PMI check register for fire fighting & fire alarm system for all the buildings separately.
- v. Any other record if required for the satisfactory execution of the contract.

20. SCOPE OF WORK for AMC & overhauling of Conveyor Belt System: -

- A. The scope of work covers the annual maintenance of Conveyor belt system by mandatory visit once in **Quarterly** and attending break down calls as and when required.
