Note : The contractor has not responded for RFI and email despite 3 RFI's and email dated 14.03.2026 where EO Civil has mentioned to consider the email as most urgent and requested to reply to the email with supporting documents on or before 16.03.2026, failing which it will be presumed that you do not have Sewage related Civil work experience and the case will be processed accordingly.

16. OBSERVATIONS:

- It is submitted that HVF tendered eligibility conditions stipulates that the contractors must possess "Experience of having successfully completed similar work in Govt. Dept. / Central PSU's during last 7 (Seven) Years ending last month should be following: 3 similar works costing not less than the amount equal to 40% (or) 2 similar works costing not less than the amount equal to 50% (or) 1 similar work costing not less than the amount equal to 80% of the estimated cost. (Similar Work means Operation and Maintenance of Sewage Treatment Plant (AND / OR) Any Sewage related Civil Works Only)".
- It is submitted that the contractor M/s. Kamatchi Enterprises, Chennai and M/s. Kalai Enterprises, Chengalpattu are not having relevant work experience as per eligibility conditions of the tender and the contractor M/s. Mariammal Constructions, Chennai has not responded to RFI's and email.

17. OBSERVATIONS OF CWC-II HELD ON 25-03-2026:

- CWC-II observed that HVF tendered eligibility conditions stipulates that the contractors must possess "Experience of having successfully completed similar work in Govt. Dept. / Central PSU's during last 7 (Seven) Years ending last month should be following: 3 similar works costing not less than the amount equal to 40% (or) 2 similar works costing not less than the amount equal to 50% (or) 1 similar work costing not less than the amount equal to 80% of the estimated cost. (Similar Work means Operation and Maintenance of Sewage Treatment Plant (AND / OR) Any Sewage related Civil Works Only)".
- CWC-II also observed that the contractor M/s. Kamatchi Enterprises, Chennai and M/s. Kalai Enterprises, Chengalpattu are not having similar work experience as per eligibility conditions of the tender and the contractor M/s. Mariammal Constructions, Chennai has not responded to RFI's and email.

18 DECISION OF CWC-II HELD ON 25-03-2026:

- a. CWC – II deliberated the case and observed that all the participants have submitted civil works experience and in order to enhance and encourage the civil contractors to execute Operation and Maintenance of Sewage Treatment Plants work, CWC-II decided to change the Pre-Qualification criteria from (Similar Work means Operation and Maintenance of Sewage Treatment Plant (AND / OR) Any Sewage related Civil Works Only) to (Similar Work means Operation and Maintenance of Sewage Treatment Plant (AND / OR) any Civil Works Only).
- b. In view of the above, CWC-II decided that the case should be re-tendered on Open Tender basis, with Two Part Bid System through e-Procurement Portal (CPPP) with eligibility criteria as (Similar Work means Operation and Maintenance of Sewage Treatment Plant (AND / OR) any Civil Works Only) and the present e-tender bearing tender ID: 2026_AVNL_264952_1 must be cancelled in the e-procurement portal (CPPP).
