REASON FOR REJECTION:

M/s. Ankur Trading Works:

The bidder has not submitted the Earnest Money Deposit (EMD) and has also failed to upload the required forms and formats duly filled, signed, and stamped, including the Land Border Undertaking document.

Further, it is observed that the bidder's working capital is negative. The bidder has not submitted the requisite financial documents and also failed to furnish Format F-9 (Certificate from Bank) pertaining to the line of credit.

Therefore, the bid is considered commercially not acceptable due to non-compliance with the Bid Evaluation Criteria (BEC) and the terms and conditions of the tender document.

M/s. Bheemeshwari Build:

As per Buyer Added Bid Specific ATC document, Section-II Clause No.: D of BEC Notes, ***“Only documents (Purchase Order, Completion certificate, Execution Certificate etc.) which have been referred/ specified in the bid shall be considered in reply to queries during evaluation of Bids. After submission of bid, only related shortfall documents will be asked for in TQ/CQ and considered for evaluation”***. It was observed that the bidder has not uploaded any relevant Purchase Order/ Work Order related to Technical BEC with the initial technical bid. Hence, the offer submitted by the bidder is Not Acceptable Technically.

Therefore, the Offer submitted by the Bidder is not technically acceptable and is liable for rejection without seeking any further clarifications, due to non-compliance with the BEC stipulated in the tender document.

M/s. Hmkmulti Infra (OPC) Private Limited:

Bidder has submitted Letter of Acceptance (LoA) No. GAIL/BLR23-26/ 5300040182/ 20112814/ RDB dated 12.12.2023; however, the corresponding completion certificate has not been uploaded. Further, it is observed that the submitted documents are neither attested by a Notary Public with a legible stamp nor certified by a Chartered Engineer.

Further, to ascertain the relevance of the submitted Work Order (WO) for meeting the BEC, the bidder was requested to furnish the detailed Special Conditions of Contract (SCC), Scope of Work (SOW), and Schedule of Rates (SOR) pertaining to the above-mentioned LoA.

Accordingly, a clarification query was raised to the bidder; however, the bidder did not respond within the stipulated date and time.

In view of the above, the bid is considered technically not acceptable due to non-compliance with the Bid Evaluation Criteria (BEC) and the terms and conditions of the tender document.

M/s. Nahar Singh Rathore:

Bidder has submitted Letter of Acceptance (LoA) No. क्रमांक/नि०/गोदाम/सि.नि.क्र 142431//2021-22/2353 dated 15.06.2021 along with a completion certificate, duly attested by a Notary Public with a legible stamp and duly certified by a Chartered Engineer. Additionally, the bidder has furnished a notarized and CE certified copy of an estimate sheet. However, it is observed that there is no reference number linking the document to the previously submitted Work Order (WO). Further, the submitted sheet appears to be an “Estimate” sheet containing Schedule of Rates (SoR) details and does not form part of the actual Work Order; hence, it does not establish the relevant details of the WO.

Therefore, the Offer submitted by the bidder is ***Not Acceptable*** due to non-compliance with the Bid Evaluation Criteria (BEC) of the tender document.

M/s. Swanip Infracon Private Limited:

Bidder has submitted Letter of Acceptance (LoA) No.: GAIL/KOC/036/21/5600004637/2021-22 dated 23.09.2021 along with a completion certificate, duly attested by a Notary Public with a legible stamp and duly certified by a Chartered Engineer.

Further, to ascertain the relevance of the submitted Work Order (WO) for meeting the BEC, the bidder was requested to furnish the detailed Special Conditions of Contract (SCC), Scope of Work (SOW), and Schedule of Rates (SOR) pertaining to the above-mentioned LoA.

Accordingly, a clarification query was raised to the bidder; however, the bidder has not submitted the relevant document for the said LOA.

In view of the above, the bid is considered technically not acceptable due to non-compliance with the Bid Evaluation Criteria (BEC) of the tender document.

M/s. Zind Baba Enterprises:

As per the Buyer Added Bid Specific ATC Document, the bidder was required to upload signed and sealed copies of Section-V (Special Conditions of Contract) and Section-VI (Scope of Work) as an acceptance; however, the same have not been submitted.

It is further observed that the required forms and formats, duly filled, signed, and stamped, including the Land Border Undertaking, have also not been uploaded. Accordingly, a clarification query was raised to the bidder, but no response was received within the stipulated date and time.

Therefore, the offer submitted by the bidder is considered not acceptable due to non-compliance with the terms and conditions of the tender document.
