Recommendation of TEC on E-tender (ID:2026 IWAI 895614 1) for "Design, Supply, Installation, Testing, Commissioning & Maintenance [1 year Warranty period + 2 years of Comprehensive Annual Maintenance Contract (CAMC)] of Conveyor Belt System at Jogighopa Terminal on EPC mode"

The statement of the technical evaluation sheet is enclosed as Annex-II and TEC report is enclosed as Annex-B.

3. Observations and Recommendation of TEC

(a) As per the NIT, the tender documents were to be submitted online by bidder to Director, IWAI, Guwahati on or before 14.02.2026 upto 15.00 hrs and to be opened on 16.02.2026 at 15.30 hrs. Accordingly, the technical bids were opened on 17.02.2026 at 15.30 hrs.

(b) After scrutiny, it was observed by TEC that 1(one) bidder viz. (2/2) M/s Rama Shankar Prasad had submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender except the **Litigation history** document and the same was asked to submit as shortfall documents. The shortfall document was to be submitted online in the CPP portal on or before 12.03.2026, 15:30 hrs. Accordingly, the shortfall document was opened on 18.03.2026.

(c) In compliance with the TEC's observation, M/s Rama Shankar Prasad has submitted the required above shortfall document as asked by the TEC. Further, the firm has submitted all the required documents to fulfill all the technical parameter mentioned in the tender document. Hence, considering above, the TEC recommends M/s Rama Shankar Prasad as a technically qualified bidder for the tender.

(d) Accordingly, TEC recommends that (1/2) **M/s Jak Reality Projects Pvt. Ltd.** and (2/2) **M/s Rama Shankar Prasad** be considered technically qualified, as they have submitted all the requisite documents fulfilling the technical parameters mentioned in the tender document.

(e) In view of the above, TEC further recommends opening of the financial bids of the above technically qualified bidders i.e. (1/2) **M/s Jak Reality Projects Pvt. Ltd.** and (2/2) **M/s Rama Shankar Prasad**.
