Recommendation: Based on the technical evaluation, the TEC observed that two bidders, M/s Ramashankar Prasad and M/s SIM Company, successfully fulfilled and submitted all mandatory technical parameters specified in the tender document. Accordingly, the TEC recommends both as technically qualified bidders and further recommends that their financial bids be opened. Conversely, upon evaluation of the documents submitted by M/s VAV World and M/s RMS Enterprise, the TEC observed that neither bidder fulfilled or submitted the mandatory technical parameters. Therefore, the TEC recommends that both be technically disqualified for this tender.
