

Minutes of the meeting held on 05.05.2026 for evaluation of Technical Bids for the work of "Special Repairs in the stretch from Km.103.225 to 133.000 (Pattadakal to Shirur Cross) on NH-367 pertaining to NH-Division, Vijayapura in the state of Karnataka (Job No.NH-367/KNT/Vijayapur/Special Repairs/2025-26/01). APT:Rs: 13.13Crores (Incl. GST)

As per the Ministry Circular No.RW/BNG/NH-169A/Km.51-88/20/2021,dated: 10.06.2025, the powers has been restored to State PWD with respect to bids with bid cost of upto Rs.100 Cr. In accordance to the para 8.3. Ministry Circular no. RW/NH-24035/4/2008-P&M/PIC Vol.II dated 23.02.2018, an Evaluation Committee for opening & evaluation of bids, was constituted under the Chairmanship of Chief Engineer NH's (NZ) Belagavi with the following composition:

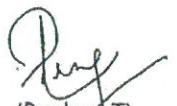
