

Minutes of the 4th Meeting of the Bid Evaluation Committee for Evaluation of Technical Bids for "Services for Supply, Operation and Maintenance of Mobile Quality Control Van (MQCV) for Non-Destructive Testing of NH works in the State of Bihar" held in the Chamber of Chief Engineer, Quality Control Zone, Transport Bhawan, New Delhi at 14:30 hours on 26.05.2026.

Ministry vide NIT no. RW/QCZ/2025-26/BH dated 04.02.2026 had invited bids for above mentioned work in the State of Bihar through CPPP Portal for a Tender Amount of Rs. 7.00 Crores. The work was sanctioned for Rs. 84 Crores for 10 Nos. of Tenders, out of which MQCV for the State of Bihar is for Rs. 7.00 Crores.

2. The 4th Meeting of the Bid Evaluation Committee for the examination of Technical Bids was held on 26.05.2025 at 14:30 Hours. Committee noted that there are 5 nos. of technical bids received for the State of Bihar, which are as below:

3. The Technical Bids were examined by the Committee during meetings held on 12.05.2026, 22.05.2026 and 26.05.2026. Based on the original Bid documents submitted by the Bidders, the Committee examined the eligibility and technical responsiveness of the Bidders as per stipulations as laid in the RFP.

4. Based on detailed deliberations, the Bid Evaluation Committee found that:

4.1 The technical bid submitted by M/s AIMIL Ltd. is found to be **TECHNICALLY QUALIFIED**.

4.2 The technical bid submitted by M/s Asian Contec Ltd. is found to be **TECHNICALLY QUALIFIED**.

4.3 Technical Bid submitted by M/s Renuka Consultants (Explorers and Designers) Pvt. Ltd. have the following deficiencies:

4.3.1 Authorization from OEM/Manufacturer (Manufacture's Authorisation Forms-MAF) have not been submitted for any equipment by the Bidder as per the requirement of the RFP.

4.3.2 Brochures/catalogues specifying technical specifications of the equipment as per requirements of RFP have NOT been submitted by the Bidder.

4.3.3 There are NO documents submitted by Bidder regarding Experience Criteria for Suppliers as per the requirement of Clause 3.2 (C) (ii) of Section 2 of the RFP.

In view of the above, the technical bid submitted by M/s Renuka Consultants (Explorers and Designers) Pvt. Ltd. is found to be **TECHNICALLY NOT-QUALIFIED**.

4.4 The technical bid submitted by M/s Avantech Engineering Consortium Pvt. Ltd. is found to be **TECHNICALLY QUALIFIED**.

4.5 Technical Bid submitted by M/s TTL Engineering Pvt. Ltd. have the following deficiencies:

4.5.1 There are NO documents submitted by Bidder regarding Experience Criteria as per the requirement of Clause 3.2 (A) (i) of Section 2 of the RFP.

4.5.2 Brochures/catalogues specifying technical specifications of the equipment as per requirements of RFP have NOT been submitted by the Bidder.

4.5.3 As per Company Profile submitted by the Bidder, the Bidder has experience in AE/IE/ PMC/ Supervision Consultant for several National Highway Projects. Accordingly, there is a conflict of Interest as per foot note of Clause 3.2 of Section 2 of RFP.

In view of the above, the technical bid submitted by M/s TTL Engineering Pvt. Ltd. is found to be **TECHNICALLY NOT-QUALIFIED**.

5. Based on above detailed examination as in Para 4 above, Bid Evaluation committee found the following:
