

Minutes of meeting of the Evaluation Committee held on 22.04.2026 for evaluation of Technical Bids for the work of "Short Term Maintenance Contract (STMC) from Km 164.00 to Km 194.55 on NH-73 pertaining to Executive Engineer, National Highway Division, Hassan in the State of Karnataka (Job No.NH-73-KNT-Hassan-STMC-2025-26-51).

1. An Evaluation Committee for evaluation of bids was constituted under the chairmanship of Chief Engineer with the following composition

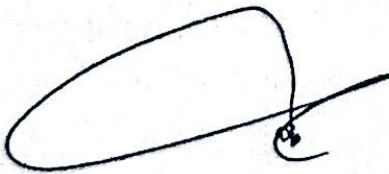

2. Bids for the above work were invited on CPP portal <https://eprocure.gov>, in vide NIT No. EE/NHD/HISN/AE-1/STMC/NH-373 /2025-26/ 1563, dated: 24.02.2026 with due date of submission of bids as 25.03.2026 upto 16.00 hours and with opening of Technical bids as on 26.03.2026 at 16.30 hours.
3. The Member Secretary of the Committee (Executive Engineer, NH Division, Hassan) opened the bids on 26.03.2026 at 17.00 hours. Details of bidders participated in the bidding process are as under:

All the documents such as Power of Attorney, Bid Security, Average Annual Turnover, Similar Nature of works and other financial capacity documents etc. have been examined by the Committee. The technical evaluation carried out by the Committee in brief is as under:-

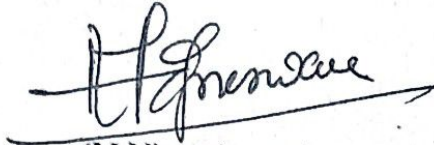
- A. Sanctioned Cost -Rs.240.99 Lakhs
B. Amount Put to tender -Rs.197.54 Lakhs (Excluding GST)
C. Bid Validity- 120 days
D Period for completion of work: 12 Months



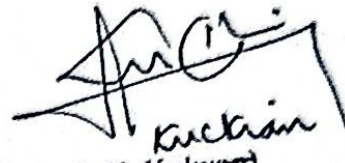

5. After evaluation of Technical Bids, the Committee found 4 bidders out of 6 bidders as technically responsive.

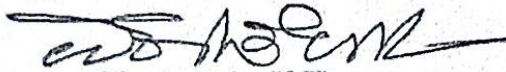

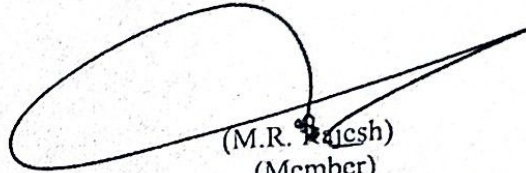
