2. Bids for the above work with amount put to Tender of Rs.128.81 Lakhs (excl. GST); were invited through e-bidding on e-tender portal <https://eprocure.gov.in> vide NIT dated 24.02.2026 with due date of submission of bids as 25.03.2026 and with opening date as 26.03.2026.

3. The Member Secretary of the Committee (Executive Engineer, National Highways Division, Hassan) opened the bids on 26.03.2026. Details of bidders participated in the bidding process are as under:

A. Sanctioned Cost -Rs.198.24 Lakhs

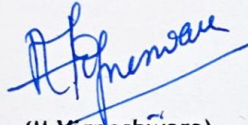
B. Amount Put to tender -Rs.128.81 Lakhs (Excluding GST)

C. Bid Validity- 120 days

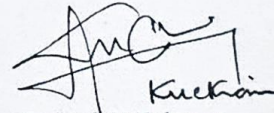

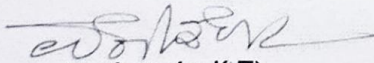

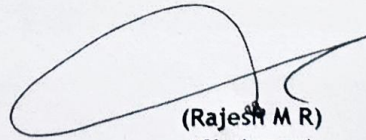
